Captain's Message

On February 6th, SFPD released its 4th Quarter Use of Force, Arrest and Police Encounters Report for 2017. The report highlights a significant decrease in use of force incidents and assaults on officers during this time period as compared to the previous year.

The data shows a 33% decrease in reportable uses of force and a 12% decrease in assaults on San Francisco Police officers in comparison to the fourth quarter of 2016. Year to date, the department saw an 18% decrease in uses of force compared to 2016.



Aggravated Assault on Officer Arrest – 2400 block San Bruno – 1/30/18, 9:20 pm

Officers responded to a call of a theft from a Walgreens store. An officers arrived and spotted the suspect making his escape on foot. The officer chased the suspect into a parking lot on Felton where the suspect got into the driver's seat of a vehicle. The pursuing officer managed to get the passenger door open and got in to apprehend the suspect who was in the process of starting the engine. The suspect gunned it and sped out of the parking lot with the officer still in the car. Other officers on the scene saw the car tear down towards Felton St. at a high rate of speed and watched as the officer came flying out of the passenger door and onto the asphalt seconds before the suspect careened into the side of a vehicle traveling east on Felton. The suspect was then taken into custody by other units in the area. The officer who was thrown from the suspect's vehicle, which had been reported as stolen, was treated for his injuries at SFGH. The suspect was booked on multiple charges that included aggravated assault on an officer, hit & run and auto theft. (SFPD Case No. 180081592)

Armed Robbery – 3rd / Custer – 1/30/18, 2:00 pm

A news crew was returning to their van with camera equipment when a gray sedan pulled up and stopped along-side them. One of the occupants got out and pointed a gun at one of the crew members who was carrying a video camera. The suspect ordered the victim to hand over the camera and the victim, fearing for his life, complied. The suspect returned to the waiting vehicle and got in before the car sped from the scene. This incident is under investigation. (SFPD Case No. 180080312)

Fraud, Mail Theft Arrest – Rhode Island / 23rd – 1/30/18, 3:53 pm

Officers responded to a call of a several suspects in a vehicle casing the homes in the area. An officer located a suspect on the **1000 block of Rhode Island**. She was identified by a resident as having trespassed onto her property. Another resident approached the officer and told her that the suspect had ditched some packages behind a nearby tree prior to being detained. The parcels were recovered and were found to have been stolen from the front of a mid-block residence. The suspect was arrested. Other officers detained two additional suspects nearby who were located with the vehicle described in the complaint. There were packages in the vehicle addressed to multiple residences, several of which had been stolen from the **1100 block of Rhode Island**. The officers were able to identify at least 16 package theft victims from the stolen mail recovered during their investigation. All three suspects were booked on multiple theft and fraud related charges along with possession of stolen property and conspiracy. (SFPD Case No. 180080776)

Armed Robbery – Hudson / Whitney Young – 1/30/18, 6:55 pm

Two victims, ages 34 and 28, were in their work truck when a black sedan pulled up and stopped behind them. Four suspect got out and surrounded the car. One of the suspects began removing tools from the bed of the victims' truck when the victims got out to stop him. One of the suspects produced a knife and stabbed one of the victims while another suspect attacked and punched the other victim. The suspects stole the tools from the trucks along with a wallet before getting back into their car and fleeing. One of the victims required medical treatment for his injuries. This incident is under investigation. (SFPD Case No. 180081382)

Robbery Arrest– Cameron / Fitzgerald – 1/31/18, 9:34 am

A 35 year old victim was walking to a friend's house when he was attacked from behind and shoved to the ground. The suspect stole the victim's shoes and wallet before running off. Officers responding to the scene spotted a suspect, who matched the broadcasted description, running from the area. He was detained and positively identified by the victim as the assailant. The stolen property was recovered and returned to the victim. The suspect was booked on robbery charges. (SFPD Case No. 180082528)

Robbery Arrest – 3rd / Williams – 2/01/18, 11:15 am

A 67 year old victim got out of his car in the Walgreens parking lot and noticed

a suspect following him as he walked into the store. The suspect followed him while he was in the store and also followed him out. When they got outside, the suspect grabbed the keys that the victim had attached to his belt and forcefully yanked them from the victim before running off. The officers searching for the suspect located a subject who matched the description provided at 3rd and Newcomb. He was detained and positively identified by the victim. He was placed under arrest. The victim's keys were recovered from the suspect's pocket. The suspect was booked on robbery and elder abuse charges. (SFPD Case No. 180085475)

Aggravated Assault – 1800 block 26th – 2/01/18, 8:30 pm

A 48 year old victim was outside of his home when the suspect, who the victim knew and had a history of altercations with, approached him with a baseball bat. The suspect threatened the victim with the bat and the victim ran off. The suspect chased him down and managed to strike the victim with the bat once before fleeing the scene. This incident is under investigation. (SFPD Case No. 180087051)

Recovered Firearm – 1400 block Newcomb – 2/03/18, 8:57 pm

Officers served a search warrant on the home of a suspect after an investigation into a separate assault incident yielded evidence that he was in possession of a firearm. The suspect was not at home at the time of the search. The officers seized a **.40 caliber handgun**, multiple magazines, ammunition, as well as a bullet-proof vest from the residence. An arrest warrant for the suspect is pending. (SFPD Case No. 180091745)

Firearm Arrest – Innes / Hunters Point – 2/03/18, 9:52 pm

Officers stopped a car for a traffic violation and discovered that the driver was on active probation with a search condition. The officers removed the driver from the vehicle as they prepared to search the car. The suspect was seen to be attempting to discard a metal object, which turned out to be a **.25 caliber pistol**, which he had concealed on his person. The suspect, a convicted felon prohibited from possessing weapons, was arrested and booked on multiple weapons charges as well as a probation violation. (SFPD Case No. 180092602)

Vandalism Arrest – 400 block Cesar Chavez – 2/03/18, 11:50 pm

Officers responded to Pier 80 regarding a suspect who had bitten the victim and then tried to board a ship. The victim, a pier employee, told the officers that the suspect trespassed onto the property and set off an alarm when attempting to gain entry through a gate to get on to a ship that was moored at the dock. The victim grabbed the suspect and was in the process of escorting him off the property when the suspect turned and bit the victim on the shoulder. The suspect then ran off back to the vessel. The officers located the suspect submerged in the water as he held on to one of the ropes connected to the ship. He was arrested and booked on vandalism and trespassing charges. (SFPD Case No. 180092771)

Shots Fired – 2100 block McKinnon – 2/04/18, 8:10 am

Officers responded to a Shot-Spotter activation and located a spent casing in the street. No injuries or damage were reported as a result of the firearm. This incident is under investigation. (SFPD Case No. 180093393)

Stabbing – Oakdale / Bayshore – 2/04/18, 12:00 pm

Officers responded to a call of a stabbing and located a 54 year old victim who had a laceration to his neck. He told the officers that he had been visiting the tent of a friend when the suspect arrived. The victim and suspect know each other from the area and are not on friendly terms. The victim told the suspect to leave and the suspect punched him in the neck before running away. The victim then realized that he had been stabbed. He was treated at ZSFGH for his injuries. This incident is under investigation. (SFPD Case No. 180093763)

Robbery – 200 block Silliman – 2/05/18, 6:00 pm

A 41 year old victim was walking home with her purse slung over her shoulder when a suspect ran up from behind and grabbed the bag. The suspect caused the victim to fall to the ground and dragged her until she finally let go of the purse. The suspect then ran off east on Silliman. This incident is under investigation. (SFPD Case No. 180096999)

[Suspicious Activity Defined](#)

[Community Policing Defined](#)

Suspicious activity is any observed behavior that could indicate a crime-related incident had been committed, or about to be committed.

Examples:

- An individual peering into vehicles or trying door handles, appearing to trying to locate any valuables
- An individual checking front doors of residences, or attempting to locate unattended packages, or following delivery trucks to see where packages are being dropped off.

Crime Defined

Robbery- The taking of property from another by use of force or fear.

Assault- The unlawful attempt, coupled with present ability, to commit a violent injury on another person. *Assault* is when a person swings their arm and *Battery* is when that arm makes contact with another.

Misdemeanor Battery- Any willful and unlawful touching of another

Felony Battery- The use of force or violence upon the person of another that causes serious bodily injury.

Aggravated Assault- Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

Burglary- The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft- Theft committed when the value of the money, labor, or property taken exceeds \$950

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the community.

- **Homeless Outreach and outreach to Drug Users:** Bayview Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support
- **Foot Patrols:** Bayview Station has beat officers assigned to the 3rd St. corridor, 18th St., and San Bruno Avenue.
- **Monthly Community Relations Meetings:** Community Meetings are held continuously on the first Tuesday of each month. Officers also attend meetings with merchant groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving
- **Email Updates:** Bayview Station sends out weekly newsletter updates to district residents that outline crime trends, upcoming community events, crime prevention tips, and contact information.

Petty Theft- Theft where the value of property taken is less than \$950

Types of Crime Reports That Can Be Filed Online:

- **Harassing Phone Calls:** When you are experiencing annoying calls - with no known suspects; for example, hang-ups or heavy breathing.
- **Lost Property:** When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- **Theft:** When property is stolen but there has been no illegal entry or contact by the thief.
- **Vandalism/Graffiti:** The act of changing, modifying or defacing public or private property, including graffiti.
- **Vehicle Burglary:** When property was stolen from a vehicle.
- **Vehicle Tampering:** Tampering with a motor vehicle, including vandalism/graffiti of the vehicle.

Calling the Police:

Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.





To celebrate the conclusion of what has likely been a week long of debauchery for SF Beer Week we are going to do our part to help clean up the Bayview.


On our first cleanup we removed over 3400 pounds of garbage from the Bayview State Park and are hoping to bump that number to 5000 pounds this time!

SFPD, CA DOJ, SF Mayor Mark Farrell Announce Independent Evaluation of SFPD Reforms

MAYOR MARK FARRELL, CALIFORNIA ATTORNEY GENERAL XAVIER BECERRA AND POLICE CHIEF WILLIAM SCOTT ANNOUNCE INDEPENDENT EVALUATION OF SAN FRANCISCO POLICE DEPARTMENT REFORMS

California Department of Justice to provide support following departure of U.S. Department of Justice decision to end Collaborative Review Initiative Agreements

San Francisco, CA—Mayor Mark Farrell, California Attorney General Xavier Becerra and Police Chief Bill Scott today announced that the California Department of Justice will collaboratively evaluate and report on ongoing reforms and the implementation of 272 recommendations at the San Francisco Police Department (SFPD).

This new agreement follows the decision by United States Department of Justice Attorney General Jeff Session to abandon collaborative effort with the SFPD to reform officer use-of-force policies, improve racial bias trainings, and enhance community policing, transparency and accountability efforts.

“We made a promise to our residents and to our communities that we were going to transform our police department—and partnering with Attorney General Becerra will allow us to follow through on that pledge,” said Mayor Farrell. “The SFPD has made measureable progress already, and the steps we have taken since the United States Department of Justice walked away have only strengthened our department. These reforms emphasize that every life is precious and every effort will be made to protect and defend our residents from harm. Our City is committed to making the SFPD a model law enforcement agency with the highest standards for accountability and transparency. I want thank the men and women of the SFPD for their commitment to reform. We are eager to see these efforts through with the help and partnership of the California Department of Justice.”

“When local law enforcement agencies reach out for support, the last thing our federal government should do is abandon them,” said Attorney General Becerra. “The California Department of Justice will stand with fellow law enforcement agencies that ask for vital assistance to promote trust, transparency and ultimately ensure public safety – both for our men and women wearing the badge and the communities they are sworn to protect. This agreement with the City and SFPD is critical for public safety. It serves as a prime example of state and local authorities collaborating in the absence of help from Washington.”

In 2016, Mayor Edwin M. Lee asked the U.S. Attorney General Loretta Lynch and the United States Department of Justice (DOJ) to conduct a comprehensive review of the SFPD, with a specific focus on reforming use-of-force strategies.

The following year, the DOJ referred the request to the Office of Community Oriented Policing Services (COPS) and signed an agreement to outline multi-year agreements with independent monitoring teams to ensure a sense of accountability and to rebuild trust with communities. The COPS team identified 94 findings and 272 recommendations that emphasized the safeguarding of life above all else. Today, more than half of those critical reforms have been implemented or are in the approval process and as a result, use-of-force incidents dropped 18 percent in 2017.

However, the DOJ under the administration of President Donald Trump has reversed course on providing community-oriented policing assistance to local law enforcement agencies. Last September, Attorney General Sessions announced that the DOJ's COPS office would no longer collaborate with the SFPD on the reform process. When that occurred, conversations began between San Francisco and the California Attorney General to ensure that the reforms continued.

"These issues are personal for me," said Board of Supervisors President London Breed. "I have witnessed firsthand the consequences that stem from a lack of trust between our communities of color and law enforcement agencies. That is why I was one of the leaders who called upon the Department of Justice to provide an independent review of our Police Department which resulted in 272 recommendations. While our current Federal Administration may believe these collaborative approaches are no longer a priority, here in San Francisco we are not stopping. We are committed to these reforms and will continue to work with the California Department of Justice to advance them."

"Our residents need accountability, they need transparency and they need closure," said Supervisor Malia Cohen. "We will not abandon these critical reforms. Though the Federal Government has shown a lack of leadership, the State and the City are continuing forward for our community's safety. We will not give up until we restore trust between our law enforcement agencies and our communities of color."

"Our department and our San Francisco communities are witnessing the positive outcomes of Collaborative Reform," said San Francisco Police Chief William Scott. "Since we began this process, Use of Force has decreased 18 percent year over year and complaints against officers are down 8.5 percent. This collaboration with the California Department of Justice will reaffirm the independent evaluation of our work and provide the technical expertise necessary to help improve our police department. With the assistance provided by the California DOJ, the changes we are making will become long-lasting and embedded in our department culture."

Since the reform efforts began in 2016, the SFPD has completed 81 of the recommendations, submitted 79 others for review and begun the process on the remaining 112. The initiatives include the enhancement of existing policies that emphasize the safeguarding of human life, de-escalation techniques, and Crisis Intervention Team (CIT) training to respond to individuals experiencing mental or behavioral health crises. Additionally, leadership in the ranks has become more diverse, nearly tripling the

number of women in leadership positions and more than doubling the number of minorities in leadership positions.

Other key accomplishments from the reforms include:

- Complaints to the Department of Police Accountability declined 8.5 percent in 2017.
- 819 SFPD members have attended the 40 hour CIT Certification course which provides trainees a set of tools to utilize in critical situations.
- The Department's Use of Force Policy was updated by the Police Commission following extensive discussion and public hearings.
- The Department's Training Division implemented mandatory Implicit Bias and Procedural Justice Training for all sworn members.
- Use-of-Force reports are now published on a quarterly basis.
- All electronic communications via department owned devices (cellphones, email and patrol car terminals) are automatically screened for uses of biased language. Violations are automatically forwarded to Internal Investigations for follow up.
- Officer encounters with the public are now recorded with the Department's eStops app and reported on a quarterly basis.
- The Community Engagement Division has been restructured to provide a strategic and department-wide platform to enhance SFPD's community policing and outreach efforts.
- The Department relaunched the Community Police Academy to provide citizens with opportunities to learn about how officers operate and interact with the community.

Dispose of Unwanted and Expired Medication at Bayview Station

There is a new secured bin at Bayview Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of prescription and off the shelf medication except for:

- *Herbal Remedies*
- *Vitamins*
- *Supplements*



- *Cosmetics*
- *Other personal care products*
- *Compressed Cylinders*
- *Aerosols*
- *Inhalers*
- *Medical Devices*
- *Sharps*
- *Illicit drugs*
- *L odine containing medication.*



When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a clear plastic zip top baggies. Contact the front desk officer

and inform them that you want your medication dispose of. The officer will assist you.

Please note that once an item that had been disposed of inside the bin, we cannot retrieve it. So make sure your ring, cell phone or anything of value is not accidentally disposed of.

With over 2,300 different telephone numbers listed to access local government services, many people did not know what number to dial to reach the appropriate department. Now you can connect to city services with only two numbers to remember: **911** for emergencies and **3-1-1** for everything else.

Before 311, over 50% of calls to the 911 center were not emergency related. **311** relieves 911 operators from these non-emergency calls. If a catastrophic emergency

such as an earthquake occurs, **311** operators will be able to provide accurate information to assist during the recovery. In the unlikely event the 911 facilities becomes inoperative, the **311** call center will function as a back up.
