Captain's Message

SFPD Announces Arrests in Home Burglary Series

Monday, April 09, 2018

Suspects Allegedly Stole Nearly \$3 Million in Currency, Credit Cards and Jewelry



In November of 2017, the San Francisco Police Department's newly

established Burglary Unit identified a pattern of residential burglaries occurring frequently in the Bayview, Ingleside and Taraval districts. Over the course of the investigation, members of the Burglary Unit determined that as many as sixty of the residential burglaries were being committed by serial burglary crews.



During the commission of the burglaries, the crews used multiple vehicles with paper license plates and attempted to disguise their identities. The suspects gained entry to the burglarized homes by forcing their way through locked gates and breaking front and rear doors of the residences. The burglaries occurred in occupied and unoccupied homes.

Burglary Unit investigators determined that eleven firearms, hundreds of pieces of jewelry, US and foreign currency, credit cards, passports, vehicle titles and vehicle keys were stolen, valued at nearly \$3,000,000.00.

Assisted by numerous local, regional, out-of-state, and federal agencies, SFPD was able to identify nearly thirty individuals responsible for or accomplices in the burglaries. As a result, the department authored and served several search and arrest warrants over the last ninety days in San Francisco, Oakland, Antioch, Brentwood and Las Vegas.

During the serving of these warrants, nine of eleven known stolen firearms were recovered. In the search warrant served in Brentwood last week, four more firearms were recovered, including two that were stolen in separate burglaries in Fremont, CA and Reno, NV.



Investigators also recovered multiple pieces of stolen property including jewelry, passports, US and foreign currency and eight vehicles used in the burglaries.



Of the thirty individuals identified in the investigation, ten have been apprehended along with two additional individuals arrested during the search warrant served in Brentwood. SFPD continues to investigate the remaining individuals for their involvement in the burglaries.

"With these arrests, there has been a marked decrease in burglaries in the Bayview, Ingleside and Taraval districts," said San Francisco Police Chief William Scott. "Our establishment of a General Crimes Unit to focus on serial residential and commercial burglaries, auto break-ins, bicycle thefts and other neighborhood property crimes is bearing results. We will continue to pursue crime prevention and investigation strategies that will increase safety for all and help bring justice for victims of serial criminals."



The ten individuals arrested to date in this burglary series are:

- 23 year-old Demarria Conley of Antioch, charged with conspiracy, burglary, possession of stolen property, and resisting arrest
- 64 year-old Steve Levy of Oakland, charged with firearms violations
- 44 year-old Jabari Jackson of San Francisco, charged with multiple counts of possession of stolen property and vehicle theft
- 25 year-old Kelvon Watts of San Francisco, charged with assault with great bodily injury and elder abuse
- 33 year-old Marshay Goodspeed of Antioch, charged with burglary and reckless evasion
- 26 year-old Jimmy Heard of San Francisco, charged with burglary and destruction of evidence
- 26 year-old Corey McCroey of San Francisco, charged with burglary and destroying evidence
- 25 year-old Mandela Mabrey of Marin City, charged with resisting arrest and a warrant

- 40 year-old Melvin Glaspie of San Francisco, charged with burglary and destroying evidence
- 46 year-old Marcus Broussard of San Francisco, charged with firearms violations, possession of stolen property and narcotics violations

Booking photos of these individuals are attached to this news release, along with photos of some of the stolen vehicles, property and guns recovered by investigators. Armed Robbery Attempt - 1100 block Carroll - 4/4/18, 12:20 pm

A 58 year old victim and his 57 year old wide were walking along a trail at the **Candlestick Point Recreational Area** when they were approached by two suspects. One of the suspects was armed with a gun. He pointed the weapon at the victim and demanded his money and phone. The victim pretended not to understand and the suspects grew frustrated and ran off. The victims flagged down a police car on **Harney Way** and reported the incident, which is under investigation. (SFPD Case No. 180249132)

Auto Theft Arrest - Felton / Dartmouth - 4/4/18, 6:42 pm

Officers were notified that a Daly City detective had followed a stolen vehicle into the Bayview and responded to assist. The officers located the stolen truck and stopped it without incident, arresting the driver. The suspect was booked on auto theft and possession of stolen property charges. (SFPD Case No. 180243281)

Robbery- Newhall / Fairfax - 4/5/18, 4:50 pm

A 37 year old victim and her adult daughter had just left a bank and were walking got their car when the suspect approached her and grabbed her purse. She struggled over the bag but became aware that the suspect was possibly armed and let go of it. The suspect fled on foot. This incident is under investigation. (SFPD Case No. 180252674)

Hot Prowl Burglary Arrests-100 block Maddux-4/6/18, 8:00 am

A resident of a home on the **100 block of Maddux** tuned in to a live surveillance feed of her house and saw that it was being burglarized. She called the police and officers arrived to see three suspects exit the rear of the residence and hop neighboring backyard fences. One of the suspects went to the back of a home on the **300 block of Bridgeview** and broke out a window. He climbed in followed by the two other suspects as the officers gave chase. The resident told the officers that the suspects had run through her house and broke out through her garage door onto Bridgeview. They ran up towards Topeka and split up. A perimeter was set up to search for the suspects. One of the suspects was located hiding under a truck on the **200 block of Topeka**. He had. A second suspect was located and arrested in the Foods Co parking lot on the **300 block of Williams**. The suspects were booked on multiple burglary, attempted burglary, and conspiracy charges. An investigation into the identity of the third suspect is ongoing. (SFPD Case No. 180254476)

Vandalism Arrest – Egbert / Jennings – 4/7/18, 1:00 pm

Officers responded on a call of a vandalism and met with the victim who reported seeing a suspect puncture one of the tires of his parked car after gaining access to the unlocked passenger compartment and breaking the dash assembly. The officers located the suspect in the area and he was positively identified. He was arrested on a citizen's arrest and booked on vandalism and trespassing into a vehicle charges. (SFPD Case No. 180257163)

Firearm Arrest – 100 block Dolphin – 4/7/18, 8:12 pm

Officers responded to a call of a vehicle, being tracked by the National Park Police, which was suspected to be involved in an auto burglary. The officers located the vehicle and approached as the driver was manipulating it into a parking space. They detained the suspect and when he got out of the vehicle, the officers heard a metallic object drop to the ground. The officer with the suspect looked down and saw a handgun on the ground at the suspect's feet. He was immediately arrested and the **loaded 9mm pistol** was seized. Another handgun, a **loaded .40 caliber** semi-automatic, was located on the floorboard of the driver's seat inside the vehicle. The suspect, a convicted felon prohibited from possessing weapons, was booked on multiple weapons charges. The National Park Police handled the original auto burglary investigation. (SFPD Case No. 180258224)

Aggravated Assault w/ Knife – 100 block Dakota – 4/7/18, 11:00 am

Officers responded to ZSFGH and met with a 24 year old victim who was being treated for a laceration to her neck. She reported that she had returned to her residence and noticed that a pack of cigarettes was missing from her porch. She suspected a subject, who had been hanging out on the block, of taking the pack. She confronted the suspect who actually admitted to taking the cigarettes and returned the pack. He then asked for it back, stating that he had left some narcotics in it. The victim refused and the suspect grabbed her and put a knife to her neck. The victim gave him the pack of cigarettes and he fled the scene. She realized that she had been cut and went to the hospital on her own. This incident is under investigation. (SFPD Case No. 180258707)

Armed Robbery – Davidson / Quint – 4/8/18, 4:00 am

A 37 year old victim, a bit tipsy from having been drinking, got into a car that he believed was his Uber ride. It was not. The suspect that was driving the vehicle ordered the victim to give up his phone and money at gunpoint. The terrified victim complied and scrambled out of the car. The victim ran away and hid in some bushes where he sat for about two hours before getting out and reporting the crime. This incident is under investigation. (SFPD Case No. 180258860)

Hit & Run Pedestrian- San Bruno / Woolsey - 4/08/18, 9:50 pm

A vehicle traveling north on San Bruno struck a pedestrian in the crosswalk at Woolsey. The dark colored sedan continued without stopping. The victim suffered serious injuries and was transported to ZSFGH for treatment. This incident is under investigation. (SFPD Case No. 180260382)

Auto Theft Arrest- 2500 block Marin - 4/9/18, 3:50 pm

Officers on patrol heard a car alarm go off nearby and responded to the location. As they turned a corner, they saw a suspect take off from a wailing vehicle with a broken window. They apprehended the suspect and recognized him from a department bulletin that identified him as wanted in connection with at least five separate auto thefts. The suspect was taken into custody and booked. (SFPD Case No. 180243792)

Robbery-Silver / Brussels - 4/10/18, 7:24 am

A 54 year old victim was walking along the street when a suspect ran up and snatched her purse form her. The victim struggled over the bag and was shoved to the ground by the suspect who then fled on foot. This incident is under investigation. (SFPD Case No. 180263728)

Aggravated Assault Arrest- 4600 block 3rd - 4/10/18, 9:30 am

Officers responded to a call of a suspect chasing people around with a knife. They located four victims, ages 19 to 52, who were all construction workers in the area. They told the officers that the suspect randomly attacked all of them, one at a time, as they worked. The suspect held a knife during the attacks in which he approached the victims individually, struck or kicked them, then ran off to the next person. The officers located the suspect at 3rd and Newcomb where he was placed under arrest. He was booked on multiple aggravated assault and battery charges. (SFPD Case No. 180264077)

Robbery-Boutwell / Industrial - 4/10/18, 3:35 pm

A 46 year old victim was standing outside when a suspect snatched his cell phone from his hand. The suspect then jumped on the victim and struck him before running off. The victim knew the suspect and told the officers that he had a restraining order against him. A warrant in this case is pending. (SFPD Case No. 180265207)

Aggravated Assault w/ Gun arrest- McKinnon / Selby - 4/10/18, 5:00 pm

Officers met with a 37 year old victim on who reported that he had been threatened by a former employee. The victim stated that he left his place of business and noticed the suspect seated in a parked car. As the victim drove past him, the suspect pointed a handgun at him. The victim drove around the block and returned to find the suspect still seated in the vehicle. He again pointed the weapon at the victim, who was able to get the license plate of the suspect's car before leaving the scene. The victim explained that the suspect had left the company on bad terms and was afraid her was a danger to himself and other employees. Officers responded to the address associated with the suspect's vehicle on the **100 block of Coleridge St.** He was observed driving in the area and was pulled over and arrested on being positively identified by the victim. The suspect was booked on aggravated assault charges. (SFPD Case No. 180265439)

Robbery- Revere / Lane - 4/10/18, 6:40 pm

A 45 year old victim was exiting a store when a suspect on the street yelled an epithet at him. He continued walking to his car when the suspect suddenly struck him in the back of the head. The victim fell and the suspect punched and kicked him. The dropped his phone during the attack and saw a second suspect pick it up before both suspects fled on foot. This incident is under investigation. (SFPD Case No. 180265796)

Suspicious Activity Defined

Suspicious activity is any observed behavior that could indicate a crimerelated incident had been committed, or

Community Policing Defined

Community policing, or communityoriented policing, is a strategy of policing that focuses on police building ties and about to be committed.

Examples:

- An individual peering into vehicles or trying door handles, appearing to trying to locate any valuables
- An individual checking front doors of residences, or attempting to locate unattended packages, or following delivery trucks to see where packages are being dropped off.

Crime Defined

Robbery- The taking of property from another by use of force or fear.

Assault- The unlawful attempt, coupled with present ability, to commit a violent injury on another person. *Assault* is when a person swings their arm and *Battery* is when that arm makes contact with another.

Misdemeanor Battery- Any willful and unlawful touching of another

Felony Battery- The use of force or violence upon the person of another that causes serious bodily injury.

Aggravated Assault- Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

Burglary- The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft- Theft committed when the value of the money, labor, or property taken exceeds \$950

Petty Theft- Theft where the value of property taken is less than \$950

SFPD and Department of Homeland Security/Homeland Security Investigations Announce Arrests in San Francisco Homicides

Friday, April 06, 2018

San Francisco Police Department Chief William Scott and Special Agent in Charge for Homeland Security Investigations Ryan L. Spradlin today announced arrests in six homicides committed in San Francisco between 2006 and 2013.

San Francisco Police Department Homicide investigators worked in collaboration with Homeland Security Investigations investigators to develop leads and new evidence that lead to a federal indictment of suspects in these cases.

"The arrests in these criminal cases were made possible through the collaborative partnership between the police department and Homeland Security Investigations," said Chief William Scott. "Through diligent investigative work and careful coordination, law enforcement agents this week were able to safely take several homicide suspects into custody without incident. We hope that these arrests will bring a measure of comfort and healing to the families of the victims, many of whom have waited years for justice."

Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on April 4th, 5th, 12th, 17th, 24th and 26th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.



Dispose of Unwanted and Expired Medication at Bayview Station

There is a new secured bin at Bayview Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of prescription and off the shelf medication **except** for:

Herbal Remedies

- Vitamins
- Supplements
- Cosmetics
- Other personal care products
- Compressed Cylinders
- Aerosols
- Inhalers
- Medical Devices
- Sharps
- Illicit drugs
- L odine containing medication.

When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a clear plastic zip top baggies. Contact the front desk officer and inform them that you want your medication dispose of. The officer will assist you.



Please note that once an item that had been disposed of inside the bin, we cannot retrieve it. So make sure your ring, cell phone or anything of value is not accidentally disposed of.

With over 2,300 different telephone numbers listed to access local government services, many people did not know what number to dial to reach the appropriate department. Now you can connect to city services with only two numbers to remember: **911** for emergencies and **3-1-1** for everything else.

Before 311, over 50% of calls to the 911 center were not emergency related. **311** relieves 911 operators from these non-emergency calls. If a catastrophic emergency such as an earthquake occu<u>rs</u>, **311** operators will <u>be able to provide accurate</u>

information to assist during the recovery. In the unlikely event the 911 facilities becomes inoperative, the **311** call center will function as a back up.
