Captain Paul Yep's Message

I recently received an email from a citizen about his interaction with Officers from Central Station and I would like to share it with our community:

"Captain Yep -

At 3:11 a.m. this morning I called -911 for a woman screaming in the 400 block of Union Street. She was screaming at the top of her lungs, and her screams sounded like someone in pain. When I phoned from my apartment, I couldn't see her, only hear her. I thought she was being beaten up, but when I went downstairs to wait for the officers, the woman was alone. It seemed the "beating" I heard was only the woman herself, beating on car hoods.

The officer I spoke with downstairs on Union Street is Officer Fitzpatrick. I told her I would write you with my name, and identify myself as the person who phoned in; hence this email.

Your officers did as good a job as humanly possibly in very difficult circumstances. There were four officers in all, two policewomen and two policemen. No harsh words were spoken. No threats were made (except from the screaming woman to the police). They asked her many times if she felt that she wanted to hurt herself or anyone else.

Fire and Rescue also came. She was gently placed on a gurney and taken to hospital. She was an African American woman about 35 years old. She appeared to be about 5'7" and was strong-- not frail-- in appearance. When I arrived, the officers were holding her on the ground and speaking to her. She was screaming at the officers, some of it obscene, some of it racial, some of it nonsensical. She said she had been homeless for 10 years. I didn't recognize her from the neighborhood or from our dinners. I was told later by the police that she was probably on meth.

Now she is gone. Poor soul!"

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

The suspect tried to flee, but a patron grabbed him to prevent him from escaping and a struggle ensued. Officers arrived and the fight stopped. Patrons and the victims positively identified the suspect. Arrest made.

Officers in the Tenderloin saw a suspect matching the description and detained him. The victims positively identified the suspect. Arrest made.

The suspect was then escorted out of the hotel. As she was leaving, she struck the victim with a metal chain wrapped around her wrist. Arrest made.
8/4	3:20am	Aggravated Assault, With Other Weapon 600 BLK of Market	The victim was sitting at the bus stop when an unknown suspect sat next to him. The suspect grabbed the victim's cane and struck him with it multiple times. The suspect then punched the victim multiple times. The suspect then fled the scene.
8/11	2:20am	Aggravated Assault, With Other Weapon Columbus/Broadway	The suspect approached the victim and struck him with a buckle causing the victim to fall. The suspect walked into the intersection and struck three vehicles with the belt causing damaged. Officers located the suspect in a store yelling and throwing things around. Arrest made.

Robbery

Robbery – Robbery is the taking of property from another by using force or by using fear.

The suspects tried to engage in a conversation with the victim, but the victim did not want to speak with them. The victim ran into a building, but was followed by one of the suspects. 8/5	10:50am	Robbery, Attempt, Commercial, With Knife 500 BLK of Geary	An unknown suspect entered the store and filled a basket with merchandise. As the suspect walked towards the exit, an employee pulled the basket from the suspect and a struggle ensued. The suspect then pulled out a box cutter. The employee backed away and the suspect fled the scene.
8/5	12:25pm	Robbery, Commercial, With Force 200 BLK of Powell	An unknown suspect entered the store and stole merchandise. An employee confronted the suspect at the door. The suspect pushed the employee out of the way and fled the scene.
8/6	2:15am	Robbery, Commercial, With Knife Unit BLK of Drumm	An unknown suspect threw money on the counter, reached over the counter and grabbed a Lotto Scratchers. 8/6	12:26pm	Robbery, With Force Battery/California	An unknown suspect approached the victim and stole her cell phone from her hands. The victim tried to get her cell phone back, but was pushed by a second suspect. Both suspects then fled the scene.
8/7	5:27pm	Robbery, Commercial, With Other Weapon 100 BLK of Post	An unknown suspect entered the store and stole merchandise. An employee confronted the suspect. The suspect pulled out a needle and threatened to stab the employee with it. Fearing for his safety, the employee moved out of the way. The suspect then fled the scene.

While trying to detain the suspect, the suspect hit security in the face. The suspect then fled the scene, but dropped the item on the ground while fleeing.
8/10	3:55pm	Robbery, Commercial, With Force 600 BLK of Kearny	An unknown suspect entered the store and stole merchandise. The suspect was confronted by the owner outside of the store. The suspect pushed the owner to the ground and fled the scene.

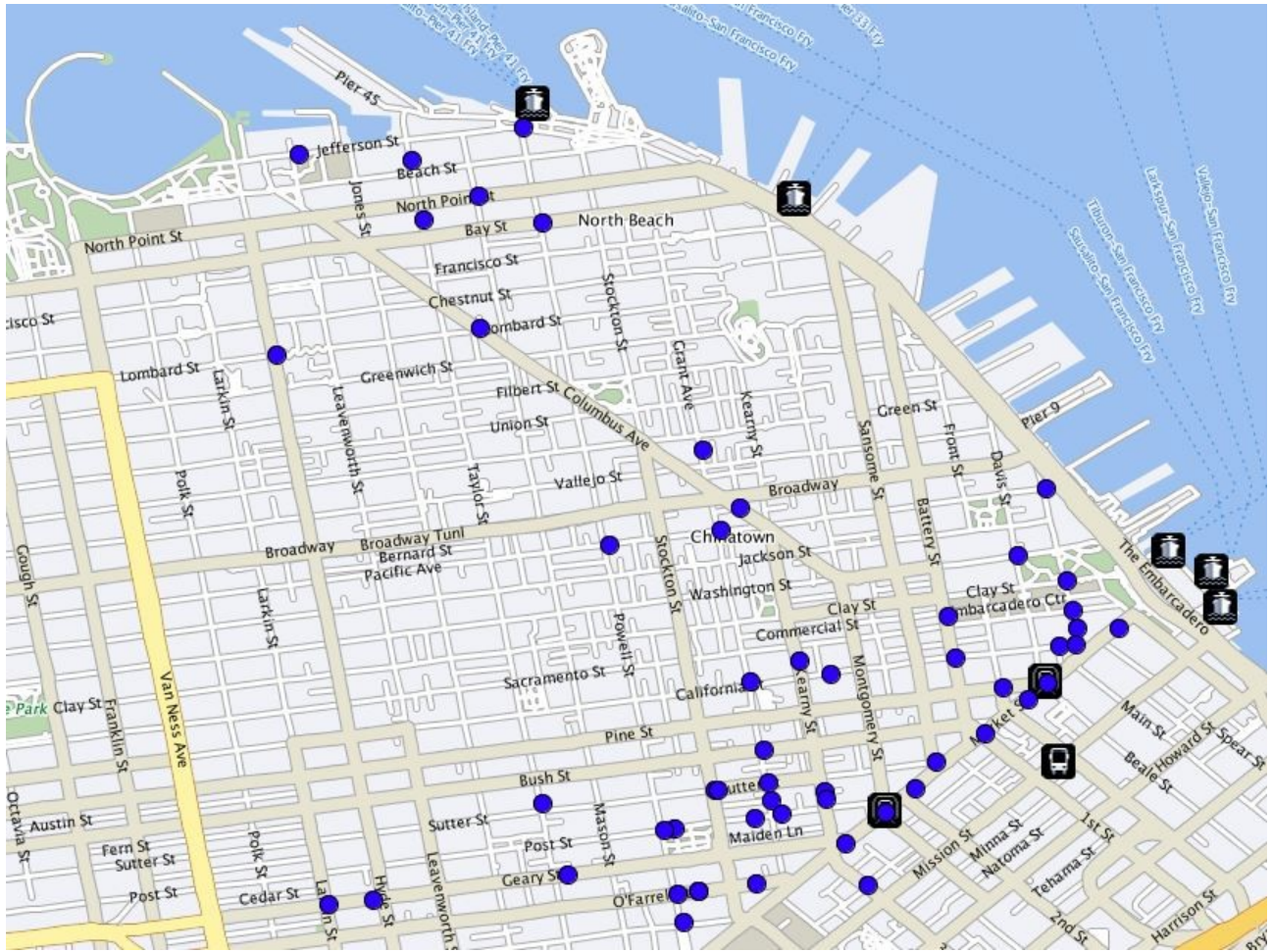

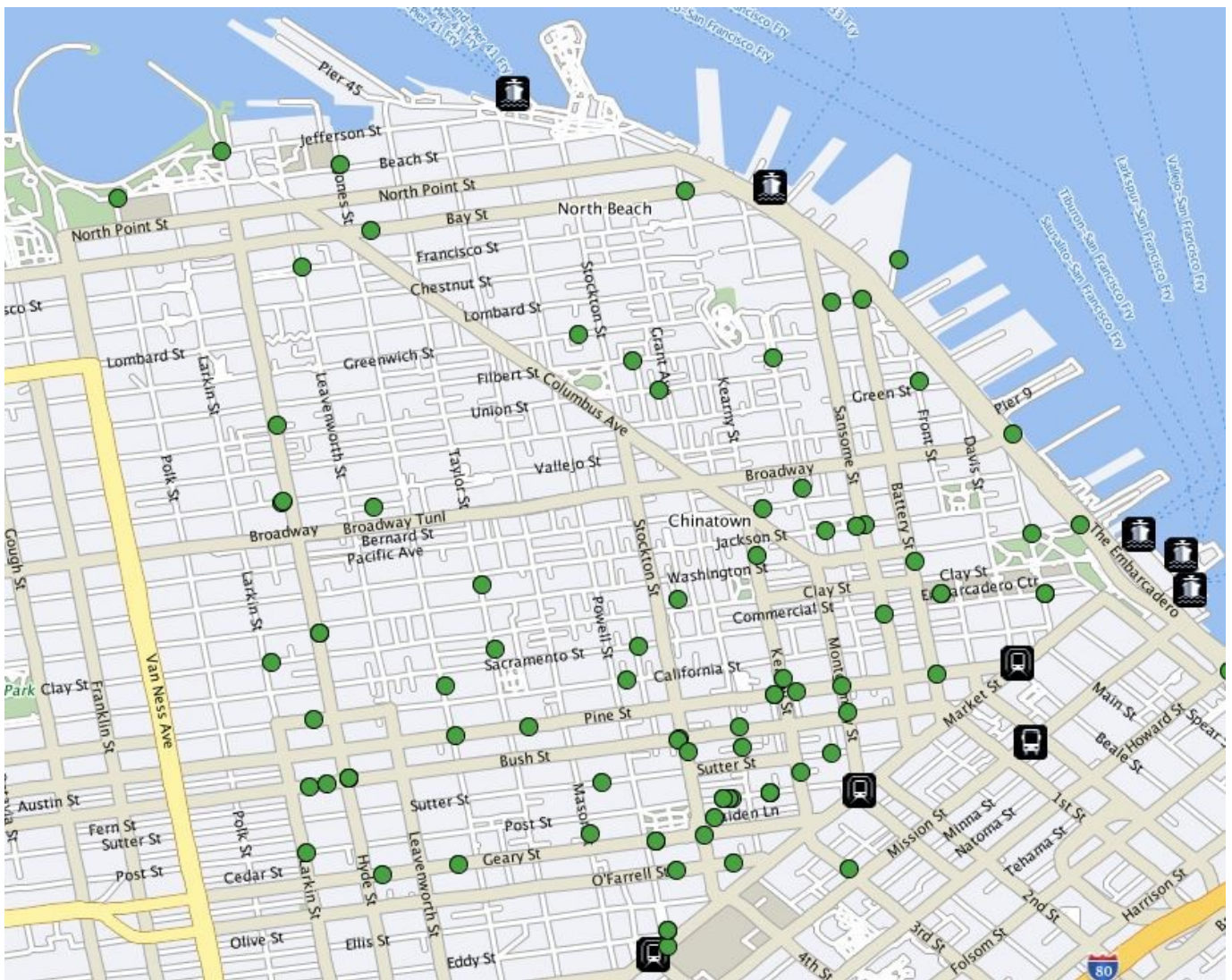

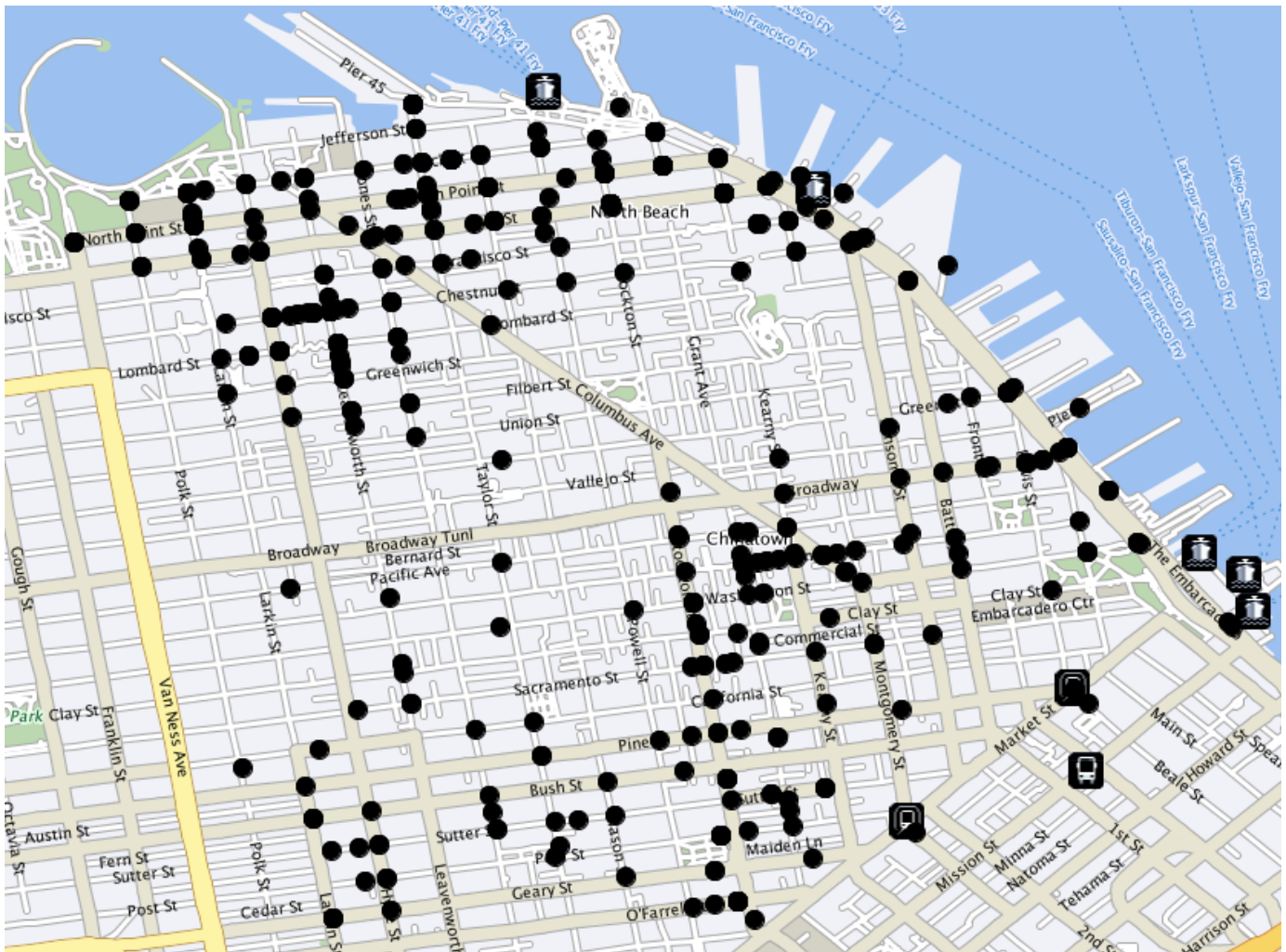

Incidents of Note

Assault, Aggravated, With Other Weapon

7/26/18 0909 hrs
1300 BLK of Stockton Street

On 7/13/18, uniformed officers were flagged down by the Victim, bleeding from the head, in front of Central Station. Officers summoned medical attention for the Victim who is in a wheelchair. The officers learned that a suspect attacked the Victim with a metal pipe, striking him in the head in an unprovoked attack. The officers responded to the location of the incident and obtained video of the incident. On 7/26/18, uniformed officers responded to the 1300 block of Stockton Street for a report of the Victim seeing the suspect from the incident on 7/13/18. Officers arrived on scene and detained the suspect, who was pointed out to them by the victim, without further incident. Officers reviewed the video footage of the incident and interviewed the suspect who confessed to assaulting the Victim. The Suspect was booked at County Jail.

Burglary, Apartment House, Unlawful Entry

7/25/18 1735 hrs
100 BLK of Alta Street

On 7/25/18, uniformed officers responded to the 100 BLK of Alta Street regarding a person breaking into an apartment building. Officers arrived on scene and met with a witness who told the officers that he observed the Suspect enter from an alleyway, through a window into the apartment. The witness who lived in the building did not recognize the suspect. The officers were able to convince the Suspect to leave the apartment through the front door where they arrested her. Officers contacted the resident of the apartment. She identified several items that belonged to her, which were located inside the Suspect's backpack at the time of her arrest. The Suspect was booked into County Jail.

Assault, Aggravated, With Other Weapon

8/3/18 0758 hrs
2600 BLK of Jones Street

On 8/3/18, uniformed officers responded to a hotel on the 2600 BLK of Jones Street on reports of an assault with a chain. Officers arrived on scene and Victim #1 pointed the Suspect out to them. Officers placed the suspect under arrest without further incident. Officers learned the Suspect entered the hotel and took coffee from a buffet area for hotel guests. When Victim #1 asked if the Suspect was a guest at the hotel, she threw hot coffee onto Victim #1 and struck him with a two foot long chain wrapped around her wrist, causing a minor injury to Victim #1. Victim #2 attempted to assist Victim #1 with the Suspect. The Suspect spat at Victim #2 and tried to strike him with the chain before leaving the hotel. The Suspect left the chain she used at the scene, which officers later seized. A computer query revealed the Suspect to be on probation out of San Francisco for aggravated assault. The suspect was booked at County Jail.

Robbery, Attempt With Force

8/4/18 1433 hrs

Grant Avenue and Sacramento Street

On 8/04/18, uniformed officers were on patrol in their vehicle, stopped at a red light when they observed the Suspect attempt to take an 80 year Victim's purse from her as she was crossing the street. The Suspect used enough force to pull the Victim to the ground and dragged her approximately three feet before fleeing the scene on foot. The Victim was able to maintain control of her purse. Officers pursued the Suspect and took him into custody without further incident. Officers returned to the scene and located the Victim as well as Witnesses. The Suspect was booked at County Jail.

Firearm, Possession By Prohibited Person

8/9/18 2344 hrs

500 BLK of Broadway Street

On 8/09/18, uniformed officers on patrol observed a vehicle make an unsafe U-turn on the 500 block of Broadway. Back to School Safety Tips

Walking to School

1. Use sidewalks or walking paths.
2. The safest place to cross streets is at crosswalks and corners.
3. Check for moving cars at driveways and intersections.
4. Obey all traffic signs and crossing guards.
5. Have a parent or trusted adult help you find the safest route.

Crossing the Street Safely

1. Stop at the curb or edge of the street.
2. Look left, right, left and behind you for traffic.
3. Wait until no traffic is coming and begin crossing.
4. Keep looking for traffic until you have finished crossing.
5. Walk, don't run across the street.
6. Don't use your phone when crossing the street.



Biking to School

1. Always wear a helmet.
2. Ride in the direction of traffic.
3. Watch for opening car doors.
4. Wear bright clothing to help drivers see you.
5. Install reflectors on the rear, front, pedals and spokes.
6. Install lights on the front **and** back of your bike.

Safer, healthier & more fun ways to get to and from school

If You Have to Drive

Do

Pull into a **passenger loading zone for drop-off**. If there is no passenger loading zone or no space available, park in a legal parking space further away. Walking is healthy.

Drop your child off at the curb on the **school side of the street** rather than crossing into incoming traffic or having your child run across the street.

Have your child sit on the **passenger side with their backpack** so they can get out of the car easily, quickly and safely.

Talk about crossing safely: Cross at corners, look all ways before crossing, and *never* run across the street.



Don't

Park in the loading zone. You can wait in the zone for up to 5 minutes but you must stay with your car. **FINE: \$106**

Park in a school bus zone during posted times. This blocks bus access and forces children to cross between parked cars. **FINE: \$106**

Double park, which creates an unsafe situation for children who are often difficult to see between cars. **FINE: \$110**

Block driveways. **FINE: \$106**

Block a crosswalk. **FINE: \$288**

Block a curb ramp or a Muni bus zone **FINE: \$288**

Let your child out on the traffic side of the car. Pull over to the curb and teach your child to be a safe pedestrian.

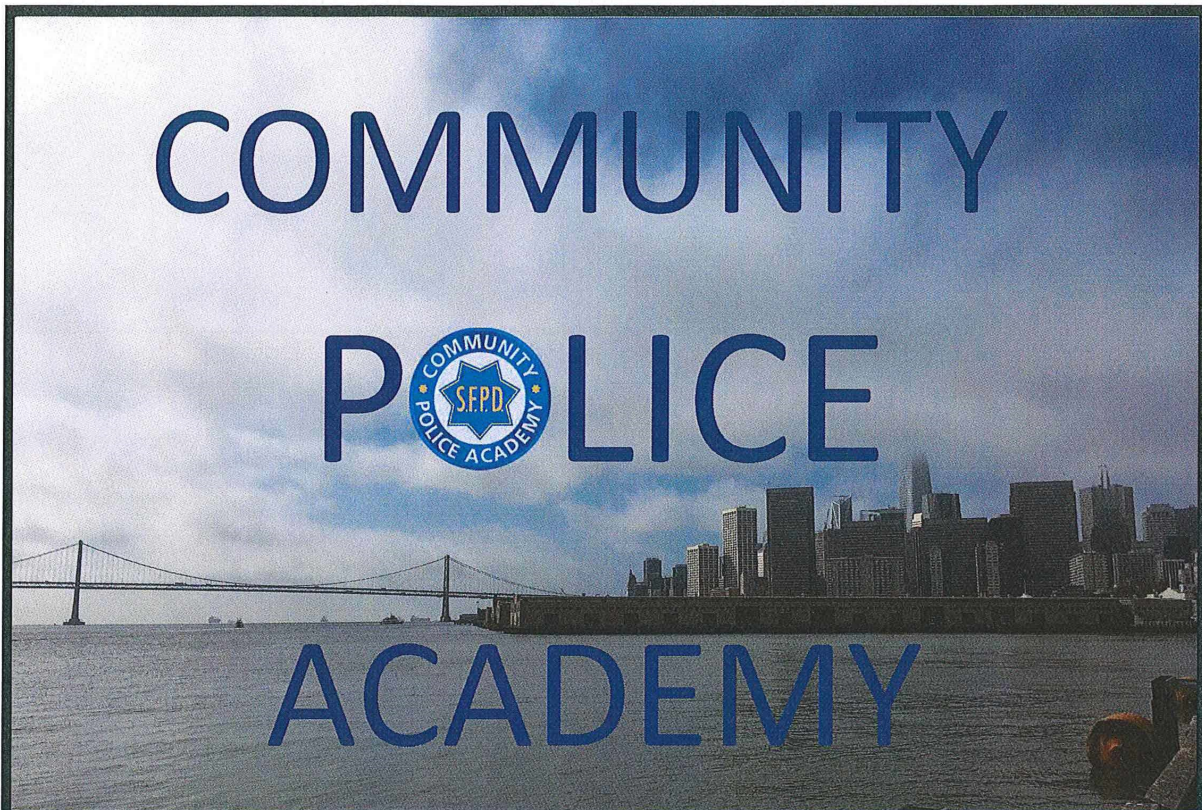

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ◆ An individual peering into vehicles to locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

Definition of Community Policing

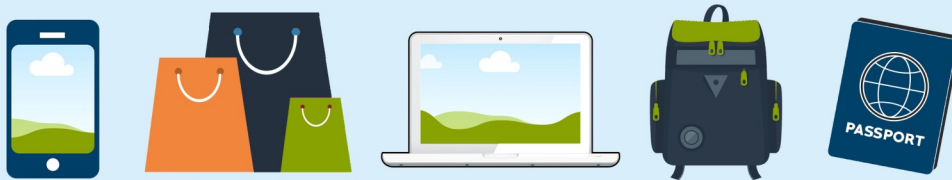
Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Central Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Central Station have beat officers assigned to Union Square, Fisherman's Wharf, Chinatown, North Beach and Market/Drumm area.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Central Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
