#### Featured Officer of the Month Ofc. George & Ofc. Demkowski



Ofc. Demkowski and Ofc. George are extremely dedicated, passionate, and hard-working on the midnight watch at Ingleside Station. In addition to performing consistently well over a period of time, here are just a couple of examples why these officers are to be commended as Officers of the Month:

Ofc. Demkowski was assigned to solo patrol on the midnight watch at Ingleside Police Station. On 01/23/2018, she saw a suspicious vehicle operating in the area of Glen Park at 3:30 in the morning. After identifying probable cause to stop the vehicle, she determined that the occupants were on parole. With the assistance of additional officers, the vehicle was searched and a fully-loaded Glock firearm with a 30-round extended magazine were located and seized. It is hard to measure how many violent crimes were prevented by this stop, search, and seizure, but this result is very hopeful and rewarding.

Ofc. George was assigned as a solo patrol officer on the midnight watch at Ingleside Police Station and was assigned to the Glen Park area. Recognizing that there had been an increase in burglaries in both the Glen Park, Diamond Heights, and outer Noe Valley areas, Ofc. George was actively patrolling back and forth between these neighborhoods. On 01/16/2018 at 0448 hours, a report of a burglary was called in around the area of the 300-block of Valley Street. Ofc. George, already in the neighborhood on active patrol, heard the description and simultaneously saw the suspect in the area of 29th Street and Day Street. After a foot pursuit, the suspect—already wanted on a "no-bail" felony burglary warrant—fought with the police and ultimately was taken into custody.

These officers' actions are just a small sample of heroic work done by midnight shift officers who keep us safe while our neighbors, families, and children sleep soundly in our beds. It is for these small and unseen—but heroic— acts, that they are our Officers of the Month.

#### **Definition of Community Policing**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city
  agencies to provide outreach and assistance to rehabilitate those who are dependent on
  illegal drugs and outreach to homeless individuals to connect them with resources and
  support.
- Foot Patrols: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously.
   Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

#### **Definition of Suspicious Activity**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are "In progress" crimes, which demand an immediate call to 9-1-1:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or

#### **Crime Definition**

Robbery - Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

\*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft –** Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

Ingleside Officers Billings and Hardy, and many other Ingleside units, responded to a report of two men with guns attempting to break into a home. When the officers arrived the suspects had already left the scene. The victims told the officers they observed one man on the sidewalk talking to another man inside a fence on the 500 block of Campbell. The man on the sidewalk quickly ran away and the second suspect, inside the fence, also tried to escape. The victim's got in their car, armed with a baseball bat, and chased the second suspect for a short distance before cornering him at Campbell and Delta Streets. When one of the victim's threatened the suspect with the bat, the suspect took out a black semi-automatic pistol and pointed it at the victims. The suspect then fled the area and the victims returned home to call police. The victims said the pair of suspects may have been among a group of squatters occupying an abandoned home in the area. We've written before about the likelihood that vehicles, with paper license plates, are likely to be stolen or involved in some crime. The vehicle code requires that all vehicles, not yet issued license plates, have a temporary registration tag in the front windshield or rear window. On this day, Ingleside Officers Peralta and Harper were on routine patrol when they spotted an older Toyota Camry with paper plates and no visible temporary registration tags. The officers noticed two men inside and a third talking to the occupants next to the passenger window. Peralta and Harper approached the Toyota and found the occupants smoking marijuana. A check of the Toyota's registration revealed it was reported stolen three days before. The driver was arrested and transported to the Juvenile Justice Center and booked on charges of possession of stolen property, possession of burglary tools, and for possession of marijuana in a vehicle by juveniles. His passenger was released to his parents and the third man was released at the scene. Report number: 180129716

#### 1:40am Mission & Silver Robbery

A man waiting for a Muni bus to take him to work became suspicious of when a gray four door Honda, with four occupants, suddenly made a U-Turn and stopped next to the curb where he was standing. The victim told Ingleside Officers George and Fogarty that a man got out of the passenger side of the Honda and grabbed his backpack from his shoulder. The victim struggled with the suspect for several seconds before the suspect punched the victim several times in the face forcing him to relinquish control of the backpack. The suspect then got back into the Honda which sped away. George and Fogarty noticed the victim was bleeding from cuts to both hands which were probably caused by a weapon the suspect used in the attack. The officers broadcast a description of the attackers and their automobile and less than four hours later Mission units stopped what they believe was the same car, with blood smears on the side, and chased several occupants before detaining them. 
#### 11:00pm 900 Blk. Geneva Robbery



# Jan 1, 2018 to Jan 31,2018 27 Incidents





#### Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on February 13th, 20th, 23rd and 28th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.





#### Homicide Investigation Leads to Officer Involved Shooting

On Friday, February 16, 2018 at approximately 6:28PM, SFPD officers responded to a shooting homicide at Oak and Stanyan Streets. Two adult males were shot and one died from his injuries.

Following that incident, a silver Toyota 4 Runner was taken in a carjacking. Through the course of an investigation, it was determined that the Toyota was stolen by the homicide suspect. The SFPD Homicide Detail issued a crime alert listing the suspect and vehicle description.

On Saturday, February 17, 2018 at approximately 12:13 AM, uniformed SFPD officers in a marked vehicle located the stolen Toyota on Alameda Street near De Haro Street. The Toyota was unoccupied and parked behind a recreational vehicle. Officers determined that the RV was occupied and contacted the occupants to conduct a wellbeing check. Multiple persons exited the RV. Officers determined that one person remained inside the vehicle.

Officers made contact with the subject who remained in the RV and an officer involved shooting occurred.

The officers established a perimeter and requested the Tactical Unit and Crisis/Hostage Negotiation Team. The occupant of the RV did not respond to officers' orders to exit the vehicle.

At approximately 2:20AM, the occupant exited the RV and was taken into custody. He was taken to a hospital for evaluation.

At approximately 3:05AM, the SFPD Tactical Unit determined that there were no additional occupants in the RV.

The occupant from the RV is the person of interest in the homicide and carjacking from the earlier incident at Oak Street and Stanyan Street. Following an evaluation at the hospital, he was taken to the SFPD Homicide Detail for an interview. No one involved was injured by gunfire in the officer involved shooting incident.

This is an active and ongoing investigation in the early stages. Investigations are being conducted by the SFPD Homicide Detail, the SF District Attorney's Office, the Department of Police Accountability and the SFPD Internal Affairs Unit.

Additional information will be released as it becomes available. As part of our commitment towards transparency and accountability, a town hall meeting regarding the officer involved shooting will be held within ten days.

#### What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

#### Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- 2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- 3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
