## Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



## Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are “In progress” crimes, which demand an immediate call to 9-1-1:

- ◆ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or

## Crime Definition

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.

**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

\***Assault** is when a person swings their arm and battery is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

**Monday, March 26<sup>th</sup>, 2018**

#### Arrests:

**1:27pm      100 Blk. Marietta      Aggravated Assault**

A physical confrontation between a Comcast employee and resident prompted dispatch to send Ingleside Officers Bautista, Thomas, Chung, Cestoni, Walsh, and Finnegan to investigate. The employee told the officers he was at the home to address service issues. The homeowner let the Comcast employee in the home and during the inspection a downstairs tenant became angry and told the employee to leave. The employee started to leave, but the tenant threw the employee down a stairwell and threw his tools outside the home. The tenant then tried to kick the employee but missed. However, he was able to punch the employee in the side of his face. The tenant was arrested for aggravated assault and taken to the County Jail for booking. Report number: 180225085

**10:20pm      500 Blk. Leland      Trespassing**

Another week and another arrest in a vacant church on Leland Street. Ingleside Officers Snadow and Lee were called to the address and found a man without identification inside the church. They also found the suspect had burglary tools along with a glass pipe used to smoke methamphetamine. He was also on probation out of San Mateo County. The suspect was transported to the County Jail and booked for trespassing, probation violation, and narcotics paraphernalia. Report number: 180226196

#### Serious Incidents:

**8:30am      1001 Goettingen      Hot Prowl Burglary**

A woman called police saying she confronted a burglar in her home. She told Ingleside Officers Dungca and Calupad that she was downstairs in her home when she heard noises from upstairs. She told the officers that she thought the noises were from her relatives. About fifteen minutes later, an unknown man walked into her bedroom holding a hammer in his right hand. He sat her on the bed, held the hammer to her face, and told her to be quiet or he would kill her. He then took her cellphone and demanded the cash in her wallet. She showed him she had no cash in her wallet. He then took her upstairs and asked her to open a safe in her bedroom. But the woman victim was unable to open the safe so he placed her in the bathroom where she stayed for several minutes until the burglar had left the premises. The officers searched the premises with the victim who said some cash was missing. The officers also discovered the front gate and door to the home were forced open enabling the suspect to enter the home. They also determined he escaped through a rear sliding door. A man walking in the middle of the street caught the attention of Ingleside Officers Wise and Fazli. The officers recognized the suspect as a man who has a long record of arrests and convictions for a variety of narcotics crimes. The officer stopped the suspect and found an open bottle of vodka in one pocket and a pipe used to smoke narcotics in another pocket. A man asleep in his downstairs apartment heard some noises coming from upstairs. The tenant told Ingleside Officers Watts and Freed that he got up when he heard someone banging on his door. He opened the door and saw a man, wearing a hoodie, and holding a crow bar. The suspect and victim looked at each other for a few seconds before the suspect, joined by an accomplice, ran from the home. The upstairs landlord came home from running a short errand and found a large amount of cash along with jewelry missing. The officers determined the suspect entered the home through an unlocked door. **12:25am      5400 Diamond Heights Blvd.      Theft**

A woman sitting at the bus stop after attending church, was on her phone, when an unknown man approached from behind and took her purse. The victim told Ingleside Officers Dungca and Calupad that the suspect fled the scene by running north on Diamond Heights Blvd. The loss was a significant amount of cash. Report number: 180222263

Two drug store workers noticed a two suspects lurking in the back aisles of the store. The employees watched as the pair quickly ran out of the store carrying a bag of items stolen from the shelves. One employee followed the suspects and snapped pictures of them. One of the suspects dropped the bags of stolen items during the escape. ### Arrests:

An unknown man rode his bicycle across the soccer field just as the game was scheduled to begin. Several soccer fans, along with the referee told the suspect to leave the field. However, instead of leaving, he took out a knife and threatened the spectators. The suspect was detained by spectators along with an off-duty Daly City police officer until Ingleside Officers Wise and Fazli arrived at the park and placed him in custody. The suspect was cited for the weapons violation and released at the scene. Report number: 180220643

An alert witness called police after watching two men breaking into a parked car near her home. The woman took pictures of the suspects just before both, now joined by a woman, boarded a parked vehicle which then sped away. Ingleside Officers Watts and Freed arrived on scene and interviewed the witness and the owner of the burglarized car. The owner told the officers the only thing missing from his vehicle was a blanket. The officers copied pictures of the suspects and their vehicle and broadcast a description for other Ingleside units. Report number: 180220524

A woman walking home felt uneasy after she noticed a man following her. Not wanting to show the man where she lived, the victim slowed down and the man walked past. She told Ingleside Officers Lustenberger, Zhao and Fogarty that she turned around and started walking home just as the suspect approached from behind and grabbed her purse. The suspect punched the victim in the face and got control of her purse before running away. The victim called police and medical help which treated her for a bruised forehead. An older Honda Civic with a broken window caught the attention of Ingleside Officers Jensen and Clayton while they were on routine patrol. The officers followed the Honda for a short distance until the driver stopped and parked in the 200 block of Schwerin. The vehicle wasn't stolen but there was a large amount of marijuana packaged for sale along with scales and other paraphernalia to assist the sales. Underneath the driver's seat was a loaded firearm. The driver was also on probation with a search condition. A search of the suspect's home on the 200 block of Teresita Drive turned up an additional weapon. The suspect was transported to Ingleside Station and booked for illegal possession of a firearm and other crimes. Report number: 180216498

#### **12:55am San Jose & 29<sup>th</sup> St. Aggravated Assault**

A woman walking home from the store was suddenly confronted by a neighbor who grabbed her arm and pulled out a kitchen knife. The woman ran home and called police. Ingleside Officers Fogarty and Zhao arrived and went upstairs to talk to the subject. The victim identified the man and signed a citizen's arrest form. The suspect was taken to Ingleside Station and booked for aggravated assault. Report number: 180216589

#### **6:04pm 3800 Blk. of Mission D.U.I**

Ingleside Officers Freed and Quinlan were dispatched to an accident where the driver of a Honda Accord had collided with a parked vehicle pushing the car into another parked vehicle. SFFD medics were on scene and evaluating the driver and a passenger both of whom were intoxicated. In the back seat was an 18 month old toddler in a child seat. The officers found two bottles of alcohol, one opened, in the suspect's vehicle. The driver and passenger were taken to San Francisco General Hospital for evaluation and the driver was, after being released and her blood drawn by a phlebotomist, arrested for DUI. ### Arrests continued:

Keen eyed Ingleside Officers Scott and Hardy were on routine patrol when they spotted three suspects wanted for the recent burglary of a store. The officers checked the crime bulletin which positively matched the suspects. A computer check revealed one of the three men was also wanted for a narcotics violation out of San Mateo County. All three were transported to Ingleside Station for booking. Report number: 180183568

#### **10:38pm      1500 Blk. Cortland      Theft**

A bar patron tried to steal a bag belonging to an employee of the establishment. The victim said she had placed her bag, containing cash, credit cards, keys, and an iPhone, on a hook suspended underneath a table. Another patron noticed the suspect sit at that table and sneakily remove the bag and place it under his shirt. The patron notified the bar employee just as the suspect got up and left the bar. Another bar patron and an off duty officer was told of the theft and quickly went outside and detained the suspect until Ingleside Officers Zhao and Fogarty arrived. The victim signed a citizen's arrest form and the suspect was booked for theft and taken to the County Jail. Report number: 180218955

#### **10:57pm      200 Blk. Judson      Air Gun**

Ingleside Officers Carew, Lustenberger, and Archilla were on routine patrol when they spotted a vehicle, with no license plates, parked with a man working under the hood. The vehicle was parked near an address where several arrests have been made during the past several months. The officers stopped their vehicle, got out, and spoke to the man working on his car. While one officer talked to the suspect, another peered into the car and saw a pipe used to smoke narcotics. Inside the car was also a backpack and inside the backpack was an air gun without the required "red tip" on the muzzle signifying it's an air gun and not a firearm. Also inside the car was several black ski masks that suspects use to hide their identity while conducting burglaries and other crimes. The suspect was cited at the scene for the illegal air gun and the narcotics paraphernalia then released. Report number: 180219000

A man, “talking to himself”, pacing back and forth, and “threatening to shoot someone”, prompted dispatch to send Ingleside Officers Labson and Park to investigate. When they arrived at the location they found an unarmed man threatening an “invisible person”. The suspect had a record and also had a pipe used to smoke narcotics in one of his pockets. He told the officers he didn’t want to really hurt anyone or himself and that he felt frustrated. He was cited for possession of narcotics paraphernalia and released at the scene. The suspect then exited the bus and boarded another #8 Muni bus heading downtown. The bus driver located the bus the suspect boarded and Officers Quinlan and Freed notified Ingleside Officers Siracusa and Glover who stopped the bus on Sunnysdale Avenue. The victim was driven to the scene and positively identified the suspect. He was cited at the scene for battery and released pending a court date. A man was stabbed in the arm by two unknown suspects. In the driver's seat was a man wanted on a no bail felony warrant. Officer Endo left the traffic stop and started tailing the wanted felon. Unfortunately, the wanted suspect took off at a high rate of speed through several intersections in the Excelsior and into Visitacion Valley where the chase was terminated out of concern for public safety. After the above chase was terminated, Ingleside Officers Naser and Fazli were assigned to investigate an arson of a portable toilet. When they arrived on scene the officers talked to a construction manager working on a home remodeling project. The worker quickly filled a spray can with water and ran down the street to extinguish the blaze. The suspect, after setting the fire, quickly ran away toward Silver Avenue. A call of a man with a gun resulted in an officer being seriously wounded, the suspect deceased, and several bystanders wounded. The original call involved the suspect in front of a residence on Amazon Street where the witness told dispatch there was a man with a gun. Dispatch told responding officers the suspect had fled the Amazon address and was now in the barbershop on the 900 block of Geneva. The officers entered the barbershop where the confrontation took place. The Department's Homicide Squad and other specialty units are investigating the incident. Report number: 180213080

A man returning home from work was robbed of several laptops. The victim told Ingleside Officers Hermosura and Wong that he parked his van in the driveway of his home, got out and went around to the passenger side of the vehicle. A brief struggle ensued until a strap on the bag broke and the suspects ran away to a double parked SUV. #### **9:30pm 900 Blk. Geneva**

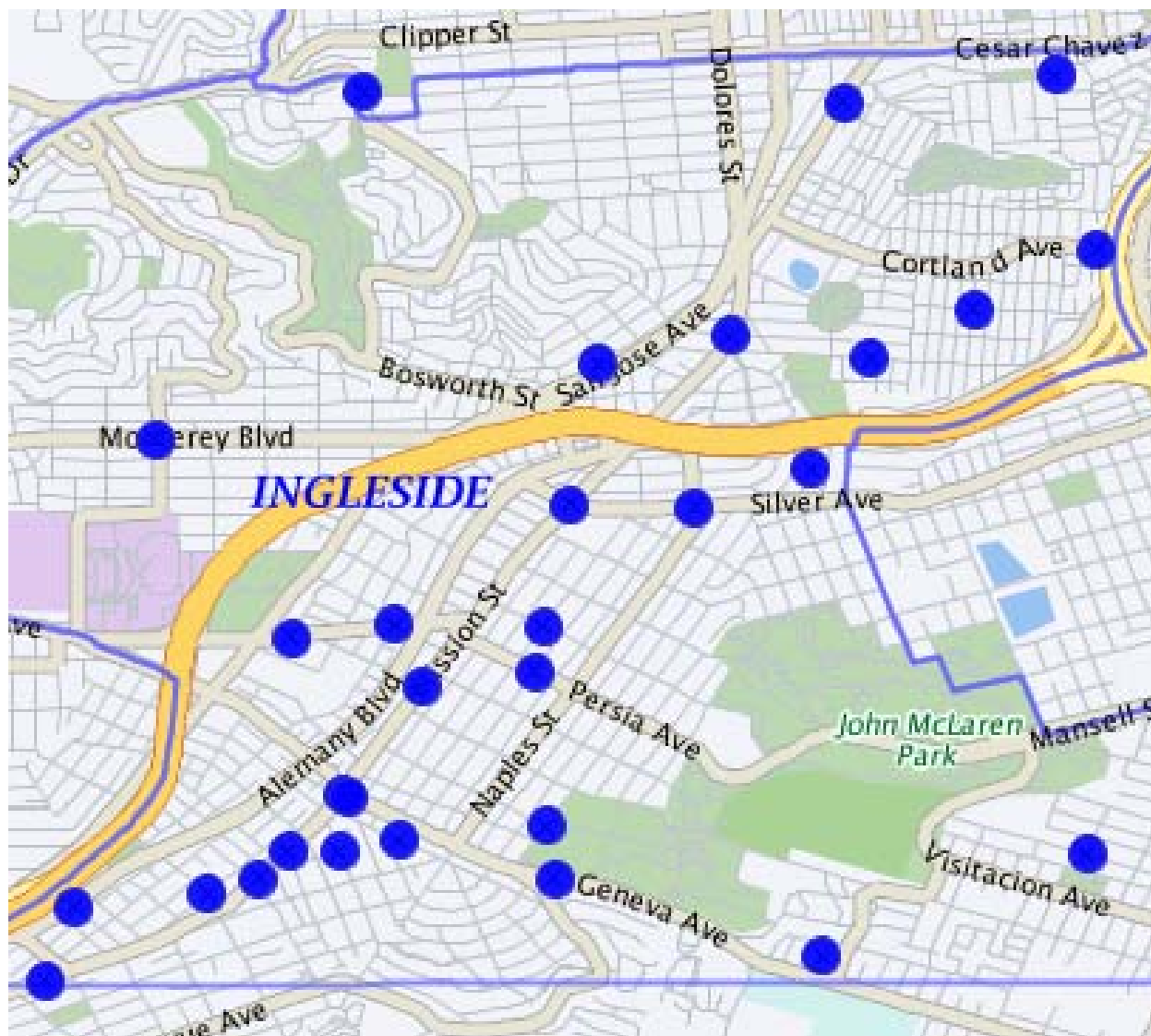
#### **Arson**

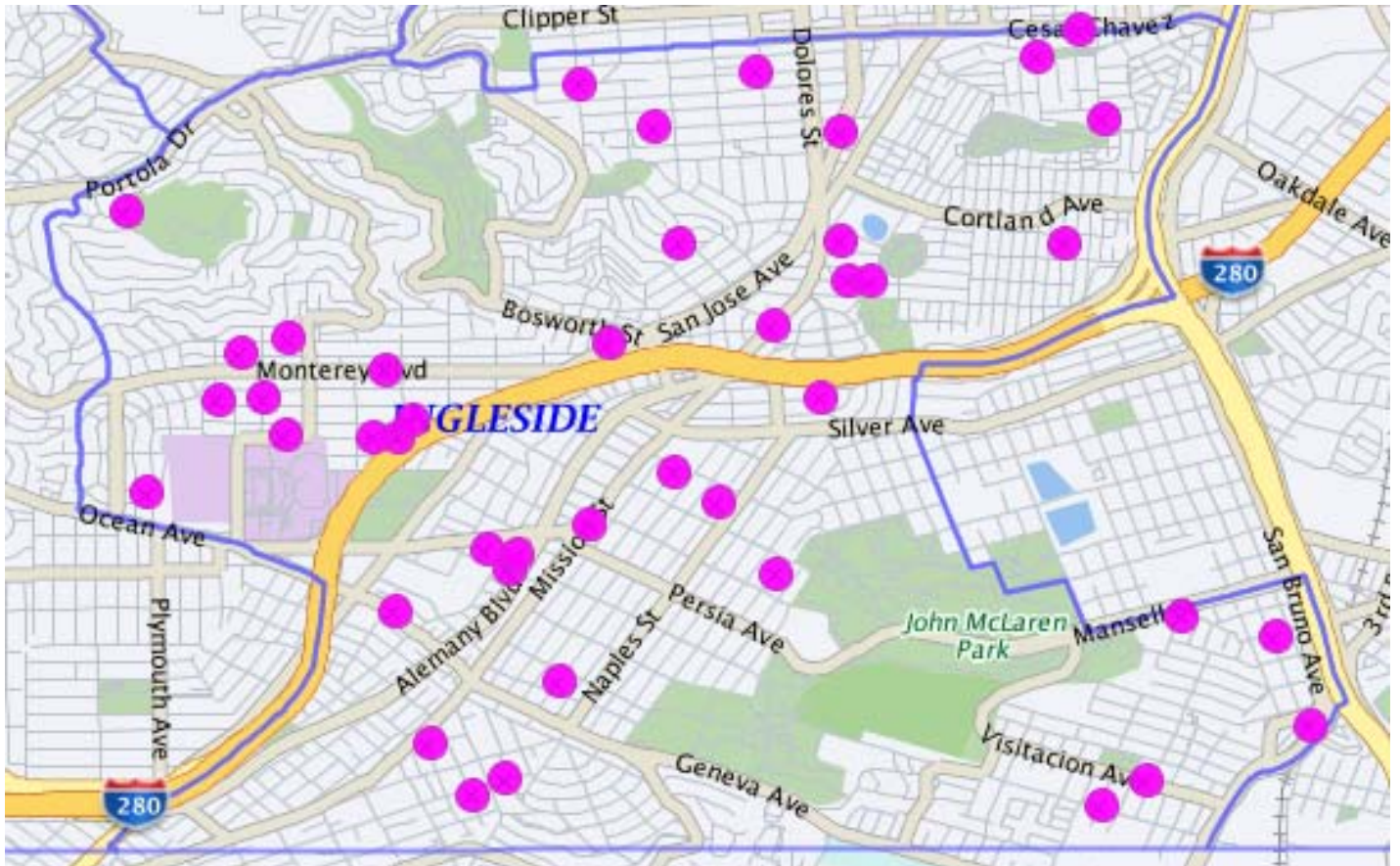

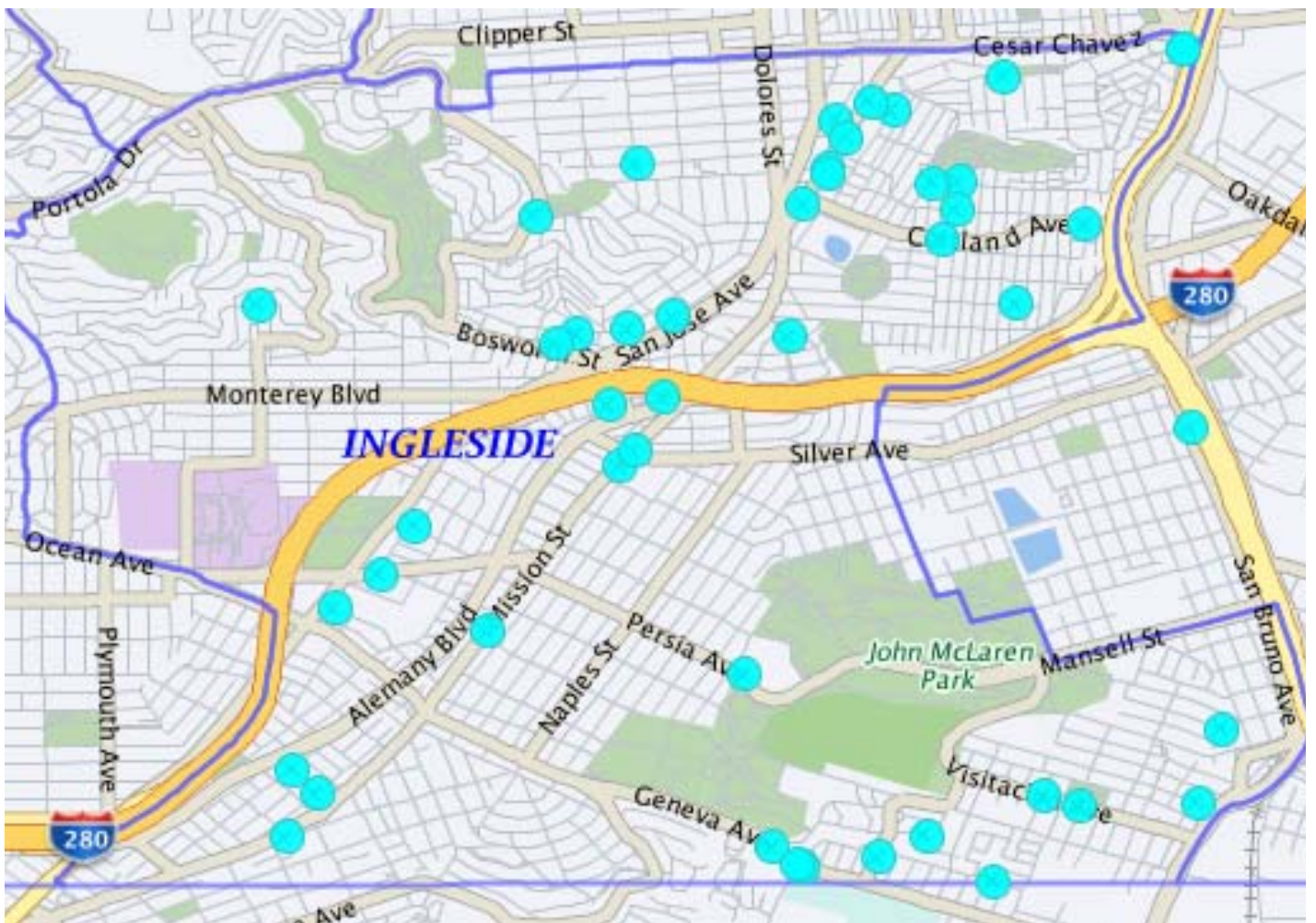

### **Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant**

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on March 14th, 22nd and 28th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

### **San Francisco Police Department Releases 2017 Year-End Crime Statistics**

#### ***Data shows decrease in homicides, shooting incidents, burglaries and auto thefts***

The San Francisco Police Department today released its 2017 crime data as reported to the FBI through the Uniform Crime Reporting (UCR) program. The data indicates that while Part I crimes increased 11.8 percent in 2017,

- Homicides decreased 3.4 percent
- Homicides by firearms decreased 5 percent
- Non-fatal shooting incidents decreased 15.8 percent
- Human trafficking decreased 32.6 percent
- Assaults against SFPD police officers decreased 4 percent compared to 2016

Through enforcement efforts, the SFPD seized 1,023 firearms in 2017 and collected 275 guns during buyback events, a 29.7 percent increase over 2016.

“Reducing violent crime is and will always be our top priority,” said Police Chief William Scott. “We’re working closely with community members and our City partners to reduce gun related violence. Protecting lives and providing safety for the public- particularly our youth- is key to ensuring a vibrant future for everyone.”

UCR data shows San Francisco and neighboring Bay Area cities experienced a rise in property crimes during the first six months of 2017. San Francisco saw a 24 percent increase in thefts from vehicles last year.

To address these types of crimes, SFPD in 2017 doubled its citywide uniformed foot patrols to deter street crime and focus on neighborhood quality of life issues. Last November, the department created a General Crimes Unit to address serial residential and commercial burglaries, auto break-ins, bicycle thefts and other neighborhood property crimes. In January, 2018, SFPD command staff assigned district

station officers to work directly with community members on crime trends, education and prevention strategies.

Last year, San Francisco police officers booked or cited 790 people for thefts from vehicles. The 2017-2018 data shows a downward trend in auto burglaries, auto thefts and burglaries:

- Auto burglaries decreased 11 percent citywide between November 1, 2017 and December 31, 2017
- Auto burglaries decreased 5 percent citywide between December 1, 2017 and January 31, 2018
- Auto thefts decreased 11 percent in 2017
- Burglaries decreased .8 percent in 2017

"We take these crimes seriously and are allocating our resources toward deterrence and investigations," said Chief Scott. "By collaborating with community members, San Francisco businesses and law enforcement partner agencies, we can address crime through education, prevention and the effective investigation and prosecution of criminals."

The UCR program counts crimes when they become known to the police. A series of 13 reports are submitted to the California Department of Justice each month; CA DOJ in turn reports this data to the FBI. Crime incidents, values of stolen and recovered property values, homicide information, crimes against seniors, hate crimes and domestic violence incidents are some of the summary reports submitted each month to CA DOJ. The submittal deadline is the 10th of the month following the close of the month.

The UCR program is considered a "snapshot of crime" reported in one month. Crime is counted based upon a hierarchical rule following FBI definitions and guidelines, so that

all jurisdictions participating in the UCR program follow the same rules. Figures are only updated twice annually.

The San Francisco Police Department also produces a monthly CompStat profile, which often includes additional crimes which have been reported after the UCR submittal deadline. CompStat focuses on crimes which have occurred during the month, an important distinction from the UCR standard. These profiles provide a more up-to-date picture of crime in San Francisco, and are used to better evaluate crime fighting strategies and deployment efforts. CompStat reports are posted on our website at [sanfranciscopolice.org/compstatreports](http://sanfranciscopolice.org/compstatreports).

### Update to Ingleside District Officer Involved Shooting

On March 21, 2018 at approximately 4:30 PM, San Francisco police officers from Ingleside Police Station responded to the 200 block of Amazon Avenue regarding a report of a man with a gun. The investigation led the officers to a business on the corner of Geneva Avenue and London Street where an officer involved shooting occurred.

The suspect in the incident, identified as 21 year-old Suisun City resident Jehad Eid, was injured and transported to Zuckerberg San Francisco General Hospital (ZSFGH). Despite lifesaving efforts Eid succumbed to his injuries and was pronounced deceased Wednesday evening.

This is an active and ongoing investigation in the early stages. Investigations are being conducted by the San Francisco Police Department's Homicide Detail, the San Francisco District Attorney's Independent Investigations Bureau, the Department of Police Accountability, the SFPD Internal Affairs Division and the San Francisco Medical Examiner's Office.

Additional information will be released as it becomes available. As part of our commitment towards transparency and accountability, a town hall meeting regarding this officer involved shooting will be held within ten days.

### SFPD OFFICERS TO TAKE SAN FRANCISCO TEENS TO AFRICA

On Thursday, March 22nd, 10 African-American high school students from San Francisco's Bayview and Western Addition communities and three San Francisco Police Department officers will embark on a nine-day trip to Accra, Ghana. The Operation Genesis program aims to instill a sense of self-discovery in the teenagers as they learn the history of their African ancestors, meet local youth and learn about the differences between life in Africa and the United States.

Officer Jason Johnson- a ten year veteran of the San Francisco Police Department who is assigned to the Community Engagement Division created Operation Genesis in hopes of making education a pivotal point in the lives of youth. Students have spent weeks studying Ghana culture and raising money for the trip. As in previous years, the students will bring books and gently used clothing for their younger counterparts in Ghana.

This is the fifth year of a program that previous participants have described as a life-changing experience. 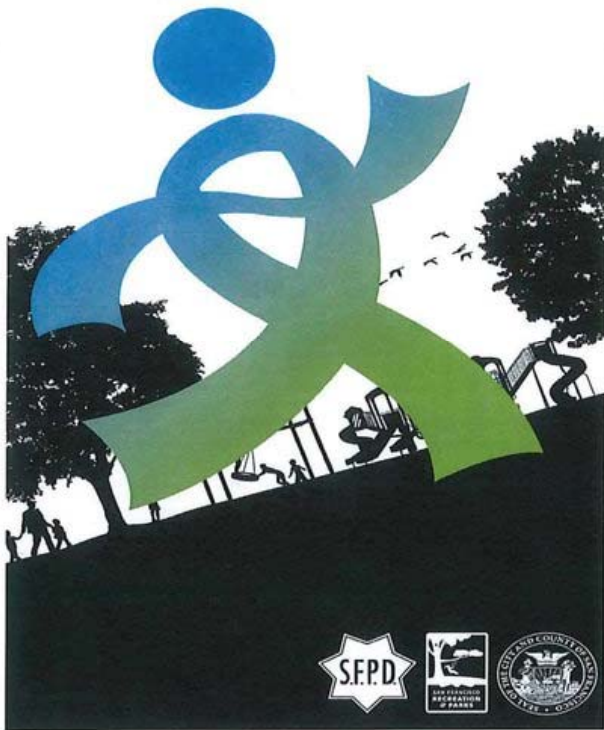

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



## What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

### Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
