Featured Officers of the Month Ofc. Downs & Ofc. Bur





This month features two officers on the midnight shift who are going above and beyond to keep us safe in our homes when the sun goes down: Ofc. Kevin Burke and Ofc. Kevin Downs. Ofc. Kevin Downs' request to transfer from Taraval Station to Ingleside Station was granted by Headquarters and this successful midnight shift partnership was formed. How successful has this partnership been? In just three shifts together, they have already seized two illegally possessed firearms in two separate incidents. On March 27th, 2018 at 01:15AM, officers saw a vehicle with "paper" plates at the Chevron Gas Station at 5098 Mission Street. He saw that one occupant of the vehicle was using a squeegee to bang on the attendant's glass door, while the driver quickly concealed an item upon seeing the officers. These subjects, both convicted felons, were prohibited from possessing the Glock with a 30-round magazine that was subsequently discovered illegally possessed in the glove box. On March 29th, 2018, these same officers spotted a vehicle running a stop sign at 01:30AM at Mission and Randall Streets. Upon seeing narcotics paraphernalia in plain view, officers discovered narcotics and an illegally possessed Glock firearm.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city
 agencies to provide outreach and assistance to rehabilitate those who are dependent on
 illegal drugs and outreach to homeless individuals to connect them with resources and
 support.
- <u>Foot Patrols</u>: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously.
 Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are "In progress" crimes, which demand an immediate call to 9-1-1:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or

Crime Definition

Robbery - Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

2:37am Persia/Prague Narcotics

Officers Buckner and Duran were driving up Persia Avenue when they spotted a car double parked in the middle of the roadway at the intersection of Persia and Prague with its hazards on. The officers stopped to investigate and saw that the driver was asleep behind the wheel. The officers made their presence known and requested the subject's driver's license and vehicle paperwork. He told the officers that he did not have his license on him and the bill of sale was somewhere inside the vehicle. The officers had the driver step out of the vehicle while they looked for the documentation. Inside, they found a baggie containing methamphetamine. Further search revealed that the driver did in fact have a license and the vehicle was legally registered in his name. He was ultimately cited for the narcotics violation and released from the scene. 1:14pm 500 Blk Leland Trespassing

Officers Peralta and Chan were on patrol when they decided to conduct a property check on an abandoned church located on the 500 block of Leland Avenue. In the past months, many officers from the Ingleside Station have made numerous trespassing arrests from this same location. On this day, they walked around the exterior perimeter and noticed that one of the windows had been broken and its security bars ripped from the wall. They also noticed dry blood leading into the building from the same window. The officers coordinated their efforts with additional units in an effort to search the interior. While on scene, they saw male subject attempt to gain entry into the building. He was immediately detained. The officers searched the premise and found no one else inside, but did find personal property belonging to the subject detained outside. The owner of the building responded and told the officers that he was willing to sign a citizen's arrest for trespassing. The officers collected the belongings and searched the subject's property and found various paperwork and prescription medicine belonging to several other people. The officers contacted these individuals, who in turn informed the officers that they were victims of theft and vehicle burglaries. The suspect was taken to Ingleside Station where he was booked for vandalism, trespassing and possession of stolen property as well as burglary tools. Report Number: 180241592

2:34pm Geneva/Madrid Possession of a Firearm

A dispute over a parking space resulted in of the parties brandishing a firearm at the other. The victim in this incident immediately called police and provided a description of the suspect and the vehicle he was driving. Officers Espinoza and Foxworth heard the call and were on the look-out for the White Chevy Camaro with paper plates, which was last seen headed Eastbound on Geneva towards Bayshore Boulevard. Officers Espinoza and Foxworth made their way to the area and spotted the vehicle getting onto the 101 northbound freeway entrance. The officers followed the vehicle and requested additional assistance. The officer pulled the vehicle over at Cesar Chavez and Indiana. With the help of the responding units, the driver was taken out of the vehicle and detained. A search of the vehicle revealed a loaded 9mm Glock handgun tucked away inside the center console. Officers also found marijuana and two additional loaded magazines. The suspect was arrested and charged with possession of a loaded firearm and possession of Marijuana for sale. 10:05am 200 Blk Crescent Robbery

Two sisters on their way to pick up a family member from karate class were brutally attacked inside St. Mary's Park. Officers Tiffer and Chang responded to the call and located the two victims, both bleeding profusely from their face and head. The one sister told the officers that they arrived at St. Mary's Park to pick up her sister's son who was attending karate class. While they walked into the park, they were attacked from behind by one male suspect and one female suspect. The male suspect grabbed a cell phone and then tried to take a backpack, but one of the sisters instinctively tried to hold on. Both victims were then pushed to the ground and were assaulted with a barrage of punches and kicks from both suspects. After losing possession of the backpack, the suspects fled further into the park where they disappeared. Two witnesses in the park heard the commotion and provided the officers with further information and description of both suspects. Officers Mullins and Garza followed the escape trail and were able to locate a wallet and a cell phone case. Both sisters were taken to San Francisco General Hospital for treatment. 7:18pm Mission/Ruth Aggravated Assault

Officers Wise and Fazli responded to a call of a large fight taking place in the area of Mission and Persia Avenue. Once they arrived, several bystanders were pointing to a subject who was walking away from the area. The officers quickly detained the subject and met with the other parties involved. Three victims, all friends, said they were working on a car in front of a home when they noticed the subject urinating across the street. This same subject then approached them accusing them of being gang members. The victims said they tried to ignore the subject because he was intoxicated, but the subject became irate and began pushing one of the victims. A fight then broke out and the subject produced some nail clippers and began assaulting all three victims. One of the victims sustained numerous lacerations to his chest, forearm, armpit and back area. Another victim used his belt in self-defense in an attempt to keep the suspect away. A neighbor in the same building saw what was going on and began recording the incident on her phone. The officers looked at the footage and recorded it as evidence. The one victim was taken to the hospital for treatment. The suspect was booked for aggravated assault and threats. Report Number: 180237234

9:10am Persia/Paris Theft

A Muni bus passenger told Officers Garza and Mullins that she was sitting on the right side of the bus, texting her boyfriend, when two male suspects approached her from behind and snatched her IPhone X out of her hand. Both suspects ran off of the bus headed northbound on Paris Street. The victim said she attempted to chase after them but was not successful. Headquarters attempted to track her phone, but it had been turned off. The officers requested the surveillance footage from the bus in hopes it recorded the incident. Report Number: 180235501

8:10pm Unit Blk Justin Dr. Robbery

A young man walked into Ingleside Station and told Officers McCall and Lozano that he was a victim of a robbery that occurred in St. Mary's Park. He said he had just finished playing basketball in the gym and started to walk home. He made his way through the baseball field and onto a concrete pathway that lead to Crescent Avenue. At the very top he saw two subjects, one male and one female, walking towards him. When they crossed paths the suspects extended their arms to shake the victim's hand. The victim obliged and shook their hands, after which both suspects demanded his property. The female suspect brandished a knife and held it against the victim's rib area. The victim, fearing for his life, put his hands up and handed over his backpack and watch. The male suspect then punched the victim and told him not to snitch. They then let the victim get up and walk away. The victim went home and waited for his brother before responding to the station to make the report. Report Number: 180237529

1:24am Mission/Cortland Possession of a Firearm

Officers Burke and Downs were driving on Mission Street when they observed a White Mercedes fail to stop at the posted stop sign at Mission and Randall Street. The Mercedes was travelling in the opposite direction, so the officers turned their patrol vehicle around and conducted a traffic stop on the same vehicle. Officer Burke approached the vehicle and made contact with the driver. While speaking with the driver, Officer Burke saw in plain view a 5"x3" piece of aluminum foil with a burnt black residue lying on the floor next to the driver's foot. Officer Burke knows that drug users often use foil to smoke a variety of narcotics like cocaine, heroin, marijuana and methamphetamine. Based on his observation he asked the driver to step out of his vehicle. The driver complied, but as he was stepping out the seat belt got entangled around an object that was affixed to the driver's waist. Officer Burke lifted the driver's sweatshirt and saw that he was concealing a fixed blade knife with an overall length of seven inches. Officer Burke searched the driver for more weapons and found a firearm magazine in one of his pants pocket. The driver then informed the officers that there was in fact a firearm under the driver's seat. Officer Downs looked underneath the seat and located a loaded .380 caliber Glock firearm. Further search of the vehicle revealed a small quantity of Cocaine Base along with Methamphetamine as well. The suspect was arrested and booked for the narcotics and possession of a Firearm. 1:33am Holladay/Peralta Stolen Vehicle

Officers Burke and Downs were patrolling the area of Holladay and Peralta Avenue, which is an area known to them where vehicle are abandoned after having been stolen. On this particular night they saw a woman abruptly exit the driver door of an older green Mitsubishi that was parked on the 200 block of Holladay Avenue. The woman approached the officers and asked if they had seen her cat that ran away. As Officer Downs spoke to the woman, Officer Burke ran the license plate, which showed that the vehicle had been reported stolen out of South San Francisco. The officer immediately placed the woman under arrest. A computer inquiry on the subject showed an extensive arrest history with priors for stolen vehicles. Report Number: 180216288

5:47pm 200 Blk Judson Narcotics

Officers Demkowski and Smith were on patrol when they spotted a motorcycle leaving a house on the 200 block of Judson Avenue. This house is known to many officers as a neighborhood nuisance, which has resulted in many narcotics, stolen vehicle and stolen property incidents and arrests. The officers followed the motorcycle and noticed that it was displaying paper plates. The officers stopped the motorcycle and its rider. Upon further inspection, the officers found that the license plate was actually being concealed under the paper plates. A computer inquiry showed that the registration had been expired more than six month ago. The computer inquiry also showed that the rider's license status was also suspended. A search of his clothing revealed two containers filled with methamphetamine. The subject was placed in custody and charged with several felony chargers. Report Number: 180231684

7:20pm San Jose/Niagara Possession of Burglary tools

Two observant witnesses helped police nab a car burglar. Officer Labson and Park responded to the area of San Jose and Niagara Avenue regarding a call of a person taking items from a vehicle. Once they arrived they met with the first witness, who said she witnessed the subject break the window to the vehicle and began taking items from it and fled. The officers searched the area and met with the second witness who saw the officers searching and pointed the suspect out. The officers took the suspect into custody and was ultimately charged with burglary, possession of burglary tools and probation violation. Report Number: 180231866

1:16am Mission/Geneva Firearm

Officers Burke and Downs were on routine patrol, driving by Geneva and Mission, when they observed a female subject acting erratic inside the Chevron gas station. As the officers pulled into the gas station they saw the female yelling and hitting the front glass doors with a long window squeegee. The employee saw the officers as they were pulling in and began flagging them down. As the officers approached, the female suspect stopped hitting the doors and returned to her vehicle, which was parked next to one of the gas pumps. The officers detained her and the two additional occupants that were seated inside the vehicle. The station employee said she was on her lunch break and had put a sign on the front window informing patrons that she would be returning shortly. She then saw the female suspect begin to vandalize the glass doors and cracking the glass in multiple places. The officers ran a computer check on the female suspect, which showed she was on active felony probation. The officers then searched the inside of the vehicle and found a half empty bottle of "Hennessy", four burnt marijuana cigarettes, a small jar containing marijuana. Officer Burke continued his search and also located a 10 round 9mm Glock magazine and a gun holster inside the glove box. Officer Burke noticed that the glove box was loose and came off its hinges exposing multiple wires and electronic components behind it. He then looked closely behind the glove box and saw a Glock 26 firearm with a 30 round magazine hidden behind the wires. The officers seized the items and transported all three subjects to the station for questioning. The female subject seen vandalizing the gas station was booked on several felony charges as well as her male acquaintance who was seated on the front passenger side closest to the firearm. The third female seated at the rear was released. Report Number: 180226607

4:12pm 600 Blk Brazil Warrant Arrest

It was the wrong place and time to be recognized for one particular individual. Officers Barajas and Lee were driving down Brazil Avenue when Officer Barajas noticed a male subject who was wanted for a parole violation. The officers have had contact with this individual before and has run from them to avoid capture. Knowing this, the officers yelled out to the suspect advising him not to run. Both the officers jumped out of their patrol vehicle and ran towards the suspect and took him into custody. A search of his clothing revealed a small quantity of methamphetamine. He was taken to Ingleside Station where he was booked for the parole violation and possession of narcotics. Report Number: 180228261

6:28pm Unit Blk Sanchez Possession of Burglary Tools

A witness on the unit block of Sanchez kept an eye on a suspicious subject, who used bolt cutters to steal a bicycle. The suspect then walked away from the area and out of sight. The witness flagged down Sergeants Tam and Ho, who began to search the area and located the suspect walking alongside the bicycle with bolt cutters protruding from a backpack that was attached to the rear of the bike. When asked, the suspect was unable to tell the officers how he came in possession of the bicycle. Officers Hoge and Harper arrived to assist and searched the suspect finding a glass bulb typically used to smoke methamphetamine. They also searched his backpack and found an array of tools, which the officers know are used to break into cars and houses. She heard the first noise at 12:30am and the second at 03:30am. She told him she looked out the window but couldn't see anything. Inside the home they saw the rear glass door had been shattered and one of the bedroom doors upstairs was damaged with a crow bar laying on the floor just outside the room. The homeowner said he was home when he heard a knock at the door. He went to the door and looked through the peep hole. He did not recognize the subject, therefore, did not answer the door. He then went to his bedroom and looked out his bedroom window and saw a Grey Honda Civic with paper plates parked outside. As the homeowner took a snapshot of the vehicle, he heard the rear glass door being shattered. He immediately locked himself inside his bedroom and called the police. He could hear footsteps and someone rummaging through his belongings downstairs. He then heard a male voice say, "They're coming" followed by footsteps running out the house. The homeowner then saw the vehicle flee the area driving down Lapham towards Chicago Way. The officers located a surveillance camera from a nearby neighbor that caught the incident on video. 
02:32pm 500 Blk Precita Theft



Mar 1, 2018 to Mar 31, 2018 24 Incidents







Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on April 4th, 5th, 12th, 17th, 24th and 26th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

Notes Used During Presentation at the March 29, 2018 Town Hall to Address the March 21, 2018 Officer Involved Shooting

Synopsis:

Wednesday, March 21, 2018 at approximately 4:28 pm

- Officers were dispatched to a 911 call on the 200 block of Amazon Avenue regarding a man in front of the residence with a gun.
- Dispatch advised responding officers that the subject identified as Mr. Jehad Eid was threatening his family, flashed a gun from under his jacket and tried to break into the garage of the house.
- Officers arrived on scene and were told by a witness that Mr. Eid was at the Amazon Barbershop.
- Uniformed officers detained one subject outside of the barbershop as a uniformed and plainclothes officer walked inside.
- As the officers entered, they observed Mr. Eid sitting inside.
- Mr. Eid stood up and shot at the officers.
- Two officers returned fire.
- Officers observed Mr. Eid fall to the ground struck by gunfire.
- One officer was shot by Mr. Eid and crawled out of the barbershop with the assistance of a Sergeant.
- Officers continued to give verbal commands to surrender as other officers on scene helped with evacuating occupants of the shop.
- Mr. Eid was not responsive to the officer's commands at which point they approached and handcuffed him.
- Officers began to render medical aid while an ambulance was requested.
- Officers determined that four additional people in the barbershop had been struck or grazed by gunfire. First aid was administered while additional ambulances were requested.
- All injured parties were transported to Zuckerberg San Francisco General Hospital.

- Mr. Eid did not survive his injuries.
- All other injured parties were treated and have since been released from the hospital.

Additional Information:

- Preliminary evidence indicates that Mr. Eid fired 9 rounds from his 40 caliber firearm.
- A 40 caliber handgun was located inside the barbershop near Mr. Eid and is pictured here today.
- Preliminary evidence indicates that two officers fired approximately 26 rounds from their firearms.
- The Medical Examiner's office preliminary report indicates that Mr. Eid was struck approximately 18 times.

Witnesses

 There are witnesses and reporting parties that heard gunfire or witnessed portions of the shooting. Those witnesses have been interviewed. We are asking that anyone in the public that has additional video evidence or witnessed the shooting contact us so that they can be interviewed.

Involved Members

Both of the officers who fired their weapons have been interviewed.

Video:

- One of the officers that discharged his firearm activated his Body Worn Camera
- A second officer that discharged her weapon was not wearing a Body Worn Camera since she was working in plainclothes.
- There are additional Body Worn Camera videos from responding officers but they did not capture the shooting.
- We have obtained and viewed dash cam video from a witnesses vehicle in the area.



"Bart Simpson" Tagger Arrested by SFPD

On March 27, 2018, at approximately 2:52 AM, Central District police officers were dispatched to the 600 block of Jackson Street regarding a vandalism call. Dispatch broadcast a description of male who was painting an image of Bart Simpson. The suspect was described as wearing a bright orange construction vest and a dark colored shirt.

The officers observed a male matching the description of the suspect near the corner of Grant Avenue and Jackson Street. Officers detained the male, later identified as Tyler Ross, a 27 year-old transient. Ross had paint on his hands and had an open grocery bag which contained several cans of spray paint. Ross also had in his possession, paint markers, white-out pens, etching pens and a Bart Simpson keychain.

One officer walked around the area of the 700 block of Jackson Street and observed a freshly spray painted image of Bart Simpson. The paint in the image matched the paint on Ross's hands and the spray paint cans found in his possession.

Based on evidence and witness statements obtained during the investigation, Ross was arrested and booked at San Francisco County Jail on felony and misdemeanor counts of vandalism at San Francisco county jail. Ross's booking photo accompanies this news release.

While an arrest has been made, this remains an open and active investigation. Anyone with information is asked to contact the SFPD Tip Line at (415) 575-4444 or text a Tip to TIP411 and begin the text message with SFPD. You may remain anonymous.





What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
