Featured Officers of the Month Ofc. Downs & Ofc. Burke



This month features two officers on the midnight shift who are going above and beyond to keep us safe in our homes when the sun goes down: Ofc. Kevin Burke and Ofc. Kevin Downs. Ofc. Kevin Downs' request to transfer from Taraval Station to Ingleside Station was granted by Headquarters and this successful midnight shift partnership was formed. How successful has this partnership been? In just three shifts together, they have already seized two illegally possessed firearms in two separate incidents. On March 27th, 2018 at 01:15AM, officers saw a vehicle with "paper" plates at the Chevron Gas Station at 5098 Mission Street. He saw that one occupant of the vehicle was using a squeegee to bang on the attendant's glass door, while the driver quickly concealed an item upon seeing the officers. These subjects, both convicted felons, were prohibited from possessing the Glock with a 30-round magazine that was subsequently discovered illegally possessed in the glove box. On March 29th, 2018, these same officers spotted a vehicle running a stop sign at 01:30AM at Mission and Randall Streets. Upon seeing narcotics paraphernalia in plain view, officers discovered narcotics and an illegally possessed Glock firearm.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are “In progress” crimes, which demand an immediate call to 9-1-1:

- ◆ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or

Crime Definition

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

***Assault** is when a person swings their arm and battery is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

4:20pm 50 Phelan Alcohol and Marijuana

City College Police Officer Flood was on routine patrol when he spotted four men standing around a parked car drinking alcohol. He stopped his patrol car and noticed there were unopened bottles of beer in the back seat along with several packages of marijuana and a scale. The officer concluded the marijuana was packaged for sale. He arrested the driver and cited him with possession of marijuana packaged for sale and released the other three men. 4:20pm Sunnydale & Sawyer Recovered Motorcycle

Ingleside Officers Johnson and Naser were on routine patrol when they spotted a collision involving a motorcycle and a Nissan. The Nissan driver told the officers that the driver and passenger of the motorcycle had run away northbound on Hahn. The officers caught up with the pair and placed them in custody. A records check revealed the motorcycle was stolen from an address in San Francisco on March 31st. The unlicensed driver was arrested for vehicle theft and his female passenger released at the scene. 9:22pm 100 Blk. Bertita Concealed Weapon

A citizen called police to report a man, near her home, concealing a gun under his shirt. Ingleside Officers Buckner and King responded and found three men nearby, one of them matching the description given by the witness. The officers searched all three men and found large knives concealed in two of the three suspects. Both were arrested and booked at the County Jail for carrying a concealed weapon. Ingleside Officers Dilag and Duran were dispatched to the Safeway store after a report of a fight and a robbery. When they arrived they found two Safeway loss prevention officers on top of a handcuffed suspect. The Safeway employees told the officers that the suspect had grabbed meat and other items and left the store without paying. When the officers confronted the suspect he became combative and tried to use a "Taser" on them. The employees were able to knock the Taser away and subdue the suspect until the officers arrived. Ingleside Officers Billings and George were dispatched to a "shot spotter" report of gunshots in the area of Hahn and Sunnydale Ave. When they arrived on scene they found one shell casing on the sidewalk, but no victims, witnesses or damaged property were found. Report number: 180258553

Two women sitting in the living of their home got up to go to another room. When they returned a few minutes later they found the front door of their home open and a laptop, phone, purse containing a wallet and other items, missing. The victims told Ingleside Officers Hermosura and Bell that the front door may have been left unlocked by a roommate. Report number: 180258741

3:23am Mission & Silver Discharging of a Firearm

A report of gunshots prompted dispatch to send Ingleside Officers Duran and Buckner to investigate. When they arrived on scene they found a bullet casing on the sidewalk near Mission and Silver. The officers reviewed security footage from a building in the area which showed a suspect and victim engaging in a discussion and then the suspect walking back to an occupied vehicle and talking to the passengers. Then the suspect walked back toward the victim and took out a gun and fired one shot at the victim. The suspect then got into the vehicle which traveled a short distance before stopping. The suspect then got out and fired a second shot at the victim. The suspect's vehicle then sped away and the victim boarded an inbound Muni bus. Report number: 180258791

8:59am 2100 Blk. Geneva Recovered Vehicle

Ingleside Officers Chang and Tiffer saw motorist at the intersection of Velasco and Santos Streets looking down for several seconds and then driving away. The officers ran the plates on the silver Audi, which turned out to be stolen. The officers lost the car in the area for a few minutes but later found it parked at Geneva and Santos Streets. They also found the driver who was quickly placed into custody. He was driving with a suspended license and was transported to Ingleside Station for booking. Two women, known to Safeway employees for stealing laundry detergent in the past, re-entered the store and started gathering up items and placing them in shoulder bags. The two suspects then attempted to leave the store but were stopped by a Safeway security agent. The agent suffered several injuries during a struggle with the pair while unsuccessfully attempting to prevent them from leaving the store. Ingleside Officers Salazar and Leung were dispatched to the scene and summoned an ambulance to transport the security officer to the hospital for treatment. Report number: 180257420

A man, shopping for groceries, returned to his car in the parking lot and was immediately assaulted by a male and female suspects. The victim told Ingleside Officers Watts and Freed that the suspects pulled him out of the car and punched him several times. They stole his iPhone, but not before kicking in the passenger side windows of his car. Officers Watts and Freed summoned medical help but the victim refused transport to the hospital. A resident watching TV in his living room heard two people talking nearby. He told Ingleside Officers Mullins and Garza that he thought it was people talking on the sidewalk. Next he heard the same two voices coming from near his front door. He went to a bedroom which has a view of the front door and while there, he saw an arm reach through the bedroom window from outside. A call of a man running in the intersection, yelling and screaming, prompted dispatch to send Ingleside Officers Hardy, Allen, Smith, and Demkowski to investigate. When they arrived, the officers found the suspect running in the street, yelling and screaming, as oncoming traffic tried to avoid hitting him. The officers chased the suspect and after a long struggle where he resisted arrest, were finally able to place him in custody. He was taken by ambulance to San Francisco General for psychiatric observation. Ingleside Officer Hardy was also treated at the hospital for injuries suffered during the arrest. An alert citizen, along with her mother, captured a car burglary suspect. The woman, shortly after parking her car and walking to a nearby home, went back to her car and found a strange man exiting the vehicle with her purse. She and her mother chased the suspect and held him until Ingleside Officers Fogarty and Zhao arrived. The officers searched the suspects backpack and discovered various tools used to break into vehicles along with cash taken from the victim's car. The vehicle owner signed a citizen's arrest form and the suspect was placed into custody, cited, and released at the scene. Report number: 180248112

A call of a man sleeping on a Muni bus at Geneva and Munich prompted dispatch to send Ingleside Officers Freed and Watts to investigate. The officers found the sleeping passenger holding an expensive laptop computer. The officers opened the computer and noted the name of the owner on the screen. The sleepy commuter didn't match the name on the computer and couldn't provide the password to open the files. He told the officers he bought the computer for \$15 downtown. He later said he bought the \$1300 retail device for \$100. The officers searched a database for the name on the computer and found the owner who said the laptop was stolen earlier from his office on Union Street. The victim traveled to Ingleside Station and met with the officers and showed them the security video of the suspect taking the laptop. The computer was returned to the victim and the suspect was booked at Ingleside Station for burglary. Report number: 180249831

7:14pm 600 Blk. Moscow Evading Police

Officers have a keen memory of suspects who give them a good reason to remember their facial features. On this date Ingleside Officers Scott and Hardy were on routine patrol when they spotted a suspect who had evaded arrest on the 15th of March. The suspect was driving the same Chevrolet Avalanche he drove on that date. Besides the evasion, the suspect had three outstanding arrest warrants from San Francisco, San Bruno, and Antioch. He was placed in custody and a search of the suspect's clothing revealed methamphetamine and a pipe used to smoke the narcotic. They also discovered a driver's license and other material stolen from a woman earlier. In addition, various tools and objects used for car burglaries were discovered in the Avalanche. Ingleside Officers Demkowski and Smith were on routine patrol when they observed a car, without license plates, drive away from an address where numerous arrests for narcotics and stolen property have been made in the past. The officers stopped the vehicle and interviewed the driver who admitted the car was his but he was unlicensed. Actually, he had been unlicensed for four years, with four convictions for driving without a license since 2011. The officers found narcotics and narcotics paraphernalia inside the car. A man riding a Muni bus was approached by two suspects. The suspects asked the victim “where’s the money”. The victim said he didn’t have any. Later, the victim told Ingleside Officers Hornstein and Trujillo that he exited the bus at 30th and Mission followed by the suspects. Once off the bus, the suspects pinned the victim against a bus shelter. One suspect took out a firearm and placed it against the suspect’s rib and the other took out a knife and did the same. The suspects took the victim’s wallet from a front pocket, removed several hundred dollars, and then threw the wallet on the sidewalk before escaping. Report number: 180249364

A woman home alone heard noises coming from the front gate of her home. She told Ingleside Officer Park and Sgt. Hoang that she went downstairs and suddenly confronted a stranger walking toward her front door. He was arrested and taken to Mission Station where a court ordered blood draw was performed. After that, he was transported to the County Jail and booked yet again for a DUI. 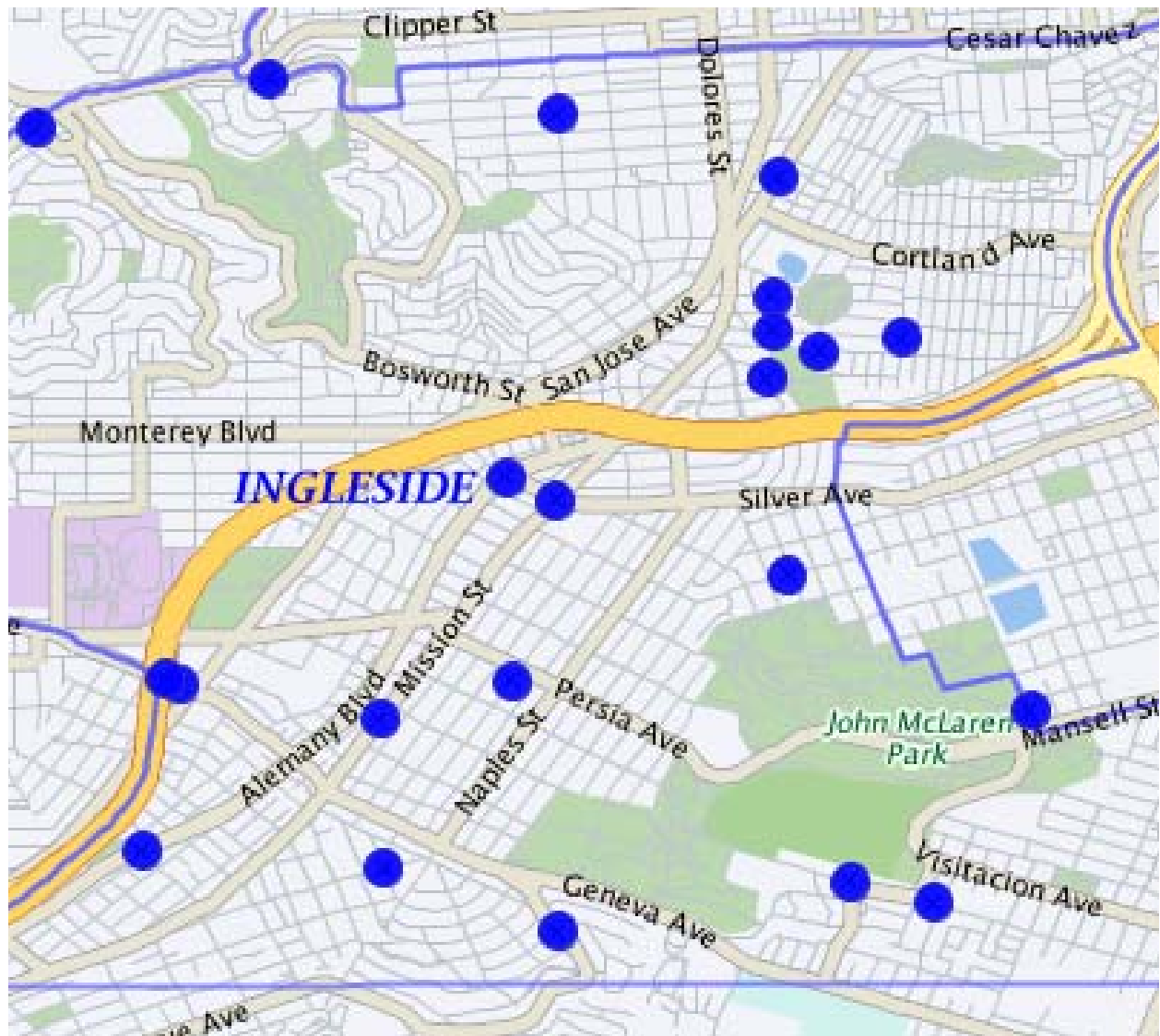
10:03pm Unit Blk. Sunnydale Arson

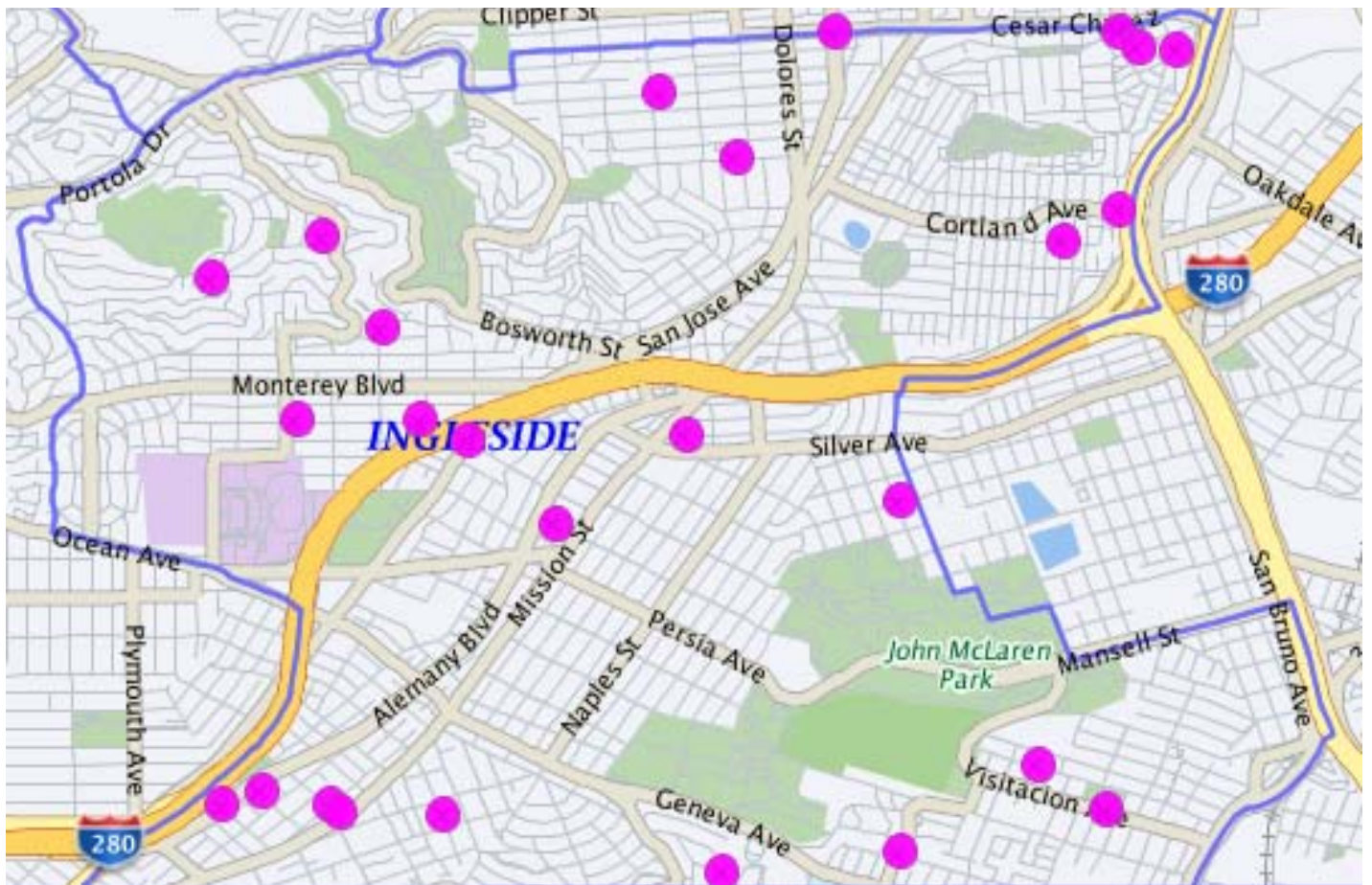

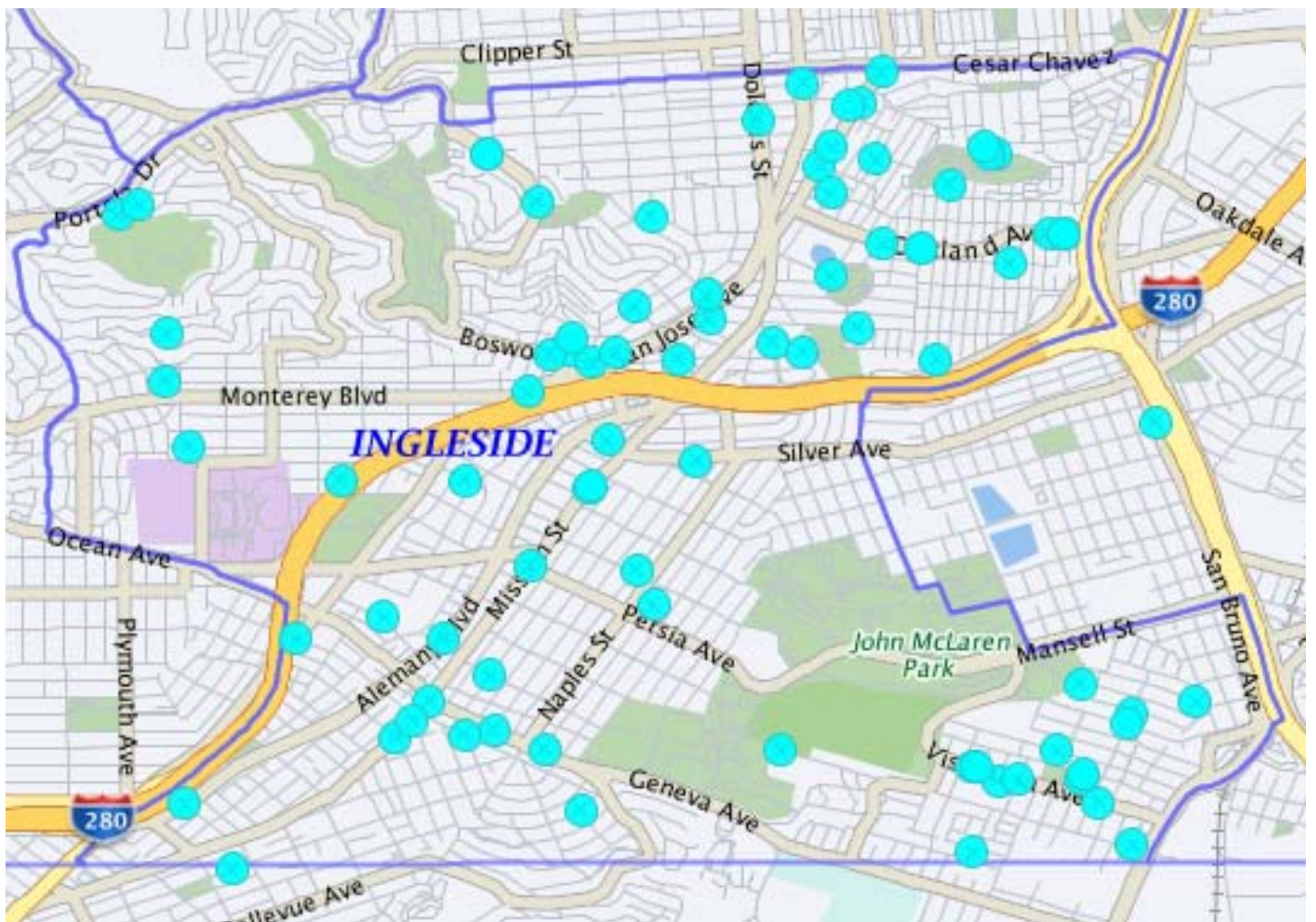

Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on April 4th, 5th, 12th, 17th, 24th and 26th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

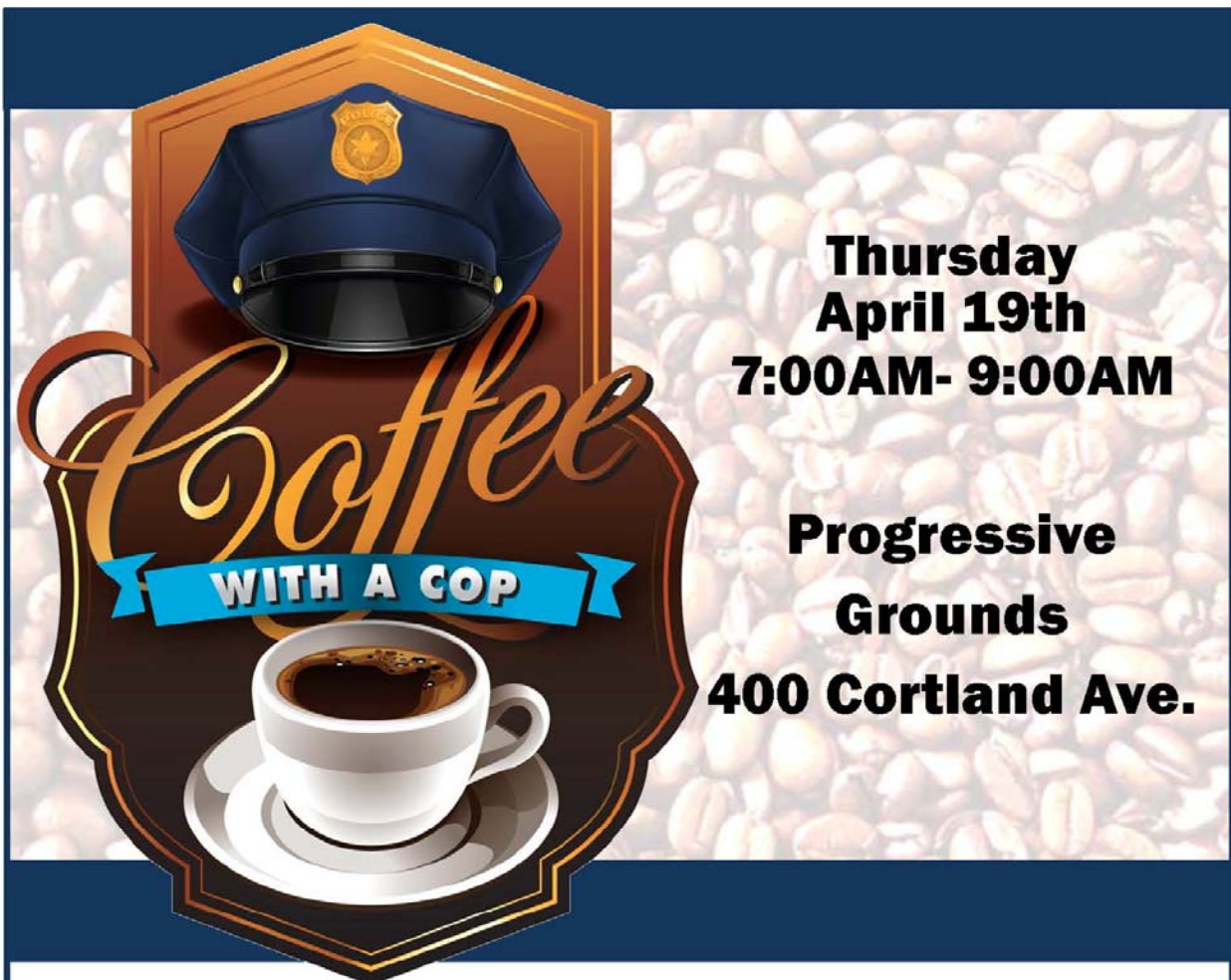

Notes Used During Presentation at the March 29, 2018 Town Hall to Address the March 21, 2018 Officer Involved Shooting

Synopsis:

Wednesday, March 21, 2018 at approximately 4:28 pm

- Officers were dispatched to a 911 call on the 200 block of Amazon Avenue regarding a man in front of the residence with a gun.
- Dispatch advised responding officers that the subject identified as Mr. Jihad Eid was threatening his family, flashed a gun from under his jacket and tried to break into the garage of the house.
- Officers arrived on scene and were told by a witness that Mr. Eid was at the Amazon Barbershop.
- Uniformed officers detained one subject outside of the barbershop as a uniformed and plainclothes officer walked inside.
- As the officers entered, they observed Mr. Eid sitting inside.
- Mr. Eid stood up and shot at the officers.
- Two officers returned fire.
- Officers observed Mr. Eid fall to the ground struck by gunfire.
- One officer was shot by Mr. Eid and crawled out of the barbershop with the assistance of a Sergeant.
- Officers continued to give verbal commands to surrender as other officers on scene helped with evacuating occupants of the shop.
- Mr. Eid was not responsive to the officer's commands at which point they approached and handcuffed him.
- Officers began to render medical aid while an ambulance was requested.
- Officers determined that four additional people in the barbershop had been struck or grazed by gunfire. First aid was administered while additional ambulances were requested.
- All injured parties were transported to Zuckerberg San Francisco General Hospital.

- Mr. Eid did not survive his injuries.
- All other injured parties were treated and have since been released from the hospital.

Additional Information:

- Preliminary evidence indicates that Mr. Eid fired 9 rounds from his 40 caliber firearm.
- A 40 caliber handgun was located inside the barbershop near Mr. Eid and is pictured here today.
- Preliminary evidence indicates that two officers fired approximately 26 rounds from their firearms.
- The Medical Examiner's office preliminary report indicates that Mr. Eid was struck approximately 18 times.

Witnesses

- There are witnesses and reporting parties that heard gunfire or witnessed portions of the shooting. Those witnesses have been interviewed. We are asking that anyone in the public that has additional video evidence or witnessed the shooting contact us so that they can be interviewed.

Involved Members

- Both of the officers who fired their weapons have been interviewed.

Video:

- One of the officers that discharged his firearm activated his Body Worn Camera
- A second officer that discharged her weapon was not wearing a Body Worn Camera since she was working in plainclothes.
- There are additional Body Worn Camera videos from responding officers but they did not capture the shooting.
- We have obtained and viewed dash cam video from a witnesses vehicle in the area.

SFPD Announces Arrests in Home Burglary Series *Suspects Allegedly Stole Nearly \$3 Million in Currency, Credit Cards and Jewelry*

In November of 2017, the San Francisco Police Department's newly established Burglary Unit identified a pattern of residential burglaries occurring frequently in the Bayview, Ingleside and Taraval districts. Over the course of the investigation, members of the Burglary Unit determined that as many as sixty of the residential burglaries were being committed by serial burglary crews.

During the commission of the burglaries, the crews used multiple vehicles with paper license plates and attempted to disguise their identities. The suspects gained entry to the burglarized homes by forcing their way through locked gates and breaking front and rear doors of the residences. The burglaries occurred in occupied and unoccupied homes.

Burglary Unit investigators determined that eleven firearms, hundreds of pieces of jewelry, US and foreign currency, credit cards, passports, vehicle titles and vehicle keys were stolen, valued at nearly \$3,000,000.00.

Assisted by numerous local, regional, out-of-state, and federal agencies, SFPD was able to identify nearly thirty individuals responsible for or accomplices in the burglaries. As a result, the department authored and served several search and arrest warrants over the last ninety days in San Francisco, Oakland, Antioch, Brentwood and Las Vegas.

During the serving of these warrants, nine of eleven known stolen firearms were recovered. In the search warrant served in Brentwood last week, four more firearms were recovered, including two that were stolen in separate burglaries in Fremont, CA and Reno, NV.

Investigators also recovered multiple pieces of stolen property including jewelry, passports, US and foreign currency and eight vehicles used in the burglaries.

Of the thirty individuals identified in the investigation, ten have been apprehended along with two additional individuals arrested during the search warrant served in Brentwood. SFPD continues to investigate the remaining individuals for their involvement in the burglaries.

“With these arrests, there has been a marked decrease in burglaries in the Bayview, Ingleside and Taraval districts,” said San Francisco Police Chief William Scott. “Our establishment of a General Crimes Unit to focus on serial residential and commercial burglaries, auto break-ins, bicycle thefts and other neighborhood property crimes is bearing results. We will continue to pursue crime prevention and investigation strategies that will increase safety for all and help bring justice for victims of serial criminals.”

The ten individuals arrested to date in this burglary series are:

- 23 year-old Demarria Conley of Antioch, charged with conspiracy, burglary, possession of stolen property, and resisting arrest
- 64 year-old Steve Levy of Oakland, charged with firearms violations
- 44 year-old Jabari Jackson of San Francisco, charged with multiple counts of possession of stolen property and vehicle theft
- 25 year-old Kelvon Watts of San Francisco, charged with assault with great bodily injury and elder abuse
- 33 year-old Marshay Goodspeed of Antioch, charged with burglary and reckless evasion

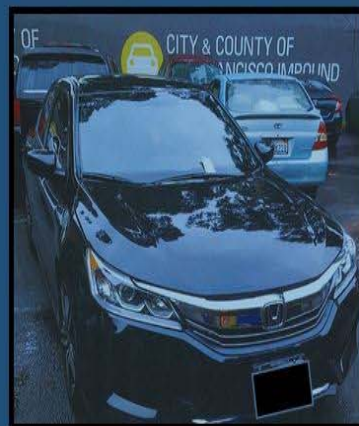
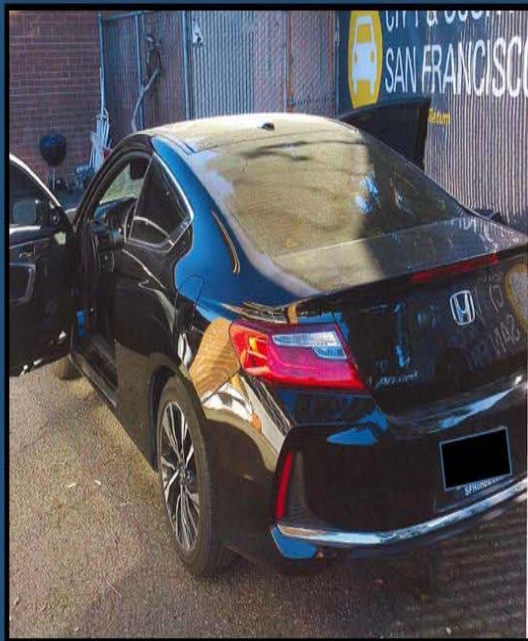

“Bart Simpson” Tagger Arrested by SFPD

On March 27, 2018, at approximately 2:52 AM, Central District police officers were dispatched to the 600 block of Jackson Street regarding a vandalism call. Dispatch broadcast a description of male who was painting an image of Bart Simpson. The suspect was described as wearing a bright orange construction vest and a dark colored shirt.

The officers observed a male matching the description of the suspect near the corner of Grant Avenue and Jackson Street. Officers detained the male, later identified as Tyler Ross, a 27 year-old transient. Ross had paint on his hands and had an open grocery bag which contained several cans of spray paint. Ross also had in his possession, paint markers, white-out pens, etching pens and a Bart Simpson keychain.

One officer walked around the area of the 700 block of Jackson Street and observed a freshly spray painted image of Bart Simpson. The paint in the image matched the paint on Ross's hands and the spray paint cans found in his possession.

Based on evidence and witness statements obtained during the investigation, Ross was arrested and booked at San Francisco County Jail on felony and misdemeanor counts of vandalism at San Francisco county jail. Ross's booking photo accompanies this news release.

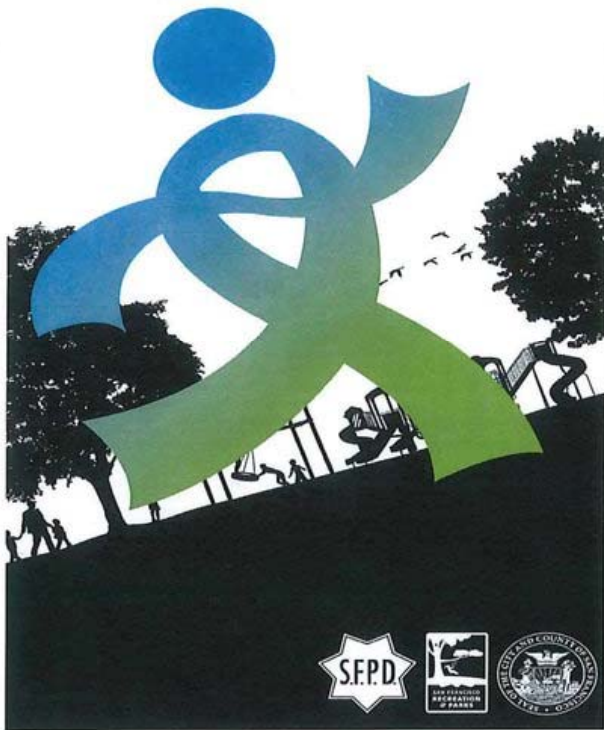

The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
