## Featured Officers of the Month Ofc. Downs & Ofc. Burke



This month features two officers on the midnight shift who are going above and beyond to keep us safe in our homes when the sun goes down: Ofc. Kevin Burke and Ofc. Kevin Downs. Ofc. Kevin Downs' request to transfer from Taraval Station to Ingleside Station was granted by Headquarters and this successful midnight shift partnership was formed. How successful has this partnership been? In just three shifts together, they have already seized two illegally possessed firearms in two separate incidents. On March 27th, 2018 at 01:15AM, officers saw a vehicle with "paper" plates at the Chevron Gas Station at 5098 Mission Street. He saw that one occupant of the vehicle was using a squeegee to bang on the attendant's glass door, while the driver quickly concealed an item upon seeing the officers. These subjects, both convicted felons, were prohibited from possessing the Glock with a 30-round magazine that was subsequently discovered illegally possessed in the glove box. On March 29th, 2018, these same officers spotted a vehicle running a stop sign at 01:30AM at Mission and Randall Streets. Upon seeing narcotics paraphernalia in plain view, officers discovered narcotics and an illegally possessed Glock firearm.

## Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



## Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are “In progress” crimes, which demand an immediate call to 9-1-1:

- ◆ An individual peering into vehicles, to try, and locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or

## Crime Definition

**Robbery** – Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery - (Misdemeanor battery)** is any willful and unlawful touching of another.

**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

\***Assault** is when a person swings their arm and battery is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft** – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

**Monday, April 16<sup>th</sup>, 2018**

### Arrests:

**4:16pm          3300 Blk. Mission          Robbery**

A shopper decided to pick up several cases of "Red Bull" at the Safeway Store. He pushed past store security and ran out of the store with two Safeway employees in pursuit. After a few blocks they abandoned their pursuit. However, Ingleside Officers Leung and Salazar found the suspect at Valley and San Jose Avenue and picked up the pursuit. Both officers, along with Sgt. Ueber and Officer Harper, were able to apprehend the suspect, arrest him, and recover the stolen Red Bull. He was taken to Ingleside Station and booked for theft and other crimes. The suspect was also on probation for assault with a semi-automatic firearm. Report number: 180282132

**9:00pm          Mission & Geneva          Warrant Arrest**

Ingleside Officers Wise and Fazli spotted a suspect wanted for stealing from a nearby drugstore. The officers stopped and questioned the man who turned out to have narcotics and narcotics paraphernalia in his pockets. Dispatch informed the officers that the suspect also had felony warrants for his arrest including fraud and several narcotics violations. He was taken to Ingleside Station for booking. ### Serious Incidents:

**5:08am          Arleta & Alpha          Robbery w/gun**

A man left his home and was walking toward the bus stop when an unknown suspect ran from behind, put a gun to his face, and demanded his wallet. The victim told the suspect to "relax", but the suspect didn't relax and instead punched the victim in the face with his left hand and hit the victim twice with the gun in his right hand. During the attack the victim's cell phone fell to the ground and the suspect picked up the phone and fled. Ingleside Officers George and Bell arrived and broadcast a description of the suspect and summoned medical assistance for the victim. Report number: 180280421

**3:35pm          Unit Blk. Pasadena          Robbery**

A woman returned home and got out of her car, with her purse strapped over her shoulder, and went to the rear door to fetch her sleeping son. Just then, an unknown suspect ran up behind her, grabbed her purse from her shoulder, breaking the strap, and ran away northbound on Pasadena. The victim told Ingleside Officers Johnson, Naser, and Mora that she chased the suspect for a short distance and then turned around and went back to take care of her son. The officers canvassed several nearby residences and found many with surveillance cameras including one that had good video of the suspect. The loss was the purse containing a pink wallet, iPhone 7, driver's license, 7 credit cards, and a small amount of cash. Report number: 180281877

### Arrests:

#### **5:20am      Bernal Heights & Ellsworth      Stolen Vehicle**

Ingleside Officers Burke and Downs were patrolling an area where several stolen vehicles are found. On this night they saw a late model Chevy Malibu with Arizona license plates and three occupants, two of whom were asleep, inside. They ran the plates and noticed the Chevy was reported stolen out of Los Angeles. Burke and Downs radioed for assistance and soon several other Ingleside officers arrived. The woman driver was removed from the vehicle and arrested for vehicle theft. She had a two prior convictions for the same crime. The front seat passenger had a no bail warrant out of his arrest from the Los Angeles County Sheriff's Department. The rear seat passenger had no warrants or wants and was released. The other two were taken to Ingleside Station and booked for their crimes. Report number: 180278062

### Arrests:

#### **5:10am      1500 Blk. Hampshire      Vandalism**

An apartment resident heard a loud crash coming from the front of his multi-unit building. He looked on his laptop to scan the buildings' security camera and quickly saw an unknown man inside the entrance to the building and the front glass door shattered. The resident called police and Ingleside Officers Cornejo and Jensen arrived and found the suspect nearby. They also looked at security footage which showed the suspect breaking the glass door and rummaging through items in the lobby. He was arrested for burglary and malicious mischief vandalism and transported to Ingleside Station for booking. Report number: 180275541

#### **2:11pm      100 Blk. Allison      Resisting Arrest**

A citizen called police to report an unknown man trying to break into his garage. Ingleside Officers Peregrina and Tiffer arrived and found the suspect nearby. The officers tried to detain the suspect but he ignored commands and kept walking away from them. When they approached him again he took up a fighting stance and said he wanted to fight the officers. Peregrina and Tiffer were able to subdue the suspect after a struggle and arrest him. Report number: 180276505

A double-parked car led to the arrest of a man wanted for an outstanding warrant. Ingleside Officers Barajas and Seavey pulled up behind the car, exited their patrol vehicle and contacted the driver and his passenger. A records check revealed the driver had an outstanding \$5000 warrant. He also had a large "BB" gun in his waistband and a quantity of marijuana. A man sitting at a bus stop was approached by a stranger who demanded his belt. The victim told Ingleside Officers Hoge and Harper that the suspect put his hand behind his back indicating he had a gun. The suspect asked the victim to surrender his belt or he would shoot him. The victim complied and the suspect took the belt and fled in a nearby parked minivan. Report number: 180277183

### Arrests:

#### **8:19pm      Diamond & Surrey      Resisting Arrest**

A call of a man walking in the street talking to himself prompted dispatch to send Ingleside Officers Denning and Tom to investigate. When they arrived they found the suspect walking the middle of Diamond Street. When the officers attempted to stop the suspect and walk him to the sidewalk for his safety he resisted. He fought and struggled before finally being subdued and placed in handcuffs. Inside one of his pockets was a glass pipe used to smoke narcotics. A computer search revealed he was on active probation from a San Francisco court. He was previously arrested on April 5<sup>th</sup> and charged with same crime. Ingleside Officers Tom, Denning, and Labson were treated at San Francisco General for injuries to knees, fingers, and shoulders. The suspect was transported to the County Jail and booked for resisting arrest and other crimes. Report number: 180274907

#### **2:30am      600 Blk. Chenery      Hot Prowl Burglary**

A man asleep was awakened by a loud noise coming from the front door of his home. He told Ingleside Officer Anderson that he grabbed a golf club and went downstairs and saw a silhouette at the bottom of the stairs near the front door. The homeowner yelled "hey" and the suspect quickly left the home. The victim showed the officer pry marks at the front door near the lock. Report number: 180272230

#### **12:00noon      Mission & Persia      Aggravated Assault**

A MUNI passenger exited a 14R Mission bus, at Persia and Mission, was pushed from behind by another passenger. The victim told Ingleside Officers Grabbe and Camarra that he turned around and said, "Hey. No Pushing!" The suspect then punched the victim in the face, got off the bus, and ran south on Mission. The victim refused medical attention. Grabbe and Camarra searched the surrounding area for the suspect without success. Report number: 180273244

#### **4:15pm      3300 Blk. Mission      Robbery w/Force**

A fight between juveniles prompted dispatch to send Ingleside Officers Watts and Freed to investigate. When they arrived they found a 14 year old girl with injuries to her hands and wrist. She told the officers she was exiting the bus when two other juvenile girls tried to pull her backpack from her shoulders. When they couldn't initially accomplish that task, they opened the backpack and stole several contents. After a short struggle, they finally wrestled the backpack away from the victim forcing her to the ground. While on the ground, the two suspects punched and kicked her before running away. The victim was transported to UCSF Benioff Children's Hospital for treatment. MUNI security promised to send security video of the attackers to Ingleside investigators. Report number: 180273987

### Arrests:

**3:34pm Onondaga & Mission Vandalism**

A dispute between a car owner and a tow truck driver resulted in the arrest of the car owner. Ingleside Officers Denning, Salazar, Leung, Hornstein, and Sugitan were dispatched to the Burger King parking lot on Onondaga Street. The restaurant had called their tow company to tow a Honda parked in the lot. When the tow truck driver arrived and hooked up the car for towing, the car owner appeared and tried to stop the action. When the tow truck driver refused, the car owner picked up a 4x4 piece of wood and struck the tow truck's door doing considerable damage. The car owner also picked up a trash can and threw it at the truck causing more damage. The officers arrested the car owner and transported him to the county jail for booking. **2:48am 100 Blk. Coleridge Arson**

Ingleside Officer Wong was dispatched to a report of a vehicle on fire. When he arrived SFFD personnel had already extinguished the fire and notified the arson unit. A witness told Officer Wong that he was awakened by a car horn and went downstairs to look outside and saw the vehicle fully ablaze. The owner of the damaged car said she bought the vehicle about two days before and did not know who started the fire. Report number: 180269481

**4:52pm 100 Blk. Blythedale Robbery**

Ingleside Officers Lustenberger, Carew, and Archilla were on routine patrol and spotted a parked Hyundai Sonata parked on the north side of Blythedale Street. The vehicle was wanted in a robbery that occurred 10 days before. The car was towed to impound and held for further investigation. Report number: 180257618

### Arrests:

#### **3:56pm      4600 Blk. Mission      Forged Checks**

Ingleside Officers Peralta and Chan arrested a suspect who, most people would agree, could only be developed by a Hollywood screenwriter. The officers were dispatched to a bank after the manager called to say a man was trying to cash forged checks. When the officers arrived they found the suspect sitting at the customer service desk. The officers first searched his clothing and found a variety of stolen and fake debit and credit cards with several different names. In another pocket was a “credit card skimmer” along with a ring of ten keys and one flash drive. The officers spoke to a bank teller who told them the suspect tried to cash a forged check for \$1100. A computer search at the bank found several more stolen and forged checks from the same account for various amounts including one for \$208 thousand and another for \$608 thousand. The account was fortunately closed before any of the checks could be cashed except one, for \$5000. Inside the suspect’s backpack were several more large denomination forged checks from a different stolen account, and seven stolen or unreported missing passports from different nations around the world. The suspect was arrested for several serious property crimes and taken to Ingleside Station for booking. Report number: 180268295

#### **10:53pm      Teresita & Melrose      D.U.I**

A collision involving a Ford Ranger pickup and a parked Mercedes Benz prompted dispatch to send Ingleside Officer Cortez and Sgt. Hoang to investigate. When they arrived the officers interviewed the pickup’s driver who said he was traveling down Teresita, in the rain, when he struck the Mercedes. The officers smelled alcohol on his breath and the suspect admitted to drinking 2 to 3 alcoholic beverages before the collision. He agreed to a take a roadside sobriety test and failed. Ingleside Officers Lozano and McCall arrived with a breath alcohol tester. The suspect agreed to use the device which measured a blood alcohol level more than twice the legal maximum. Another breath alcohol test, conducted at Mission Station, confirmed the first test’s results. He was taken to the County Jail and booked for DUI. Report number: 180269312

### Arrests:

#### **11:31am Ocean & San Jose Theft**

Every day, at the beginning of their shift, officers hear about crimes in the neighborhood and suspects, if known, wanted for those crimes. On this day, Ingleside Officers Dungca and Calupad were on patrol when they spotted three juveniles wanted for the theft of an iPhone X from a passenger on a MUNI bus. The MUNI surveillance video matched the description of the three young men standing on the Southeast corner of Ocean and San Jose Avenue. After consulting with a MUNI task force officer assigned to the case, Dungca and Calupad arrested one of the juveniles as the prime suspect in the theft. He was taken to the Juvenile Justice Center for booking. The other two young men were released at the scene. Report number: 180138541

#### **4:53pm Bernal Heights/Ellsworth Stolen Vehicle**

Ingleside Officers Burke and Downs were patrolling an area where thieves dump stolen vehicles. On this date they discovered another one that was especially troublesome. Burke and Downs found a late model black Toyota Corolla that was recently reported stolen. The driver was recently arrested for possession of stolen property, using another person's identification, and possession of narcotics. Inside the stolen vehicle the officers discovered numerous stolen ID's, stolen credit cards, fifteen counterfeit one hundred dollar bills, passports from several nations, a holster, a bullet resistant vest, and a Crossman pellet rifle without the required orange tip on the muzzle. The officers also discovered a significant amount of methamphetamine. The suspect was taken to the County Jail and booked on a variety of charges. The stolen car was towed to auto return. A "shot spotter" alert sent Ingleside Officers George and Billings, along with several other Ingleside units, to investigate. He also found a homeless man who told Capt. Hart he lit the blaze to stay warm. Ingleside Officers Leong and Tillan arrived on scene to assist Captain Hart. The suspect, after discussing his circumstances with the officers, accepted homeless services at Glide Memorial Church. Leong and Tillan transported the suspect to the Church while Capt. Hart notified the Arson Task Force of the incident. Report number: 180264334

**4:45pm      Crescent & Agnon      Attempted Robbery**

A young man walking home from school on Crescent Street was approached by two men. The victim, wearing earphones, walked by the two men and then felt someone tapping him on his shoulder. One suspect asked the victim for his phone. The victim said he didn't have a phone and started running away eastbound on Crescent to escape the suspects. The suspects chased him for a short distance and then stopped. He called police from his home and Ingleside Officers Wise and Fazli arrived to interview the victim. Report number: 180265978

A woman went to her front door after hearing someone knocking. It was her neighbor who said her car, parked outside, was on fire. The victim went outside and saw smoke coming from a child seat in the back, three tires flattened, the hood and passenger doors damaged with black spray paint, several windows shattered and white paint on the roof. She told Ingleside Officers Naser and Johnson that she had no idea who would want to damage her property. The officers notified arson investigators who traveled to the scene. 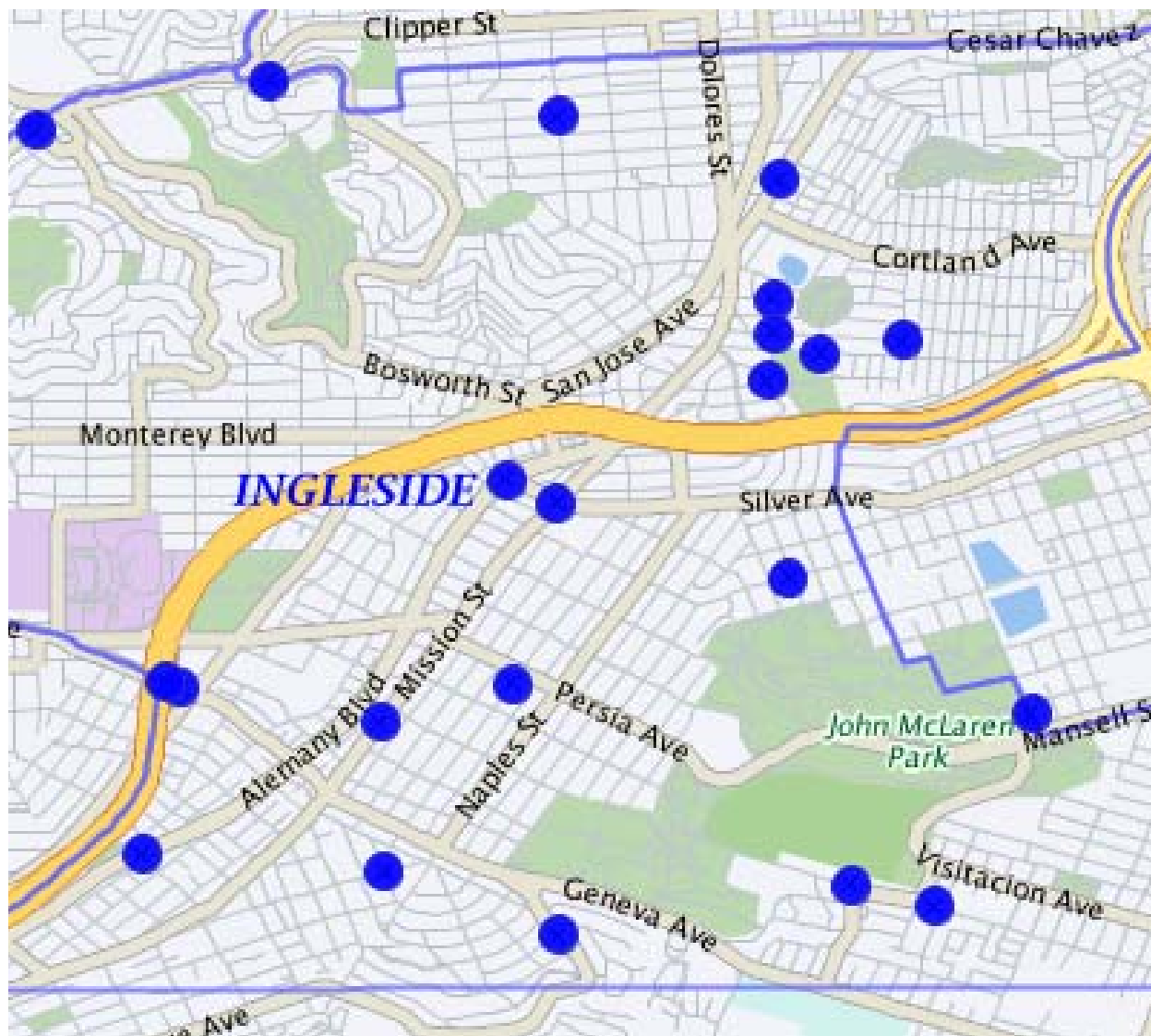
**6:00pm      Unit Blk. Valerton Ct.      Hot Prowl Burglary**

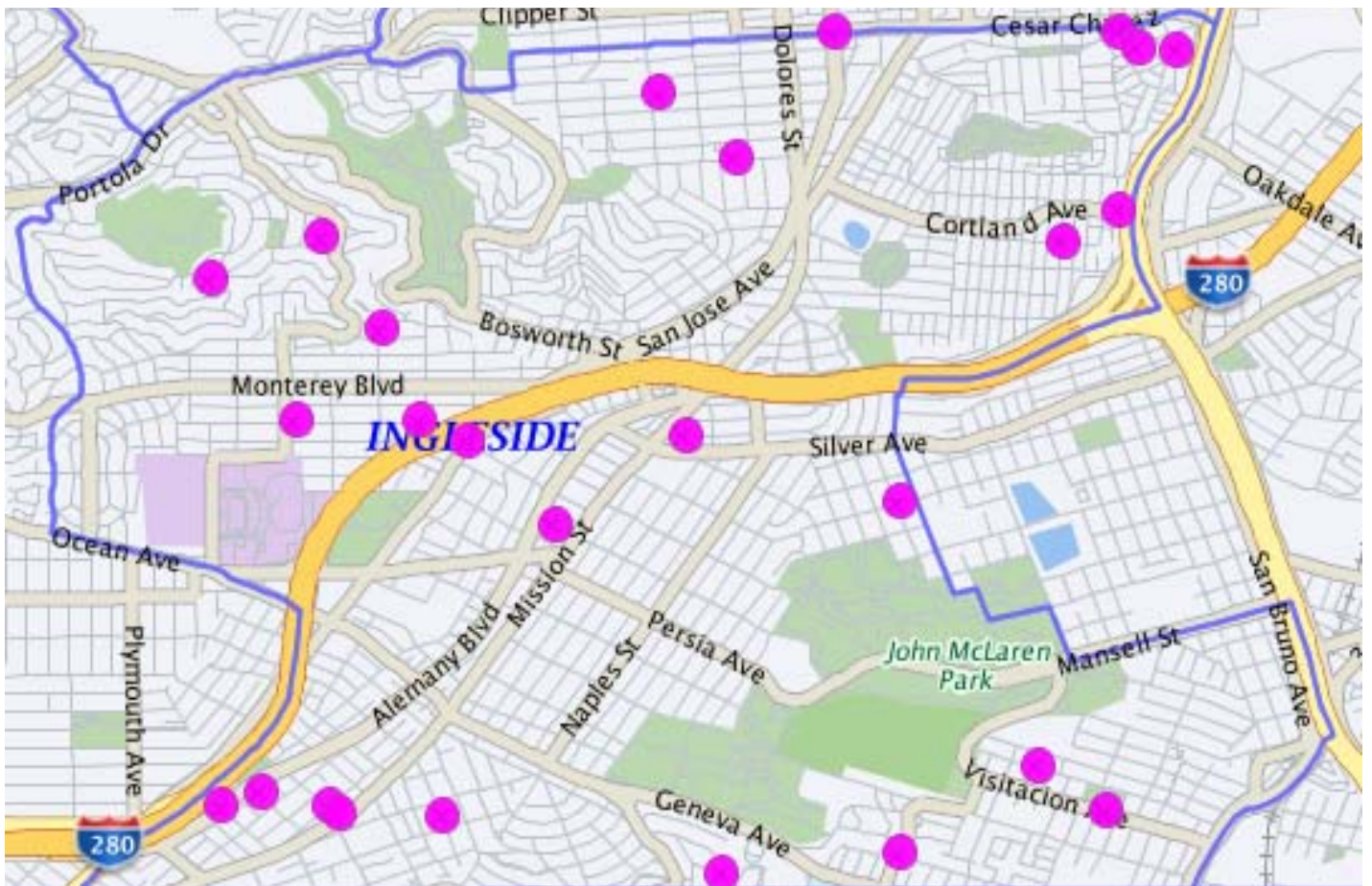

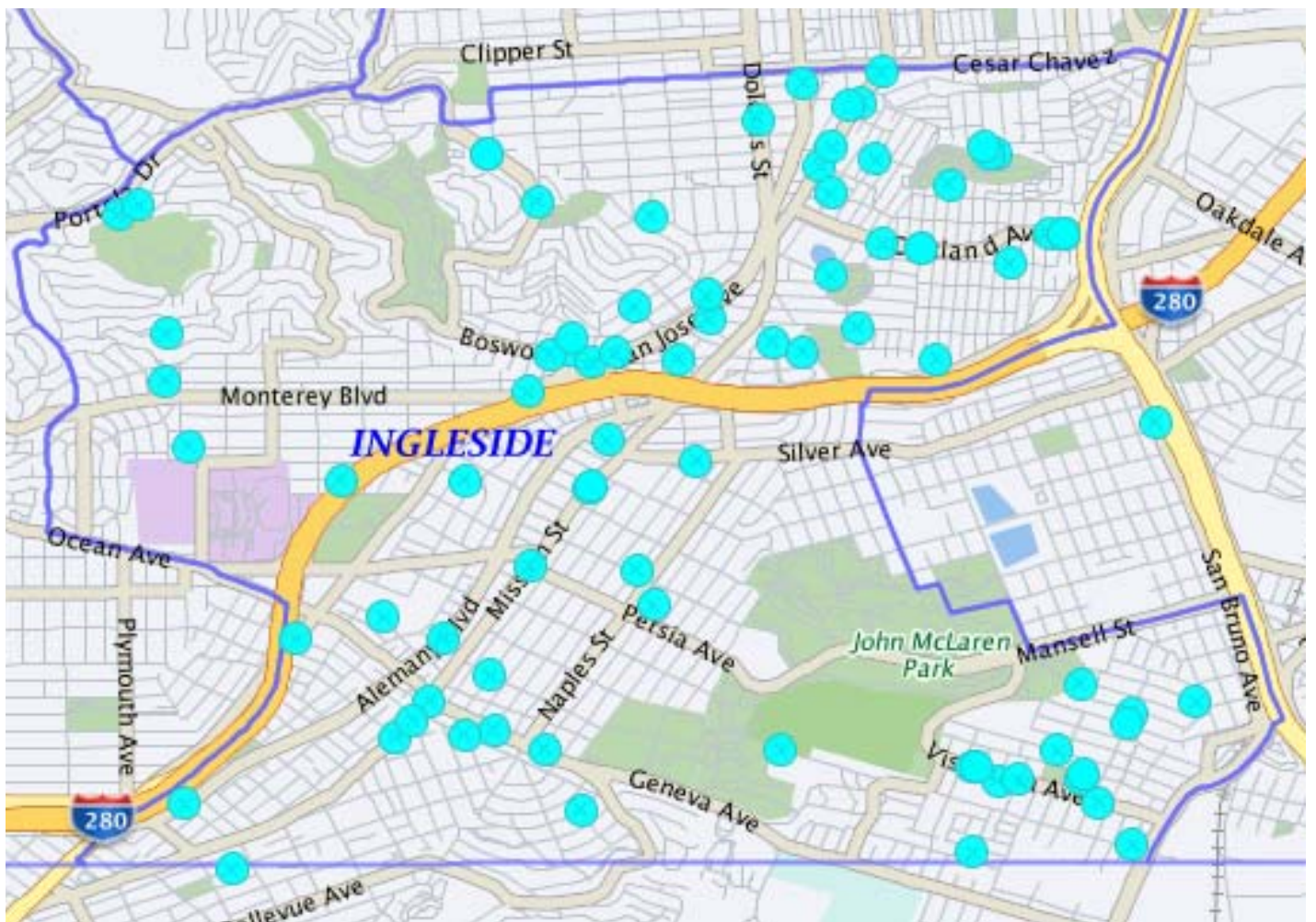

### **Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant**

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on April 4th, 5th, 12<sup>th</sup>, 17<sup>th</sup>, 24th and 26th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

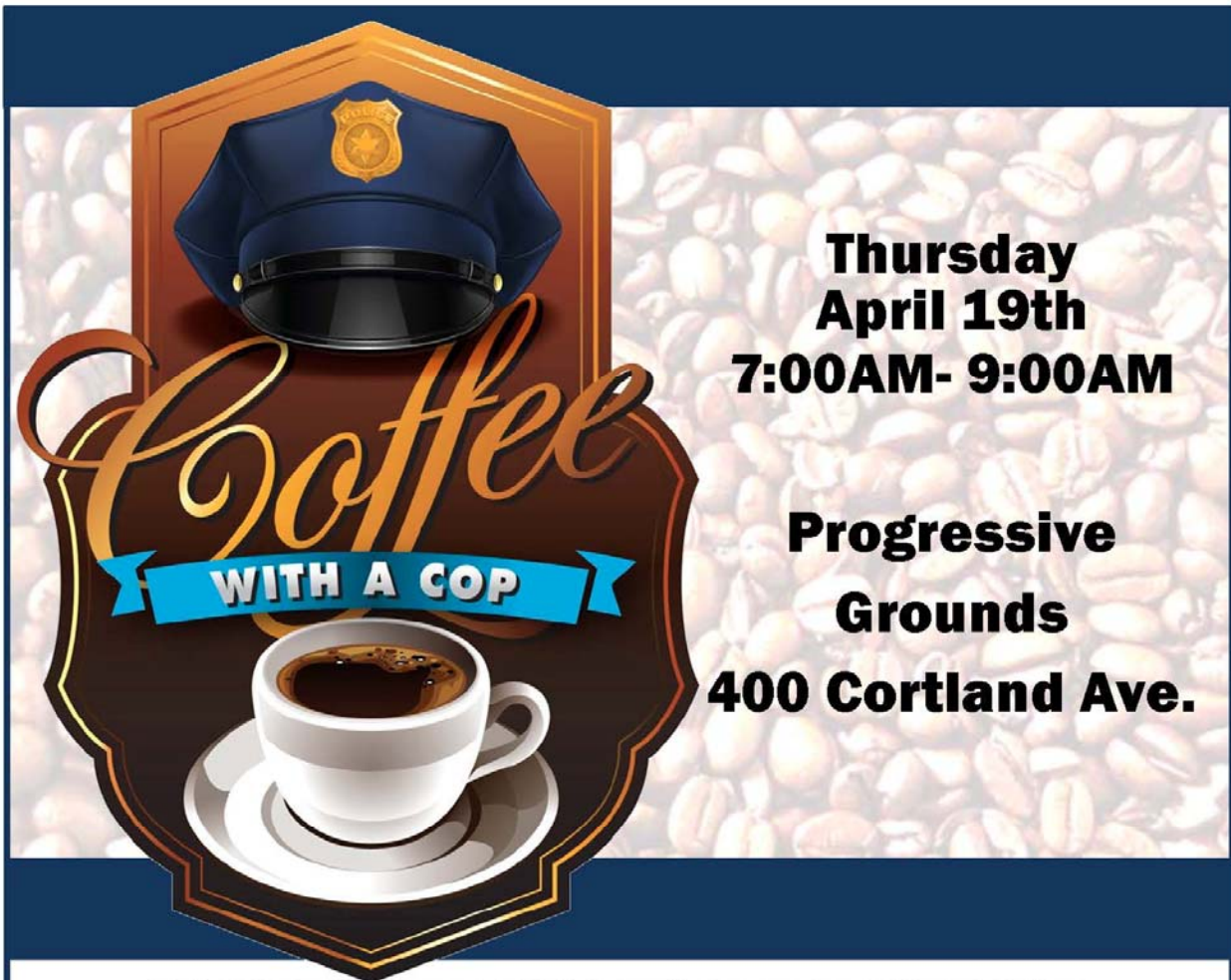

### **SFPD Announces Arrests in Home Burglary Series** ***Suspects Allegedly Stole Nearly \$3 Million in Currency, Credit Cards and Jewelry***

In November of 2017, the San Francisco Police Department's newly established Burglary Unit identified a pattern of residential burglaries occurring frequently in the Bayview, Ingleside and Taraval districts. Over the course of the investigation, members of the Burglary Unit determined that as many as sixty of the residential burglaries were being committed by serial burglary crews.

During the commission of the burglaries, the crews used multiple vehicles with paper license plates and attempted to disguise their identities. The suspects gained entry to the burglarized homes by forcing their way through locked gates and breaking front and rear doors of the residences. The burglaries occurred in occupied and unoccupied homes.

Burglary Unit investigators determined that eleven firearms, hundreds of pieces of jewelry, US and foreign currency, credit cards, passports, vehicle titles and vehicle keys were stolen, valued at nearly \$3,000,000.00.

Assisted by numerous local, regional, out-of-state, and federal agencies, SFPD was able to identify nearly thirty individuals responsible for or accomplices in the burglaries. As a result, the department authored and served several search and arrest warrants over the last ninety days in San Francisco, Oakland, Antioch, Brentwood and Las Vegas.

During the serving of these warrants, nine of eleven known stolen firearms were recovered. In the search warrant served in Brentwood last week, four more firearms were recovered, including two that were stolen in separate burglaries in Fremont, CA and Reno, NV.

Investigators also recovered multiple pieces of stolen property including jewelry, passports, US and foreign currency and eight vehicles used in the burglaries.

Of the thirty individuals identified in the investigation, ten have been apprehended along with two additional individuals arrested during the search warrant served in Brentwood. SFPD continues to investigate the remaining individuals for their involvement in the burglaries.

“With these arrests, there has been a marked decrease in burglaries in the Bayview, Ingleside and Taraval districts,” said San Francisco Police Chief William Scott. “Our establishment of a General Crimes Unit to focus on serial residential and commercial burglaries, auto break-ins, bicycle thefts and other neighborhood property crimes is bearing results. We will continue to pursue crime prevention and investigation strategies that will increase safety for all and help bring justice for victims of serial criminals.”

The ten individuals arrested to date in this burglary series are:

- 23 year-old Demarria Conley of Antioch, charged with conspiracy, burglary, possession of stolen property, and resisting arrest
- 64 year-old Steve Levy of Oakland, charged with firearms violations
- 44 year-old Jabari Jackson of San Francisco, charged with multiple counts of possession of stolen property and vehicle theft
- 25 year-old Kelvon Watts of San Francisco, charged with assault with great bodily injury and elder abuse
- 33 year-old Marshay Goodspeed of Antioch, charged with burglary and reckless evasion

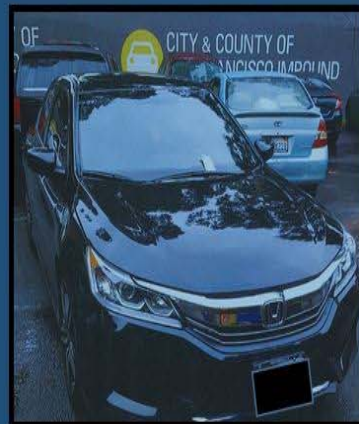
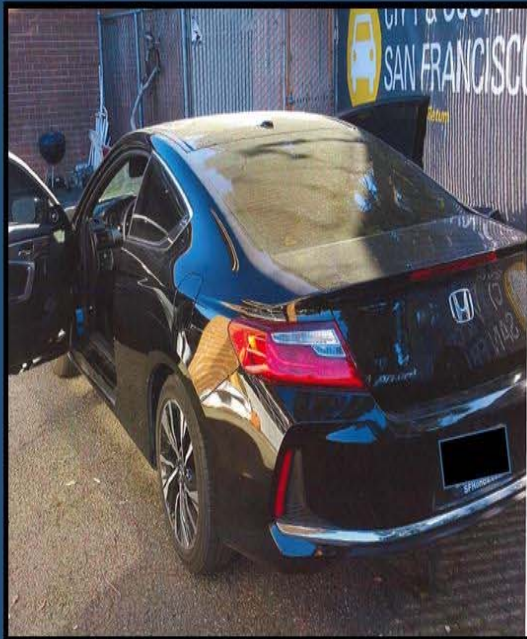

### **San Francisco Police Department and Department of Homeland Security/Homeland Security Investigations Announce Arrests in San Francisco Homicides**

San Francisco Police Department Chief William Scott and Special Agent in Charge for Homeland Security Investigations Ryan L. Spradlin today announced arrests in six homicides committed in San Francisco between 2006 and 2013.

San Francisco Police Department Homicide investigators worked in collaboration with Homeland Security Investigations investigators to develop leads and new evidence that lead to a federal indictment of suspects in these cases.

"The arrests in these criminal cases were made possible through the collaborative partnership between the police department and Homeland Security Investigations," said Chief William Scott. "Through diligent investigative work and careful coordination, law enforcement agents this week were able to safely take several homicide suspects into custody without incident. We hope that these arrests will bring a measure of comfort and healing to the families of the victims, many of whom have waited years for justice."

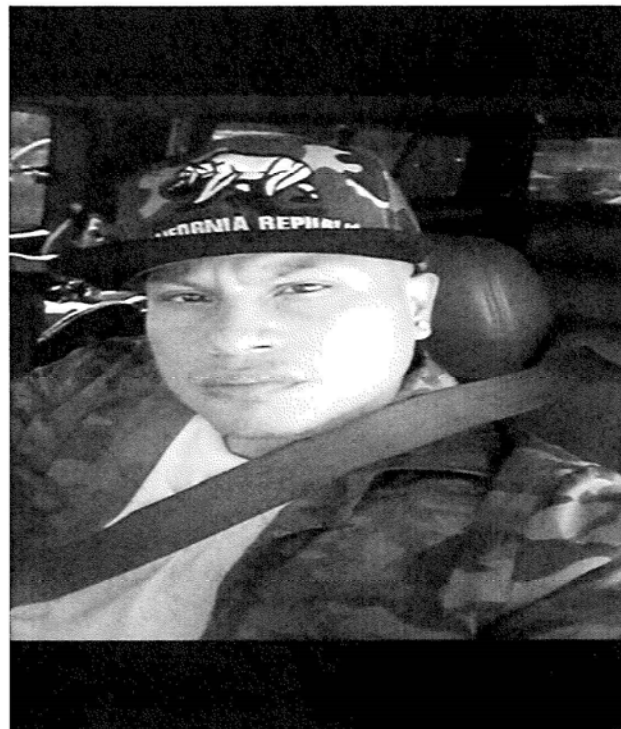

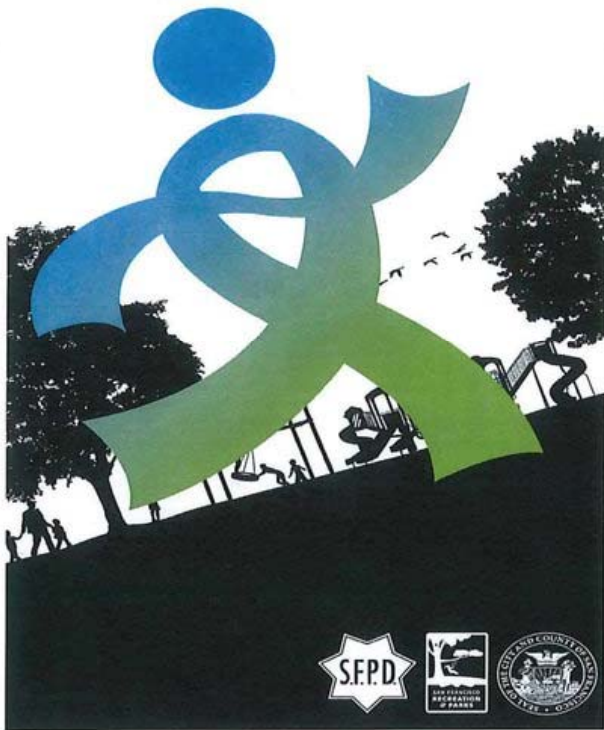

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



## What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

### Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
