## **Featured Officers of the Month** Ofc. Downs & Ofc. Bur





This month features two officers on the midnight shift who are going above and beyond to keep us safe in our homes when the sun goes down: Ofc. Kevin Burke and Ofc. Kevin Downs. Ofc. Kevin Downs' request to transfer from Taraval Station to Ingleside Station was granted by Headquarters and this successful midnight shift partnership was formed. How successful has this partnership been? In just three shifts together, they have already seized two illegally possessed firearms in two separate incidents. On March 27th, 2018 at 01:15AM, officers saw a vehicle with "paper" plates at the Chevron Gas Station at 5098 Mission Street. He saw that one occupant of the vehicle was using a squeegee to bang on the attendant's glass door, while the driver quickly concealed an item upon seeing the officers. These subjects, both convicted felons, were prohibited from possessing the Glock with a 30-round magazine that was subsequently discovered illegally possessed in the glove box. On March 29th, 2018, these same officers spotted a vehicle running a stop sign at 01:30AM at Mission and Randall Streets. Upon seeing narcotics paraphernalia in plain view, officers discovered narcotics and an illegally possessed Glock firearm.

## **Definition of Community Policing**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Ingleside Station officers coordinate with city
  agencies to provide outreach and assistance to rehabilitate those who are dependent on
  illegal drugs and outreach to homeless individuals to connect them with resources and
  support.
- <u>Foot Patrols</u>: Ingleside Station has foot beat officers assigned to the Geneva and Cortland corridors.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously.
   Station personnel also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Ingleside Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

## **Definition of Suspicious Activity**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

The following are some examples of Suspicious Activity that are "In progress" crimes, which demand an immediate call to 9-1-1:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or

## **Crime Definition**

Robbery - Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

\*<u>Assault</u> is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft –** Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

## 12:00pm 2400 Block of Alemany Warrant Arrest/Firearm

Officers Grabbe and Camarra responded to a call of a person wanted on an out of county burglary warrant. The person who answered the door matched the picture of the wanted suspect. He was detained without incident. The suspect had a full search condition and was prohibited from possessing a firearm. After a lengthy investigation the following items were found: a loaded gun, several bank documents with various names of multiple people, currency template, card printer, counterfeit currency, lock pick set, glass cutter, tracking detector, blank bank cards, embosser and many more items. The suspect was booked on warrants totaling over \$30,000 as well as other charges stemming from the above fraudulent items and burglary tools found inside the home. Report number: 180300762

Officers Fazli and Wise responded to a call of a residential burglary. The victim was at home when he heard a noise coming from the bedroom window. He saw a male at the window attempting to gain entry. The suspect removed the screen and opened the window. The suspect punched the victim on the chest. There was a second suspect outside on the sidewalk. The victim pushed the suspect back and both suspects fled the scene. Report number: 180301635

Officer Espinoza responded to a battery committed on a MUNI bus. The victim was on the 29 Line when the suspect approached her and said "do you have a problem"? ## 5:27am Folsom/Bernal Heights Possession of Firearm

Officers Downs and Burke were on duty patrolling the area of the Bernal Heights Park when they came upon a parked jeep with no front license plate. The officers could see that there were two people seated in the back seat. They got out and approached the vehicle in order to talk with the occupants. As they neared the vehicle they could smell the distinct order of burnt marijuana coming out of the open windows. Inside they could also see marijuana and an open container of alcohol in plain view. They then had the two occupants exit the vehicle so that they could conduct a more thorough search. Inside, Officer Burke located a fully loaded 9mm Glock 17 handgun with a 16 round magazine attached to it in the center console. Both subjects were arrested and taken back to Ingleside station. Turns out the passenger had an outstanding misdemeanor warrant for her arrest. The driver was booked on various felony charges including possession of a loaded firearm and possession of a concealed weapon and marijuana charges. Report Number: 180297250

## 11:47am 1100 Blk Brussels D.U.I

An anonymous neighbor called the police to report a single car accident. The neighbor told dispatch that his neighbor had collided with his own retaining wall as he pulled into his drive way. Medics were sent in case the driver was injured. When Officers Freed and Watts arrived they were told by the medics that the driver was still in his car and that he tried to start the car up, so they took the keys away for his safety. Officers Freed and Watts went to talk to the driver and immediately smelled alcohol and found a half empty bottle of Jack Daniels in the driver door pocket. They tried to have the driver do some Field Sobriety Tests, but he was so intoxicated that he could not even stand. The medics transported the driver to San Francisco General where a warrant was obtained to draw his blood. Once released, the driver was ultimately charged with driving under the influence. ## 3:57am 100 Blk Sagamore Vehicle Burglary

Officers Jensen, Clayton, and Bell were at the gas station at Mission and Sickles on an unrelated call when a male subject tried to get their attention from across the street. The male yelled out, "Hey Officer, this guy is following me". The officers looked in his direction and in fact saw a White Lincoln Aviator slowly following the subject. The officers crossed the street and went to talk with both parties. It turned out that the driver of the Lincoln Aviator was the victim of a vehicle burglary and was in the process of following the suspect as he was calling the police when they came upon the officers at the intersection. The owner said he had just gotten home from work and was about to take a shower when he heard noises coming from outside. He looked out his window and saw the male suspect reaching into his vehicle through a shattered window and opening his passenger door. The victim yelled out to the suspect not to take his tools, but the suspect responded by saying, "I don't care". The suspect grabbed the bag of tools and fled the area. The victim quickly got dressed, jumped into his car and began following the suspect while calling the police. The officers back tracked and found the bag of tools that the suspect dumped as he tried to make his get-a-way. The suspect was arrested and booked for vehicle burglary, possession of burglary tools and probation violation. Report Number: 180294864

## 10:14am 200 Blk Schwerin Fire/Marijuana Cultivating

SFFD units responded to a call of a house fire on the 200 block of Schwerin and discovered something unusual inside. When Officers Cornejo-Rodriguez and Peregrina arrived they were informed by the fire chief that the house was being used as a grow house with hundreds of marijuana plants throughout the house. With the assistance of other Ingleside units, Officers Cornejo-Rodriguez and Peregrina entered the house and searched the premise finding plants in different stages of growth, grow lights and multiple fans. A PG&E representative also arrived and discovered that the power had been illegally bypassed to conceal the power usage used for the grow house. Fire investigators located a power surge box, which was the cause of the fire inside the house. The marijuana plants were eventually seized from the home as evidence. Report Number: 180295254


## 7:15pm Visitacion/Desmond Theft





## Traffic Safety Enforcement Operations Plan for San Francisco with OTS Grant

The San Francisco Police Department will conduct Traffic Safety Enforcement Operations on April 4th, 5th, 12<sup>th</sup>, 17<sup>th</sup>, 24th and 26th with a focus on bicycle and pedestrian safety. Over the past three years, the department has identified areas where significant numbers of pedestrian and bicycle-related collisions have occurred and responded by deploying additional officers to those areas in an effort to prevent deaths and injuries. Special attention will be given to Focus on the Five violations: speeding, making illegal turns, failing to stop for stop signs and red lights, failing to yield to pedestrians in cross walks, as well as any other dangerous violation.

San Francisco is committed to eliminating traffic deaths on our streets as part of Vision Zero SF. Vision Zero SF is our city's commitment to prioritize safe streets for everyone.

Bicycle and pedestrian fatalities are rising in California as more people use these non-motorized means of transportation. In 2016, California witnessed 867 pedestrians and 147 bicyclists killed, accounting for more than 28 percent of all traffic fatalities.

All riders are reminded to always wear a helmet – those under 18 years of age must wear helmets by law. Pedestrians should cross the street only in marked or unmarked crosswalks at corners. All motorists are reminded to be mindful of others who share the road.

Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

## SFPD Makes Several Auto Burglary Arrest Throughout the City

On Wednesday April 4<sup>th</sup>, 2018 at approximately 8:24 PM, Southern District plainclothes officers were conducting surveillance on the area of the 1700 block of Alameda Street. The officers witnessed a car double park near another vehicle. A male who was later identified as Troy Savoy, a 20 year-old San Francisco resident, exited the car and began casing another vehicle. ## Sobriety Checkpoint In San Francisco

San Francisco Police Department's Traffic Unit will be conducting a sobriety checkpoint this Friday, April 27, 2018, at an undisclosed location within the city limits between the hours of 7:00 P.M. and 3:00 A.M.

The deterrent effect of sobriety checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized sobriety checkpoints and proactive DUI patrols are conducted routinely. Nationally, the latest data shows nearly 10,000 people were killed by an impaired driver.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving. Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while also yielding considerable cost savings of \$6 for every \$1 spent. Nearly 90 percent of California drivers approve of DUI checkpoints.

DUI checkpoints are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

## Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

- 1. Complete two 8 hour classes with ALERT, or,
- 2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
- 3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
