San Francisco residents, visitors, and businesses can help by remaining vigilant while enjoying New Year's Eve festivities. These simple tips will help you stay safe:

- If you see something, say something. Call 9-1-1 or talk to a police officer if you see something suspicious.
- Have a plan. It is easy to lose track of people during large events. It is even more difficult when there is an emergency. Designate a meet up spot if you get separated from your group.
- Be aware of your surroundings and take note of emergency exits
- Have a designated driver or alternative transportation plan if you plan on drinking alcohol.
- All fireworks including "Safe and Sane" are dangerous and illegal in San Francisco. We encourage everyone to choose safety and observe a public fireworks shows.
- If you have a noise complaint, call the police nonemergency line at (415) 553-0123.

## **Definition of Suspicious Activity**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

## **Definition of Community Policing**

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Northern Station officers coordinate with city
  agencies to provide outreach and assistance to rehabilitate those who are dependent on
  illegal drugs and outreach to homeless individuals to connect them with resources and
  support.
- <u>Foot Patrols</u>: Northern Station have beat officers assigned to Hayes Valley, Haight Street, Japantown, Civic Center, Polk Street, and the Marina.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously.
   Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- <u>Email Updates</u>: Northern Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

#### **Crime Definition**

Robbery - Robbery is the taking of property from another by using force or by using fear.

**Assault** – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

\*Assault is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

**Aggravated Assault** – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

**Burglary** – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

**Grand Theft –** Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

**Petty Theft** – Theft where the value of the property taken is less than \$950.

## **Summaries of Supreme Court Case Law**

#### Fourth Amendment: Detention based on taking an individual's driver license

People v. Linn (2015) 241 Cal. App. 4th 46

Rule: An officer's taking of a voluntarily offered drivers license does not automatically mean the encounter is casual. The court will look at the "totality of circumstances" to determine whether an individual was free to leave transforming the casual encounter into a detention.

- Officer did not conduct a traffic stop. Officer parked his motorcycle within three feet of the driver's car and approached her and asked for her driver's license.
- Officer made contact with the driver because the passenger of the vehicle was "flicking ashes out the window."
- Officer commanded driver to put out her cigarette and put down her soda can, thereby

indicating that she was not free to do as she pleased, officer requested driver's license, and officer held the license as he initiated a record check of the driver.

- Officer conducted unexplained records check.
- Under the totality Of circumstances, a reasonable person would not have felt free to leave.

#### Fourth Amendment: Consent to Search during Unlawful Arrest is Involuntary

People v. Espino (2016) 247 Cal. App. 4th 746

Rule: Defendant's consent to search his vehicle is involuntary when consent is obtained while under an unlawful arrest. (Conviction reversed.)

- Officer stopped defendant for speeding.
- Based on informant's tip and other factors, officers prolonged the traffic stop to conduct additional investigation.
- Defendant consented to search of his person and officers found an object they thought was crack. Defendant was hand-cuffed.
- After examining the object, an officer determined it was a diamond.
- Without removing the handcuffs, officers continued to question defendant and requested consent to search his car.
- After some hesitation, defendant gave consent for the car search, whereupon officers found several grams of methamphetamine in defendant's car.
