### **Definition of Suspicious Activity**

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

#### Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

### **District Court of Appeals decisions**

- In re Kenneth Humphrey (A152056) [Note: This Is A Landmark Case Relating To Bail Proceedings And Should Be Read In Its Entirety By Any Persons Involved In Arraignments/Bail Hearings] In this habeas corpus case, petitioner argued the trial court erred by setting a monetary bail amount he was financially unable to pay without first inquiring into his ability to pay or whether any less restrictive nonmonetary alternatives were available. Likely recognizing the Legislature's and Judiciary's recent efforts to bring about meaningful bail reform in California, the Attorney General agreed a new bail hearing should be conducted whereby the trial court considers, among other things, a criminal defendant's ability to pay monetary bail, and whether any less restrictive nonmonetary alternatives to bail may be available. The Court of Appeal reversed the trial court's bail determination and remanded the matter for a new bail hearing consistent with its opinion.
- In re White (D073054) The California Constitution provides that a defendant "shall be released on bail by sufficient sureties" unless an exception applies. Once of those exceptions is for "[f]elony offenses involving acts of violence on another person, or felony sexual assault offenses on another person, when the facts are evident or the presumption great and the court finds based on clear and convincing evidence that there is a substantial likelihood the person's release would result in great bodily harm to others." In this case, where the defendant was awaiting trial for various sexual offenses, the court denied bail. The Court of Appeal upheld the denial, applying a substantial evidence standard of review, and concluding that the above exception was properly applied by the trial court. The Court of Appeal noted that the recent Humphrey case was inapplicable because the trial court made the constitutional findings required for an order of detention, thus precluding the necessity to determine ability to pay.
- In re Webb (D072981) Petitioner was charged with bringing a controlled substance into a state prison. She posted \$50,000 pursuant to the bail schedule and was released. At arraignment, she pleaded not guilty, and over her objection, the court imposed a Fourth Amendment waiver as a condition of bail. A majority of the Court of Appeal held that a trial court lacks inherent authority to impose conditions of bail once a defendant posts the scheduled bail amount. The court distinguished such a situation from releasing a defendant on his or her own recognizance (OR), because OR release does permit a court to impose reasonable conditions of bail. The court struck the Fourth Amendment waiver as a condition of bail. A concurring justice believed that trial courts do have inherent authority to impose conditions of bail, even when the scheduled amount is posted.
- People v. Williams (C080351) Defendant has a long criminal history. He has several prison sentences from multiple cases. Some of those sentences were imposed under the Three Strikes Law. His combined sentences totaled 196 years to life. After the Three Strikes Reform Act of 2012 (Proposition 36) was enacted, defendant petitioned for relief. The prosecution argued that granting the petition would pose an unreasonable risk of danger to public safety. A contested dangerousness hearing was conducted. The court denied the petition, concluding defendant would pose an unreasonable risk of danger to public safety. The Court of Appeal reversed, holding that the trial court abused its discretion by not: (1) first calculating which of defendant's many convictions were eligible for resentencing; and (2) not taking into account when defendant could be released if the petition were granted. If there is a lengthy delay before defendant could be released even if the petition were granted, the trial court should grant the petition because the dangerousness determination would be deferred and vested in the parole board.
