CAPTAIN BAILEY'S MESSAGE

Hello all,

Supervisor Breed and I have called a **community meeting to be held on Saturday February 24th at 11am at Park Station's Community Room, 1899 Waller Street** to allow community members to gather and share their concerns for themselves and their neighborhoods. It will allow us the time to inform all community members the steps we are taking to ensure your safety within the district.

Park District has seen some very unsettling incidents this past week. Friday night Feb 16th was the night Park district experienced its first homicide for 2018. We saw the loss of one life and serious injury of another. Death by homicide anywhere is always concerning but to get the suspect into custody in less than 10 hours is really your best case scenario. SFPD members did a great job in the investigative follow up, which ended in a barricaded suspect, a standoff, shots fired, and eventually a surrender. Thank goodness there were no additional victims or injuries.

On Thursday February 22nd 3 dead bodies were found in a doorway on the 1500 block of Page St. Of course this is incredibly sad that three people would be discovered, deceased in a doorway but what I can tell you that there is no evidence to indicate there was any foul play. The Medical Examiner is handling the case at this time.

I know in the aftermath of such incidents and in particular the violent homicide community members become very concerned for their safety and the safety of their loved ones. I do want to assure you that Park Station officers will continue to do all we can to keep community members safe. You will see more patrol in the Pan Handle and surrounding district as we try to restore a sense of safety.

As you all know the police are only one part of the equation when it comes to creating a safer neighborhood. The community involvement is crucial to a safer neighborhood. It is with this in mind that we have scheduled a breakfast clinic to allow community members to share with us their concerns for their neighborhoods. We invite all concerned citizens to come to our station's community room at 1899 Waller Street on Wed, Feb from 11am to 1pm and meet members of Park Station and share with us your concerns. This meeting is in addition to our community meeting, which is scheduled at 7pm on the second Tuesday of every month (next meeting April 9th). We want to develop collaborative solutions to the issues the community faces. We will provide refreshments for all who attend. Please try to attend as we work to develop solutions to neighborhood issues.

I want to take this moment to remind everyone that the Park district is a safe place to be. We do NOT have a lot of violent crimes happening in our district, and although most crimes committed in our district are property crimes, in 2017, we as a district saw a reduction in every property crime including vehicle break ins. We are continuing to see a reduction to crime in our district. This is because of all the collaborative work that is happening between the police department, the neighborhood community groups, individual community members, our Park District Supervisors Breed, Sheehy, Stefani, Yee, and Fewer and the many city agencies. All of us are coming together to provide collaborative solutions to neighborhood issues.

I do believe that when we all come together, all things are possible, and making our community a safe haven is the top priority for myself and all my officers at Park Station.

- ☑ The festivities are about celebrating community. Look out for each other and report any suspicious persons or activity to event staff or a police officer. A good adage is, "If you see something, say something." In an emergency, call 9-1-1. To provide an anonymous tip, call the SFPD Anonymous Tip Line at (415) 575-4444.
- ☑ Stay informed by signing up for emergency text message alerts by texting the word AlertSF to 888-777. AlertSF allows us to notify you of emergencies in San Francisco.
- ☑ Keep your friends close and your drinks closer. Don't accept drinks from strangers. Drink responsibly and don't drink and drive- always use a designated driver.
- ☑ The San Francisco Bay Area has a host of public transit options that will get you to, from and around Lunar New Year events.
- ☑ If you drive to the festivities, remember to "Park Smart!" Take your valuables with you, don't leave them inside your car.
- ☑ Maintain possession of your cell phone, wallet and other valuables.
- ☑ There is safety in numbers. Stay with a group when on the street or leaving bars and clubs. Be cautious about leaving a bar or club with a stranger. A rule of thumb is that if you feel "unsure" about someone, rely on that instinct and do not go with that person.

Lt. Maron was then promoted to the rank of Lieutenant and assigned to Park Station as one of the 2 night Lieutenants.

Lt. Maron, like all police officers finds his job challenging and rewarding, but what he enjoys the most about being a police officer is the interaction with the public where he is in a position to make a positive impact. For Lt. Maron, the key for that impact is the initial first impression. PARK STATION'S OFFICERS OF THE MONTH FOR FEBRUARY 2018

It's a proven fact that police presence brings down crime, however, we know it is impossible to have police presence everywhere 24/7. Captain Bailey dedicated Officers Jeffery Sung, Ashley Slomowitz, and Michael Reilly as Park Station's homeless outreach officers. These three officers have been tasked with providing outreach to the homeless population within the Park district, with a focus on the parks in the district as well as high-traffic areas. The team performs well-being checks and attempts to engage individuals into services and other resources as identified by the community and their own daily observations. These officers are tasked with teaming up with Richmond Police Station Officers, the Department of Public Works, the Recreation & Parks Department, the Park Rangers, and SF HOT to reduce the number of calls for service and to improve the quality of life for everyone within the community. These officers are out on a daily basis maintaining a high-visibility police presence in providing admonishments, issuing citations, and making arrests when deemed appropriate. Their high-visibility and efforts to identify as many people as possible makes suspects think twice about committing crimes while visiting our neighborhoods.

Captain Bailey nominated these officers as officers of the month because of their outstanding work and attention to detail.

Larry Rosenfeld was born in Southern California and acquired an appreciation for San Francisco and the Bay Area quite young. Larry had his eighth birthday in Cuernavaca, Mexico where his family lived during much of that year. After high school, Larry migrated around California attending different colleges, the last one being Stanford University, where he did his graduate work in Electrical Engineering. Larry spent the bulk of his professional career in Santa Rosa with Hewlett-Packard Company and its spin-off, Agilent Technologies. It was in Santa Rosa that his daughter was born.

Upon his retirement from Agilent in 2006, Larry and his wife moved to the Inner Sunset and he busied himself doing volunteer work at All Saints' Episcopal Church in the Upper Haight. Larry's daughter, son-in-law, and granddaughter live quite near him (although in the Taraval District). In 2009, Larry became treasurer and a board member of Inner Sunset Park Neighbors, and soon after, when then-Chief George Gascón, and then-Captain David Lazar asked all the district commanding officers to implement Community Police Advisory Boards at their stations, Larry became the representative from the Inner Sunset to Park Station.

In 2011, Larry took over from Richard Magary as representative from Park to the City-wide CPAB committee.

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

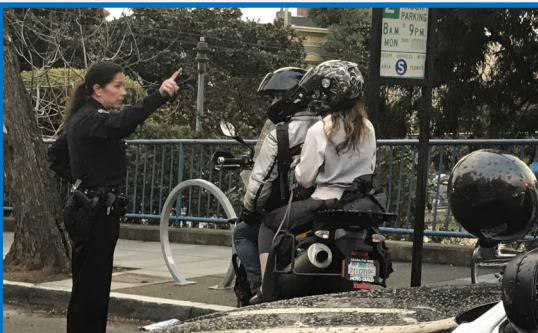
- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



DEFINITION OF COMMUNITY POLICING

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Park Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Park Station runs full time beat officers assigned to Haight Street.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Weekly Email Updates: Park Station sends out weekly email newsletter updates to residents in the District that alerts residents to crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.



CRIME NOTES*Definitions*

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(**Felony battery**) is the use of force or violence upon the person of another that causes serious bodily injury.

***Assault** is when a person swings their arm and **battery** is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

LIST OF CRIMES**Incidents:****Warrant Arrest—Area of Haight St. /Cole St.—02/17/2018 10:05 am**

Officers responded to the intersection regarding a homeless complaint. Upon arrival, officers observed a male subject sitting on the sidewalk and obstructing the free movement of others in the area. Officers advised the subject of his violation, and it was discovered that he had two active misdemeanor warrants out of Marin County. He was booked for the listed warrants.

Robbery with Force—Area of Church St. /Duboce Ave.—02/17/2018 11:16 pm

Two officers responded to the above intersection in regards to a battery incident. Upon arrival, officers made contact with the victim who stated that when the MUNI bus came to a stop and the doors opened, two unknown suspects attempted to take his cellphone from his hand. One suspect struck the victim's nose and then fled the scene in their unsuccessful attempt to steal the cellphone. The victim was being treated for a swollen nose, and transported to the hospital. Officers searched the area for any witnesses to no avail.

Burglary/Forcible Entry—900 block of Cole St.—02/18/2018 2:55 am

Officer responded to the above location regarding a report of an alarm call. Upon arrival, the officer made contact with the owner of the store, and observed the front glass window of the store to be shattered. The officer conducted a search of the premise for the unknown suspect with negative results. The owner stated that currency from the cash register was missing, nothing else appeared to be stolen. The store surveillance cameras did not capture the incident.

Civil Sidewalks Booking—1900 block of Oak St.—02/18/2018 8:33 am

Officers observed a person sleeping on the sidewalk in violation of the city's Sit/Lie ordinance. Officers made contact with the subject and a computer check revealed two narcotics warrants for his arrest. The subject was placed under arrest and a baggy of suspected methamphetamine was located in the subject front pocket and suspected Psilocybin in his suitcase. The subject was transported and booked at Park Station.

Warrant Arrest/Local SF Warrant—Area of Duboce Ave. /Church St.—02/18/2018 3:57 pm

Officers observed a male subject riding a bicycle on the sidewalk of the intersection. Officers activated the emergency lights and made contact with the subject. Officers explained to the subject that he was being detained because he was riding his bicycle on the sidewalk. A computer check revealed that the subject had an active misdemeanor warrant. Officers placed him under arrest and he was booked for his violations.

Robbery with Gun—4100 block of 17TH St.—02/18/2018 7:19 pm

Officers responded to a call regarding a robbery with a shotgun. Upon arrival, officers spoke with the victim who stated that he was sitting in his vehicle when he observed a vehicle stop in front of his. An unknown male subject got out of the driver's seat and retrieved a shotgun from the back seat and carried it into the store. The victim then got out of his vehicle and the suspect exited the store, pointed the gun at him, and told the victim to give him the money that was inside the store. The victim put his hands in the air, entered the store with the suspect, opened the cash register, and the suspect took the cash and fled the scene in the vehicle.

LIST OF CRIMES**Incidents cont...****Warrant Arrest/Local SF Warrant—Unit block of Belcher St.—02/19/2018 12:32 pm**

Officers were dispatched to the area regarding a possible verbal argument. Upon arrival, officers observed a female subject standing with her belongings scattered around her on the sidewalk and a male subject standing next to a wheel chair. A computer query revealed a felony warrant out of San Francisco on the male subject. When asked about any photo identification the suspect said he had documents inside of his bag on the wheelchair. An officer looked at the wheelchair and observed an amazon package that the suspect stated belonged to his friend. Two more packages were located with a different name. Officers contacted the names on the packages and it was discovered the packages were reported stolen by their owners. The suspect was transported to Park Station and booked for his violations.

Robbery with Force—600 block of Stanyan St.—02/19/2018 6:19 pm

Officers responded to the above location regarding a theft from a grocery store. Upon arrival, officers made contact with the reporting party who stated that he observed a male suspect enter the building and leave with a victim chasing after him. The victim asked the suspect to return the items that he had stolen and the suspect returned the property. The suspect then began to hit the victim multiple times, and an unknown bystander tackled the suspect causing him to fall down on the ground. Officers spoke with the victim who stated that she observed the suspect grab a hot sauce and place it into his jacket, making no attempt to pay for the item. She then followed the suspect and asked him to return the item. The suspect began to flip out, and proceeded to punch the victim numerous times. The victim complained of pain to the right side of her face but declined medical assistance. The suspect was subsequently booked for the stolen merchandise and the use of force.

Resisting, Delaying, Obstructing Peace Officer Duties/Warrant Arrest/Local SF Warrant—1400 block of Haight St.—02/20/2018 8:40 am

Officers observed a subject lying on the ground in an alcove of a residence and in violation of the San Francisco Civil Sidewalk ordinance. The subject was accompanied by two other individuals, and when officers asked for identification the subject pretended to reach inside his pockets and then began to walk away. The subject broke into a sprint and ran into the street against a solid red signal light. Officers pursued the subject who proceeded to run towards the front steps of a residence. Officers placed the subject in handcuffs, and located the subject's backpack which contained an uncapped needle with a substance inside. A computer search revealed that the subject had two outstanding felony warrants, and he was booked at Park Station for both warrants and his violations.

Threat or Force to Resist Executive Officer/Warrant Arrest/Local SF Warrant—Area of Oak St. / Masonic Ave.—02/21/2018 5:01 pm

On 02/20/2018 officers patrolling the area observed a homeless individual lying on the sidewalk with a large amount of various belongings that were obstructing the way. A records check of the male revealed that he had a misdemeanor warrant out of San Francisco. Officers advised the subject to take care of the warrant and move his belongings, and the subject agreed to do so. At the above listed date and time, the officers observed the homeless male and his belongings still on the same sidewalk. Officers placed the subject under arrest and the subject began to struggle, kick, and resist. The subject proceeded to slam his head inside of the patrol vehicle and sustained an injury on his forehead. Medics arrived and transported the subject to SFGH. Once the subject was medically cleared he was booked for his warrant and violations.

Officer was flagged down by a victim in the area regarding an auto boost. The front side window was smashed and multiple items had been stolen.

Victim walked into Park Station to report that his rental vehicle was broken into. He discovered that multiple items were missing, and there was no damage made to the vehicle.

Victims walked into Park Station to report that their vehicle had been burglarized by an unknown suspect. The rear window of their vehicle had been smashed and multiple items were stolen.

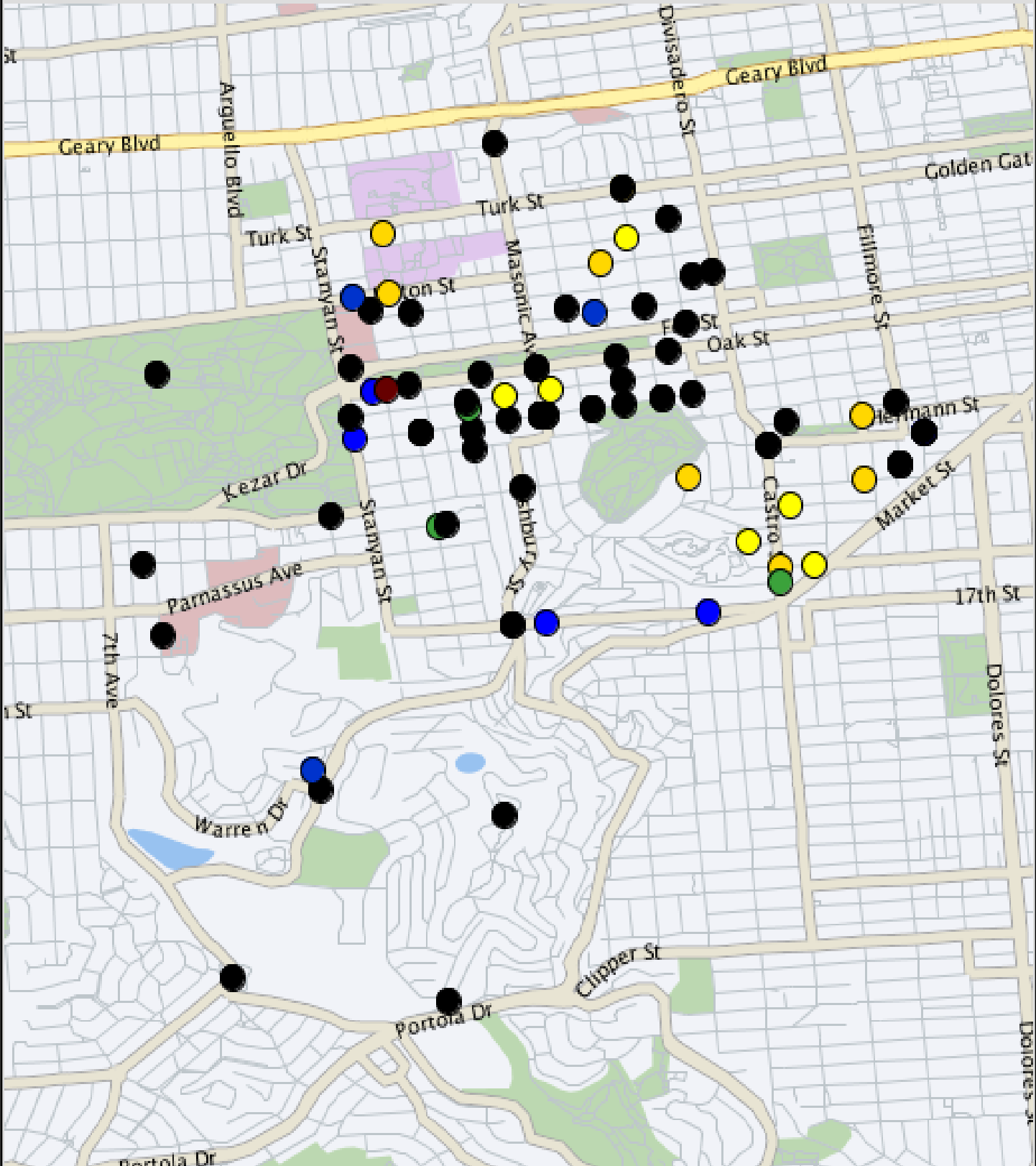
Theft from Locked Vehicle—Area of John F Kennedy Dr. /Conservatory Dr.—02/21/2018 4:10 pm

Incidents:

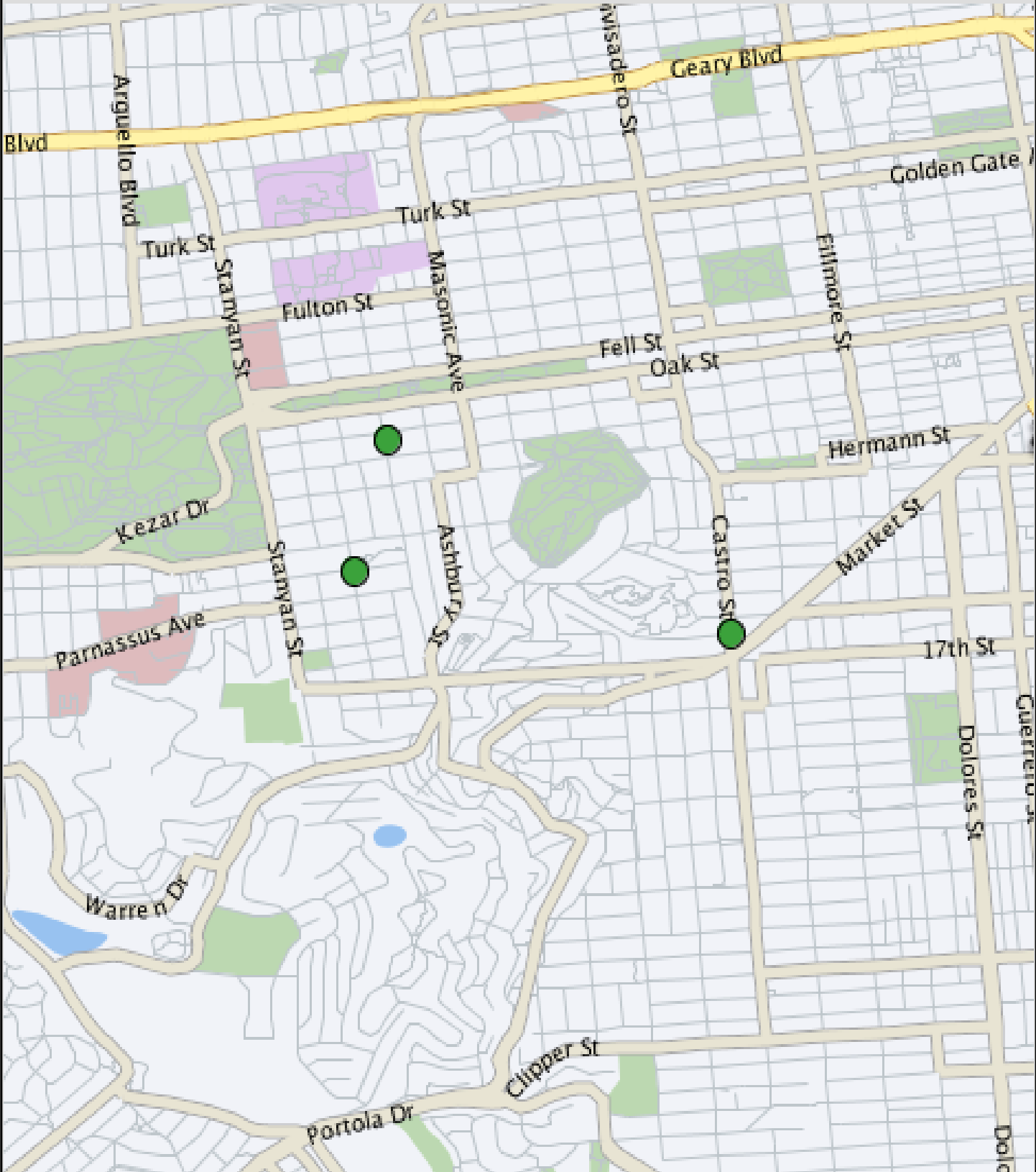

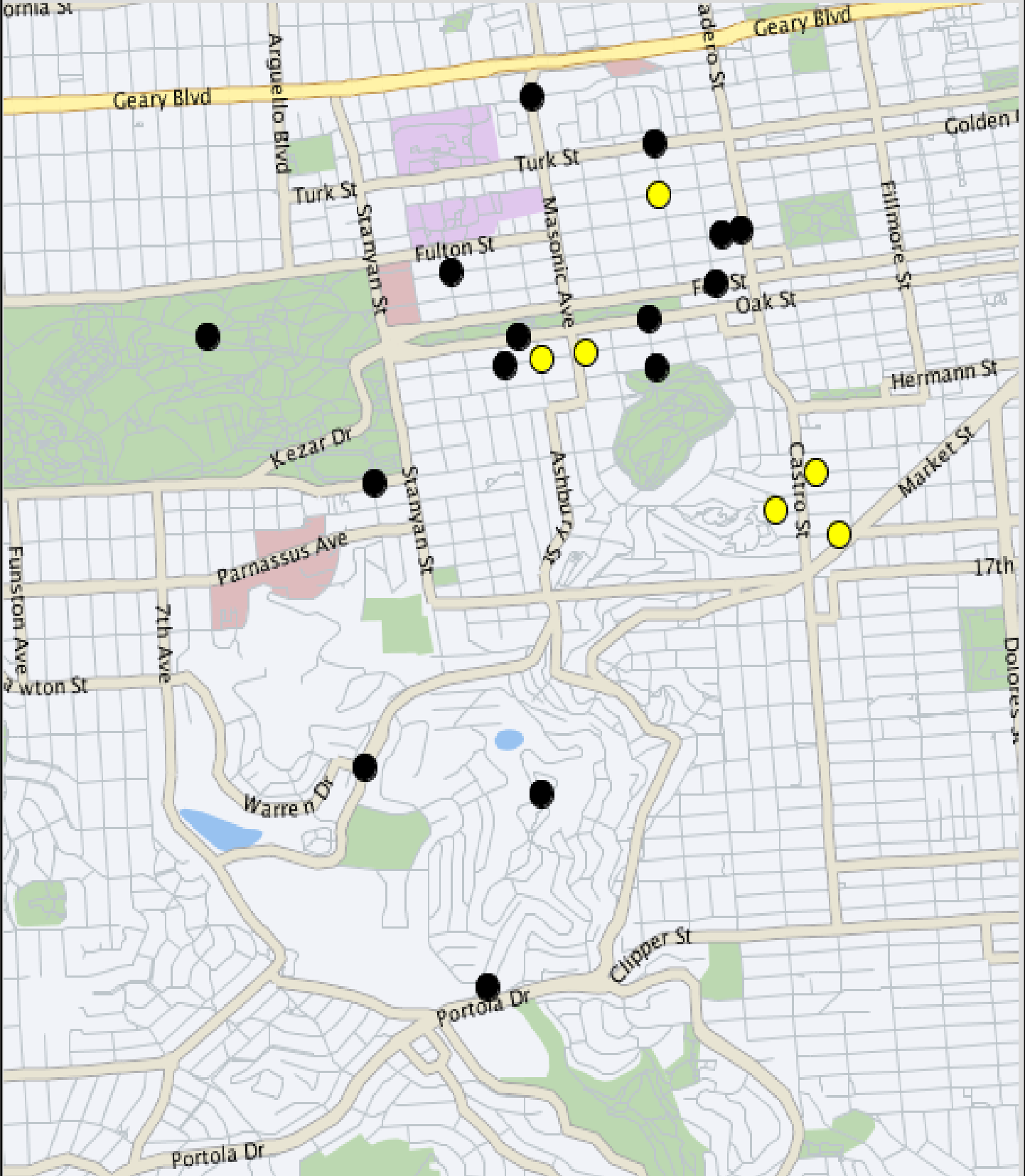

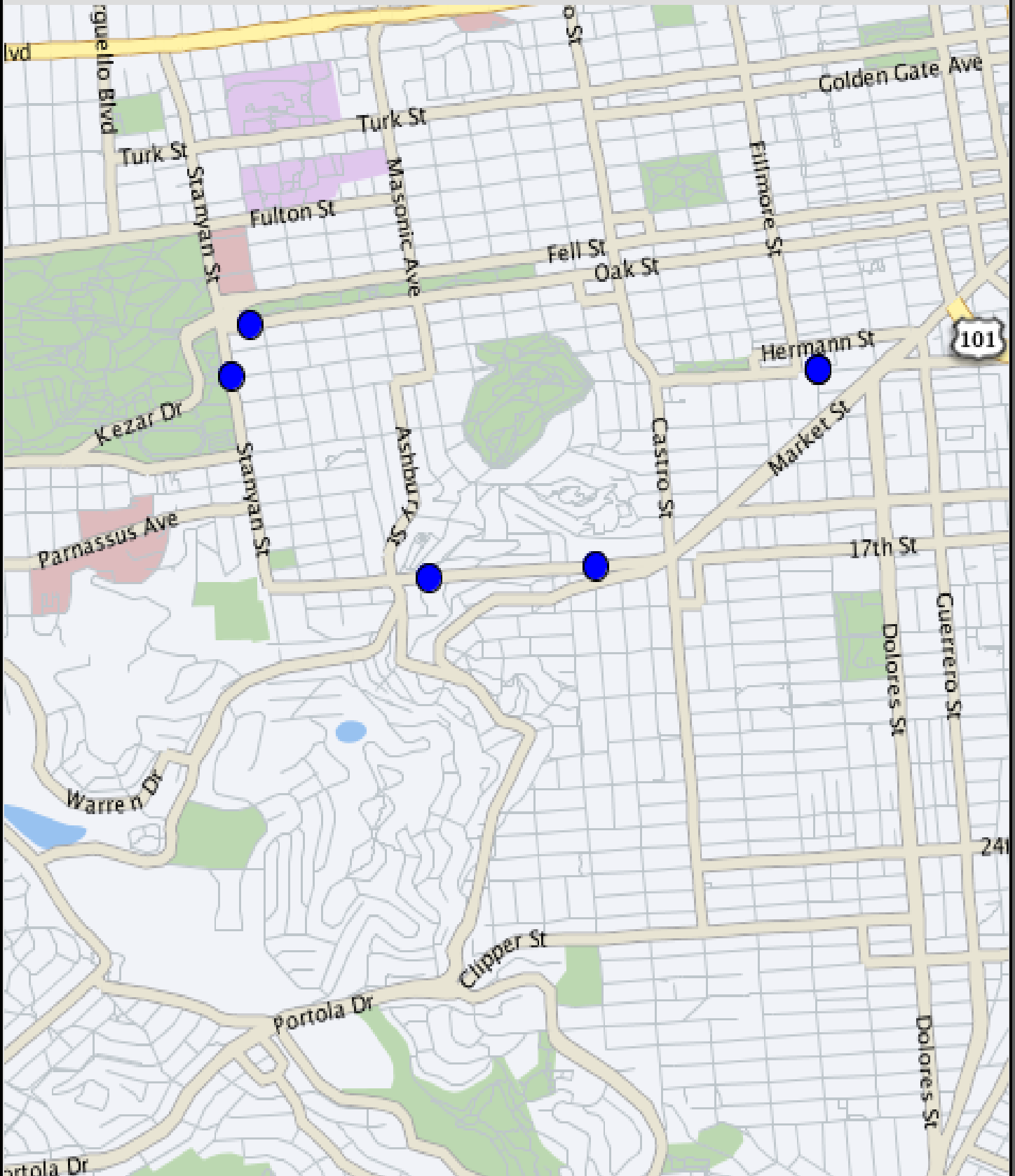
MAP OF CRIMES— VEHICLE INCIDENTS

HELPFUL TIPS**DON'T BE CAUGHT EMPTY-HANDED!!!!**

1. When placing an online or phone order, **request signed confirmation upon delivery**
2. Deliver packages to your office if at all possible; if not, deliver to a neighbor who will be home to sign for your package
3. If ordering from Amazon, use a self-service Amazon locker located throughout San Francisco; they will send you a notification email when the package is received. Go to Amazon.com and search for "Amazon Locker"
4. For U.S. Postal Service deliveries, you can authorize USPS to have certain deliveries left in a garage, with your neighbor, etc.; first you will need to create an account at USPS.com. Also check out "UPS My Choice" where you can log on to UPS.com and track your package to reroute, reschedule, or authorize a shipment release for your delivery. Get a PO box for deliveries for extra security
5. Shipping via UPS? Go online to UPS.com and search for "UPS Access Point"; neighborhood stores that will hold your packages for you
6. There are several apps available in San Francisco that allow you to ship to a package destination, and then will schedule the delivery to your home once you are available
7. Set up a delivery alert by email or text as to when your package has been delivered
8. Pay for insurance to cover the cost of the item shipped if lost, damaged or stolen
9. **Never let a package sit unattended on your doorstep**; package theft is very high in San Francisco.



COMMUNITY POLICE ADVISORY BOARD

We have continued to facilitate and sustain on-going dialogues with the members of the community to cultivate and expand the regional Community Policing Advisory Board (CPAB). CPAB has routinely contributed to facilitating many community events, discussions, and informal outreach with all members of the community. Since the onset of this larger project, we have held many community engagement events, which have been successfully facilitated by law enforcement personnel from Park Station with the assistance of members of CPAB such as: as “National Night Out”, the ‘Meet the Beat” neighborhood forum series, Community meetings, and the “Coffee with a Cop” outreach series . We have also promoted and provided updates on these CPAB-facilitated events in our station’s Newsletter, with upbeat and informative articles that describe the work of our officers alongside CPAB members. As mentioned previously, CPAB consists of senior leaders in the community who are invested in and committed to enriching the relationship between law enforcement and the community it serves. CPAB is an integral part of the dynamic evolution of this community engagement project.

These weekly and monthly events, which encourage all members of the community to participate and engage with Police, provide us with a direct opportunity to listen to people, and to hear their concerns and perspectives, which we in turn share with the committee for further review and consideration. Our commitment to community policing is enriched tremendously by these engagements and ultimately assist our goal in providing the highest level of public service and safety to the communities we serve.



WHO AND WHEN TO CALL?

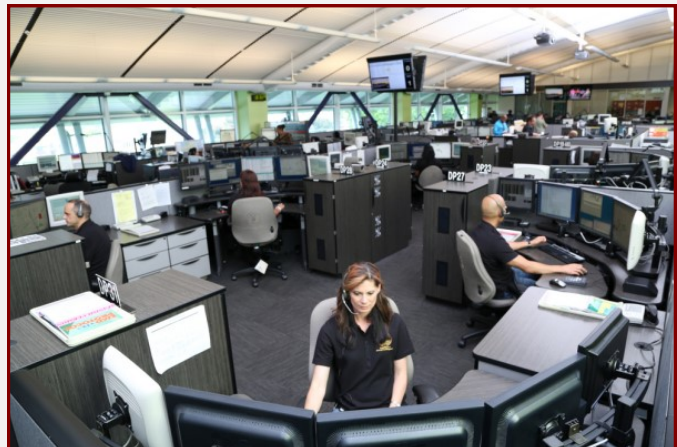
3-1-1: Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

Non- Emergency San Francisco Dispatch Line: Please call the non- emergency dispatch line **(415-553-0123)** when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, or a homeless/nuisance related issue. **The non-emergency line is for situations that require the police, but do not require an immediate police response.**

9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency. The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1.**

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our quarterly ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.
