## DEFINITION OF SUSPICIOUS ACTIVITY

**Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.**

### **Examples of Suspicious Activity:**

- ♦ **An individual peering into vehicles, to try and locate any valuables left unattended.**
- ♦ **An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.**
- ♦ **An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.**

## DEFINITIONS OF CRIME

**Robbery**– Robbery is the taking of property from another by using force or by using fear.

**Assault**– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

**Battery- (Misdemeanor battery)** is any willful and unlawful touching of another.

**(Felony battery)** is the use of force or violence upon the person of another that causes serious bodily injury.

**\*\*Assault is when a person swings their arm and battery is when that arm makes contact with another person. \*\***

**Aggravated Assault**– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

**Burglary**– The intent upon entry into a property to commit grand theft, petty theft, or any felony.





## DEFINITION OF COMMUNITY POLICING

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

**Homeless Outreach:** Richmond Station Officers coordinate with city agencies to provide assistance and offer City services as needed. The Officers handle quality of life issues and find programs for willing individuals.

**Foot Patrol:** Richmond Station has dedicated foot patrols on Clement St., Geary Blvd, Golden Gate Park as well as the Cliff House.

**Richmond Station Community Meetings:** Community Meetings are held once a month for the public and residents of the Richmond District to attend. People can voice their comments or concerns about issues in the Richmond District.



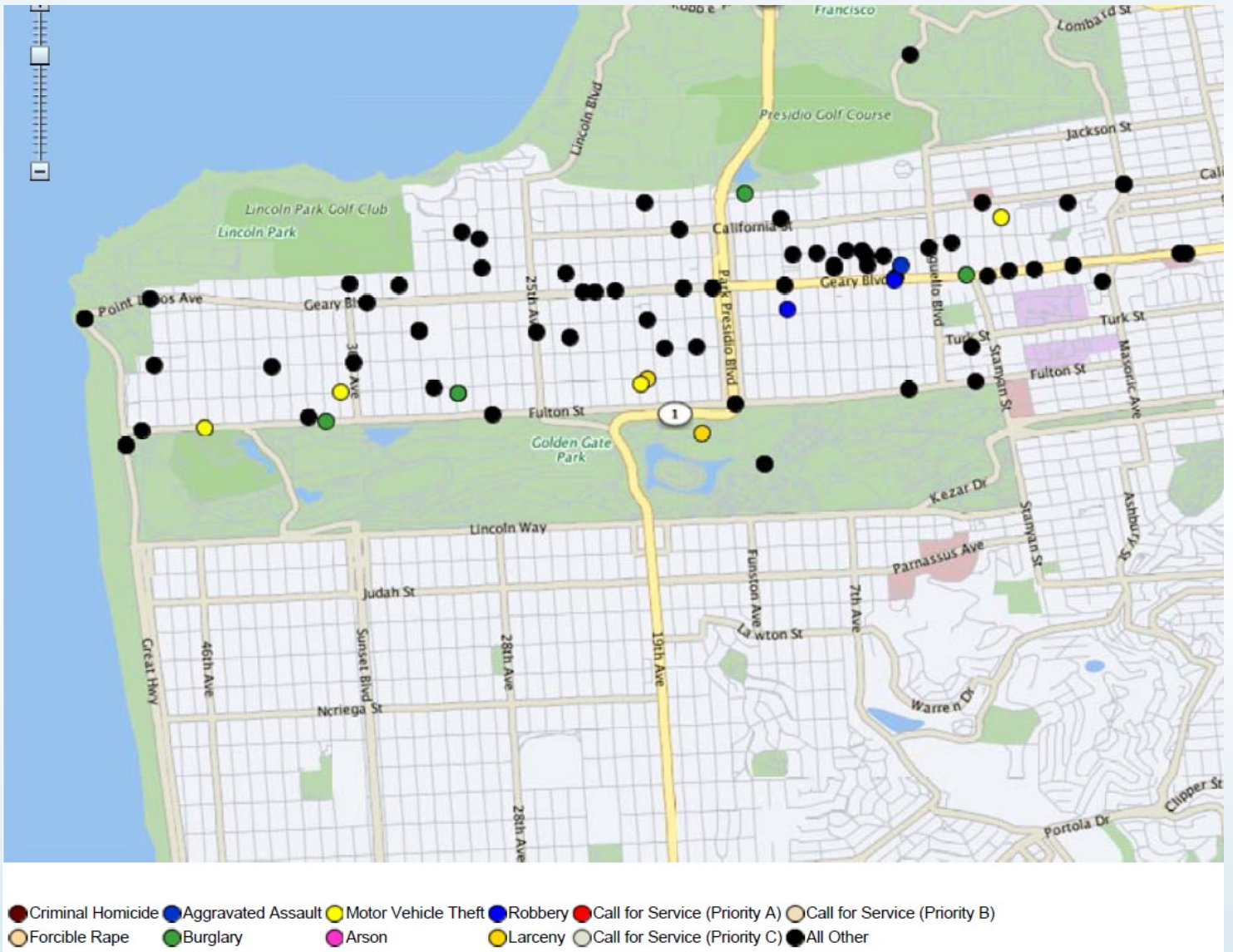

### **Assault on a Police Officer, Fighting in a Public Place, Drunk in Public (Arrest) 05/18/2018 0159 Hours Geary Blvd/ 3rd Ave**

Officers on patrol observed a large crowd of people around two subjects, who were in a physical altercation. Officers attempted to break up the fight, when the suspects turned on the Officers. An even larger crowd gathered. As an Officer was attempting to take one of the suspects into custody, the suspect picked up a metal frame barricade and attempted to swing it at the Officer. Additional units prevented the suspect from striking the Officer with the barricade. The Officer sustained injury during the fight and required medical treatment. Both suspects were taken into custody. Officers from neighboring districts responded as back up to help control the scene.

Suspect 1 was arrested and booked at County Jail One on the following charges: Assault, Resisting Arrest

Suspect 2 was issued a citation and released from Richmond Station of the following charges: Fighting in a Public Place, Resisting Arrest, Drunk in Public

### **Robbery with Force (Arrest) 05/15/2018 1500 Hours 3900 Block Geary Blvd**

The suspect was inside the Salvation Army Store. The victim witnessed the suspect quickly grab several items, walk past the manned registers, and exit the store without paying for the merchandise. The victim attempted to stop the suspect and a struggle ensued. The suspect struck the victim in the stomach 3-4 times with his right hand. A bystander assisted the victim and the suspect fled the scene. The bystander then followed the suspect and called police. Arriving units detained the suspect, and the victim positively identified the suspect. During an arrest search, suspected Marijuana was located in the suspect possession. The amount was determined to be in excess of 1 ounce.

The suspect was arrested and booked at County Jail One on the following charges: Robbery, Possession of a Controlled Substance, Committing a Similar Offense While out on Bail.

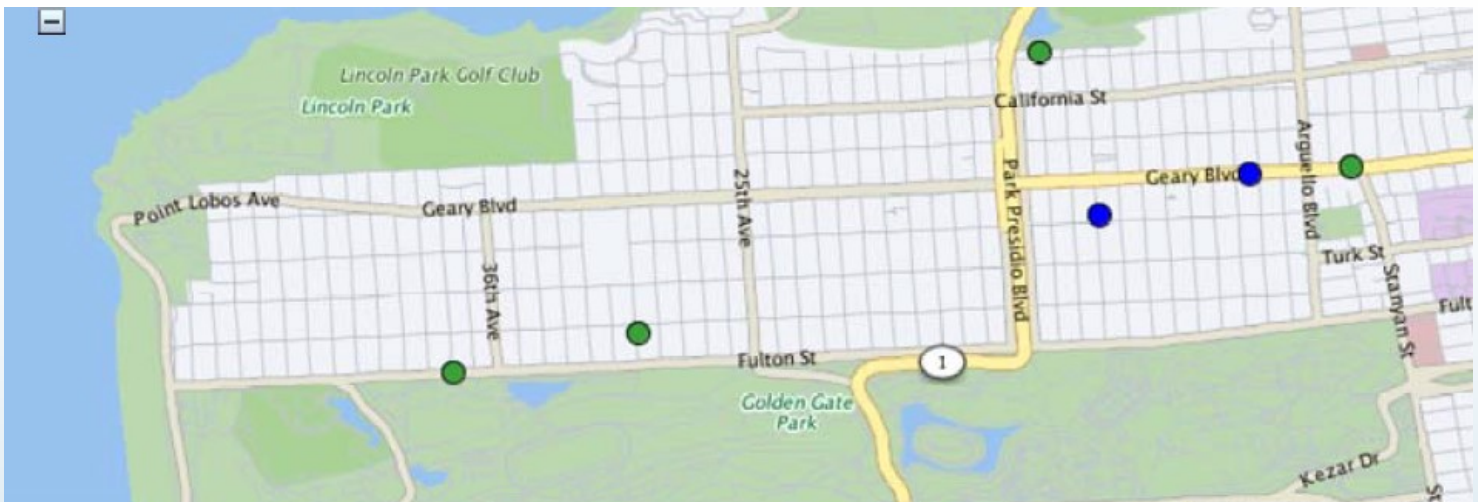

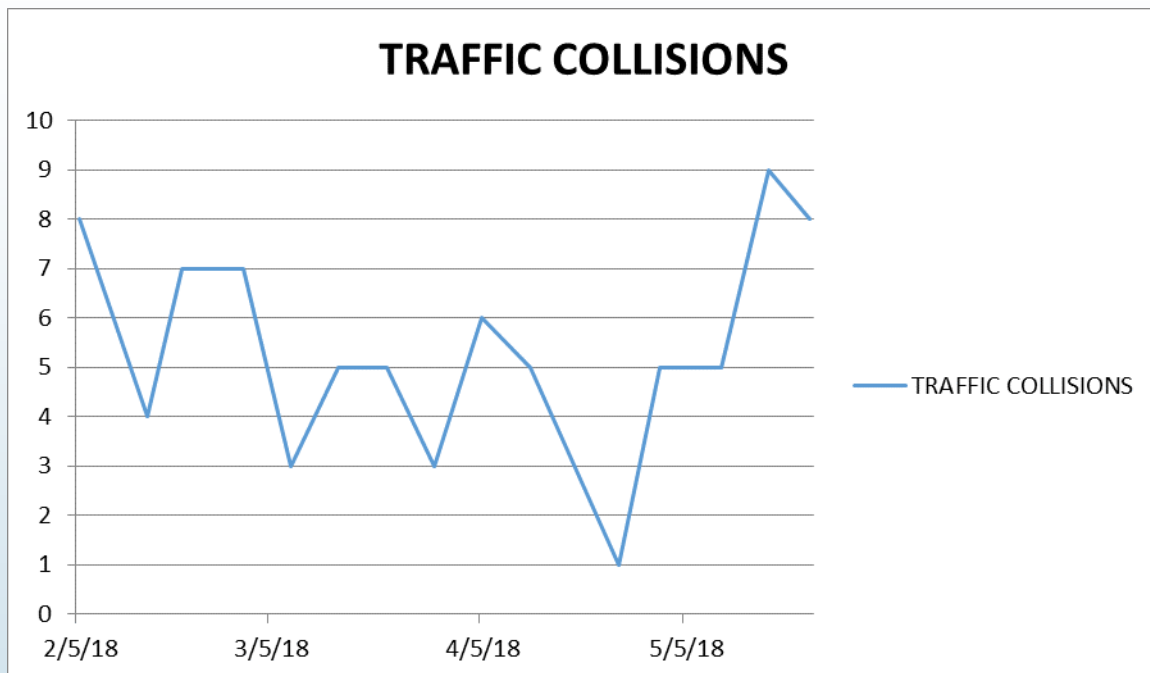

### **San Francisco Police Make Arrest in Cold Case Homicides**

On December 9, 1999 at approximately 7:00 PM, San Francisco Police responded to an incident in an apartment building on the 400 block of Bush Street. Former University of Nevada, Las Vegas (UNLV) swimmer Kameron Sengthavy, a 25 year-old male, was found deceased from apparent stab wounds.

On June 1, 2000 at approximately 7:00 AM SFPD officers responded to a gas station at Washington and Van Ness Streets where the body of a gas station attendant, Thomas Lee, a 60 year-old San Francisco resident was found shot by an unknown assailant.

Investigators from the SFPD Homicide Detail conducted investigations of these crimes. After exhausting all leads, these investigations were assigned to the Department's Cold Case Unit.

In early 2018, investigators from the SFPD Homicide Detail's Cold Case Unit developed information that led to the identity of the suspect in these two homicides. The suspect was determined to be a Donovan Ray Lacy, a 38 year-old male.

Lacy is currently serving time in a Florida prison for several bank robberies he committed in that state. Lacy, however, had previously lived in the Bay Area and was brought back to Marin County to stand trial for several bank robberies that occurred in 2012 and 2013. In January of 2014, Lacy was convicted on the Marin County bank robbery charges and was sentenced to 105 years in prison. Following his sentencing in Marin County, Lacy was transported back to Florida. A booking photo of Lacy from Marin County Sheriff's Office accompanies this news release.

SFPD investigators gathered evidence and developed probable cause to charge Lacy with the murders of Sengthavy and Lee. An arrest warrant has been issued charging Lacy with two counts of homicide. Lacy is expected to be extradited to San Francisco to stand trial for the murders.

Upon conclusion of the San Francisco murder trials, Lacy is expected to return to Florida to finish out his nine-year sentence for bank robbery. He would then be transported back to Marin County and serve out his 105-year sentence for the 2012 and 2013 bank robbery convictions.

While an arrest has been made in these cases, they remain open investigations. ### DUI Saturation Patrols This Friday

San Francisco Police Department's Traffic Unit will be conducting DUI saturation patrols this Friday, May 25, 2018, between the hours of 7:00 P.M. and 3:00 A.M. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely.

Officers will be looking for signs of alcohol and/or drug impairment by checking drivers for proper licensing, delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving. Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000, not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to the San Francisco Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to 'Report Drunk Drivers – Call 9-1-1'.

## Types of Crime Reports That Can Be Filed Online:

- **Harassing Phone Calls:** When you are experiencing annoying calls - with no known suspects; for example, hang-ups or heavy breathing.
- **Lost Property:** When property has disappeared and not stolen. If you think it could have been taken but you have no idea by who, you may enter the report online.
- **Theft:** When property is stolen but there has been no illegal entry or contact by the thief.
- **Vandalism/Graffiti:** The act of changing, modifying or defacing public or private property, including graffiti.
- **Vehicle Burglary:** When property was stolen from a vehicle.
- **Vehicle Tampering:** Tampering with a motor vehicle, including vandalism/graffiti of the vehicle.

## Calling the Police:

**Dispatchers ask questions in a particular order for a reason. It is best to stay calm and answer all questions to the best of your ability.**

Complaint: **Location, Hazards (ie. weapons at scene), Victim info (sex, age, condition)**

Suspect Description: **Gender, Race, Age, Clothing, distinguishing features**

Vehicle Description: **Color, Make, Model, License Plate, distinguishing features**
