Release of Police Reports under CA Family Code § 6228 - New Forms

The purpose of this bulletin is to announce the release of new forms to comply with CA Family Code §6228 provisions listed in Department General Order 3.16, Release of Police Reports, adopted by the Police Commission on December 12, 2018. These forms will be processed by Crime Information Services Unit (CISU) and Special Victims Unit (SVU).

List of new documents:

- SFPD Form 591, Request for Incident Report: Family Code §6228
- SFPD Form 592, Notice of Good Cause for Delay (Internal form)

The new forms are attached to the bulletin and available to members on the SFPD Network. Intranet site.

Upon request, members can provide SFPD Form 591, Request for Incident Report: Family Code § 6228, to a member of the public but should instruct the requestor to submit the form to CISU for processing.

Members assigned to the Airport Bureau shall follow San Mateo County requirements for release for police reports.

Any questions or clarification regarding this policy should be made to sfpd_writtendirectives@sfpov.org who will provide additional guidance about the directive.

Under CA Family Code § 6228, incident reports requested by a victim or his or her representative for the alleged crimes of domestic violence, sexual assault, stalking, human trafficking, and abuse of an elder or dependent adult are entitled to receive copies within flive working days of the request, unless good cause for delay exists. If good cause exists, reports shall be released no later than ten working days after request is made.

- Any current identification including, valid driver's license, SF City ID eard, a state-issued ID eard, or a passport.
- A guardien shall also present a copy of his or her letters of guardienship.
- An attorney for the victire, shall present ID and written proof that he or she is the attorney for the victire.
- A conservator of the victim shall present ID and a copy of his or her letters of conservatorship.
- A personal representative (parent, guardian, adult child or adult sibling) of the victim, if victim is alive and not the subject of a conservameship, shall present ID and a written authorization, signed by the victim.
- A representative of a victim who is decreased, shall present a certified copy of the death certificate or other satisfactory evidence of the death of the victim at the time the request is made.
- If a victim is unable to provide photo ID at the time of the request, the Department, in its sole discretion, may provide the victim with a ongy of an incident report if they can provide other satisfactory evidence of their identity.
