# Ofc Joel Hornstein



Ofc. Hornstein joined the San Francisco Police Department on October 30<sup>th</sup>, 2006 and has worked at Ingleside Station for the past 10 years. Formerly a paramedic and currently a Field Training Officer, he brings his top skills in both policing and patient care to the late day shift. He has recently been awarded a Silver Medal of Valor for heroically rescuing an elderly person from the 5-alarm 29<sup>th</sup> & Mission Street fire. He also earned a life-saving award for saving the life of a person choking at the Nugget Rib Cook-Off in Sparks, Nevada. Whether on-duty or off-duty, he brings calm to the chaos.

In addition to these significant events, he proactively responds to our community's everyday call for service and events needing police attention. Ofc. Hornstein and his partner responded so quickly to a residential burglary in progress call in Visitacion Valley, that they observed the suspects and pursued them on the freeway and down Tunnel Road in Brisbane.

A woman taking photos at a Bernal Heights' parking lot lost her expensive camera to a thief. The victim told Ingleside Officers Quinlan and Canady that the suspect exited a white VW van, grabbed her camera after a brief struggle, ran back to the van which then sped away. A man walked into Ingleside Station to report a car burglary. He said clothing, musical instruments, and other items were taken from his car parked on Ocean Avenue. He also had video of the burglary as well as three suspects getting into a Chevrolet and fleeing the scene. A crime alert was issued and Ingleside Officer Burke found the Chevrolet parked in the 200 block of Edna where a known subject lived. The officers conducted a probation search of the home and did not find any of the stolen items. However, they did find several items including ammunition and window punches which he was prohibited from possessing. He also admitted that he was the driver of the getaway car involved in the theft. He was arrested and taken to Ingleside Station for booking. Report number: 190608772

**6:26pm      100 Blk. Loehr      Possession of a Firearm**

Ingleside Officer Zahn obtained information about a suspect who was in possession of a firearm. The suspect was prohibited from owning or possessing firearms. Later the same day, Sgt. Lopez, Officers Downs, Burke and Zahn located the subject inside his vehicle, and he admitted to possessing a firearm inside of the vehicle. They also found ammunition and a small amount of MDMA narcotic in the car. He was arrested at the scene and transported to the County Jail on several felony charges. Report number: 190609639

A woman walking down the street was suddenly approached by a suspect who took her cellphone. She yelled, "He stole my phone" and a neighbor ran out of his garage and chased the suspect for several blocks before abandoning his pursuit. A road rage incident resulted in one of the driver's arrested on a variety of charges. Ingleside Officers Parker and O'Driscoll responded to the scene and found two vehicles and two angry drivers. After interviewing both men and several witnesses, they determined that one of the drivers twice rear ended the other motorist and, after the second collision, got out of his car and punched the victim in the face several times and also pepper sprayed him. He was arrested at the scene and eventually transported to the County Jail. Report number: 190605251

A man was transported to the hospital after being punched in the face by an unknown assailant. The victim told Ingleside Officers Labson and St. Clair that he was standing outside a store, talking on his phone, when an unknown man came up from behind and punched him in the eye. The driver refused to give his real name and provided the officers with several false identities. When he finally surrendered his real name the officers found several warrants for his arrest from South San Francisco, and Colma for narcotics and vehicle code violations. A woman left her home and noticed a car parked in her neighbor's driveway that she hadn't seen before. She was suspicious and those suspicions were proved correct when she returned home and saw masked men exiting her home and running to the parked vehicle. The car sped away and the woman found several rooms in her home ransacked. She called police and Ingleside Officers Ramirez and Prieto responded and broadcast a description of the suspects and the vehicles. Report number: 190602796

A dispute among residents of a home resulted in one of the residents being booked for arson. Ingleside officers Labson and St. Clair were dispatched to the scene of a small garage fire. SFFD units were already on scene. Witnesses and a victim said the suspect was angry about some previous incident and threatened to burn the house down. He set fire to paper inside a bucket in the garage. It was quickly extinguished by another resident. The officers, after interviewing several witnesses, arrested the suspect for arson and transported him to the County Jail for booking. Report number: 190601914

**11:48pm      Unit Blk. Wabash Terrace      Warrant Arrest**

Several neighbors called police to report a suspicious man peering into vehicles on the street. Ingleside officers Parker and O'Driscoll responded and found the suspect standing next to a vehicle on Wabash Terrace. A computer search revealed he was wanted on a \$10,000 warrant for failure to appear in a previous court case. He was quickly placed in custody. A search of his clothing revealed a pipe used to smoke methamphetamine. He was transported to the County Jail for booking. Report number: 190602291

#### Serious Incidents:

**3:28pm      S.F City College      Suspicious Occurrence**

San Francisco Community College Police Officers Victorino and Sandhu were dispatched to a report of a suspicious man peering into vehicles at one of the school's parking lot. They found the suspect who denied peering into vehicles although he possessed an emergency tool used to break windows and escape a vehicle if trapped inside. The officers did not find any vehicles damaged in the lot and released the suspect at the scene. Report number: 190601544

Another incident involving reports of a suspicious man walking around peering into parked cars. Ingleside officers Ahern and Mar responded and found a suspect who matched the description provided by neighbors. **Evading Police**

A simple traffic violation turned into a dangerous event involving an intoxicated driver endangering her young child. It all started when Ingleside officers Mar and Ahern observed a woman driver of a BMW SUV ignore the stop sign at Persia and Moscow streets. The officers pulled in behind the vehicle, activated their red lights, and stopped the driver. They asked for her license, insurance, and registration. She said she didn't have any. The officers asked her to turn off her engine to which she responded, "no". The suspect then put the car in gear and sped off endangering the safety to others, herself, and the young child in her vehicle's car seat. The officers boarded their patrol car and attempted to catch up to the driver. Within a few minutes the suspect had collided with another vehicle at Naples and Brazil, the female driver jumped out of her SUV, and was running away carrying her infant daughter. She was soon apprehended and placed under arrest. A computer check revealed she was unlicensed. She was charged with several vehicle code violations, with endangering her child, evading an officer, and DUI. Several occupants of the vehicle hit by the suspect had to be treated for injuries at San Francisco General Hospital. Report number: 190596133

**Battery**

Ingleside officers Jensen and McCall were dispatched to investigate a report of a man attacked at a bus stop. When they arrived they found the victim bleeding from wounds to his face and nose. He told the officers he was waiting for a bus when a red car stopped, several men jumped out of the vehicle and started punching him in the face. After the attack, they got back in their car and sped away. The victim told the officers he did not know the attackers or any reason for the attack. He was transported to the hospital for treatment. Ingleside officer Carew was dispatched to a report of a woman who just kicked in the window of business. Witnesses said the woman appeared to have an altered mental state and was yelling during the incident. Witnesses also said the suspect ran to a waiting Muni bus which traveling toward downtown. Officer Carew broadcast a description of the suspect to surrounding units. The business owner estimated the damage to the window at \$3000. Report number: 190594240

#### **8:00pm      1600Blk. Sanchez      Hot Prowl Burglary**

Another resident lost property to a thief using a common method to open garage doors. The victim lost three expensive bicycles to a suspect or suspects who broke a window on the garage door and used an object to pull the emergency cord on the garage door motor. Pulling the cord enabled the suspects to open the garage door and gain access to the garage and the home. Ingleside officers Cvetovac and Ticzon responded to the crime scene and alerted the station investigative team to the theft. Report number: 190596569

# Glen Park News

The following 4 commercial burglaries have occurred in the Glen Park neighborhood in the past week:

- 1) 7/21 overnight to 22, Destination Baking Company, 598 Chenery St. 190-529-930
- 2) 7/21 overnight to 22 - Higher Grounds Coffee - 691 Chenery St. 190-529-974
- 3) 7/25 overnight to 26 - Glen Park Hardware - 685 Chenery St. 190-541-940
- 4) 7/25 overnight to 26 - Gialina's Pizza - 2842 Diamond St. - 190-541-978

The MO appears to be the same: kicking in the front door of the business and taking the cash register. One register was recovered and is being processed by our Crime Scene Investigations Unit. The exact times of the incidents are not clear, however, based upon the locations of these businesses, they likely happened in the very early morning hours on the 22nd and the 26th, respectively.

While it's really helpful to capture the incident on video, it's also REALLY helpful when we can capture the suspect(s) driving/walking to and/or driving/walking from the burglary.

Here's where you come in: If you happen to live in the neighborhood of these incidents, and you happen to have a camera that faces the street, would you please check the video to see if there is footage of the suspects going to or coming from this incident either on foot or in a vehicle? Anything you could find would be most helpful.

In the meantime, we are scouring the neighborhood for witnesses and evidence, coordinating with our citywide Burglary Detail to determine patterns and likely suspects across police district boundaries, and have briefed all of Ingleside's night shift officers to this crime "hotspot" location.

San Francisco SAFE, our prevention partner, along with Ingleside Station, will be meeting with these businesses to consult regarding security best practices, including lights, cameras, burglar alarms, etc.--anything that will help to dissuade, prevent, and/or rapidly detect criminal activity with these or any other businesses in the neighborhood. The only other reminder is that if people see something to please say something; all in-progress suspicious behavior should be reported to 911, so that our dispatchers can prioritize and coordinate a rapid response to suspects casing or attempting to break into our businesses.

Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



## What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

### Ways To Become An ALERT volunteer:

1. Graduate the SFPD NERT course (<http://sf-fire.org/neighborhood-emergency-response-team-nert>), or,
2. Graduate the SFPD Community Police Academy course (<https://sanfranciscopolice.org/community-police-academy>)
3. Pass a basic DOJ/FBI Background check.
4. Sign up for the next 8 hour ALERT new volunteer training class.

# Muni Subway Closes Early for Critical Maintenance

The SFMTA maintenance crews work hard every night after Muni Metro subway service hours to maintain the tracks and equipment underground. On most nights, this gives them only about two hours to get work done. In order to complete critical maintenance tasks that cannot be completed during normal windows, we are planning two weeks of early subway closures, so crews have more hours each night to do this vital work.


**DETAILS:**  **STARTS THIS MONDAY, AUGUST 12TH**

Starting August 12 and continuing for approximately two weeks, the subway between Embarcadero and West Portal will close early at 9:30 p.m. When the subway closes early, buses will run above ground to connect all stops, beginning at 9:30 p.m. through the normal end of train service at 1 a.m. Owl service will remain unchanged. Trains will start regular morning service each day.

### TRANSIT SERVICE PLAN - 9:30PM TO END OF NORMAL SERVICE AT 1AM

-  Shuttle buses will serve all Muni Metro stops between Embarcadero/Brannan and St. Francis Circle
-  Train service between Balboa Park and St. Francis Circle
-  Buses will run between Embarcadero/Brannan and Zoo. No L trains running.
-  Train service between Ocean Beach and Church/Duboce (Inbound N trains become outbound N trains at Church/Duboce)
-  Train service between Balboa Park and Church/Duboce (Inbound J trains become outbound J trains at Church/Duboce)
-  Train service between Sunnydale and Embarcadero/Brannan

### CUSTOMER INFORMATION:

- Inbound N Judah and outbound J Church trains will use the accessible stop entering the Duboce Portal to serve passengers needing the ramp.
-  For service on Market Street, Muni customers can board bus shuttles at a bus stop marked with the half-moon sign.
- Muni customers are encouraged to leave extra travel time during subway closures.
- Regular bus fares will apply on bus shuttles and valid transfers will be accepted.

The extended window will give us an opportunity to do complex work aimed at making subway operations more reliable and prevent future breakdowns.

An additional early shutdown window is planned for December.

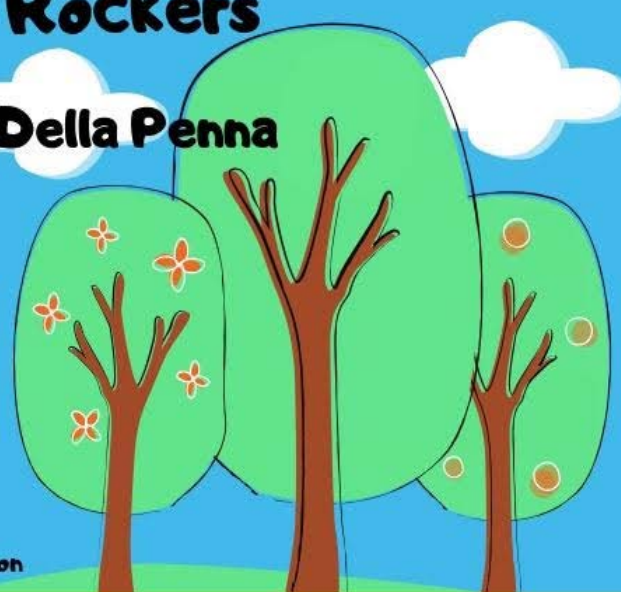

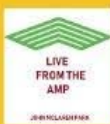

### **San Francisco Police Investigators Seek Public Assistance to Solve a Fatal Hit and Run**

On August 4, 2019 at approximately 11:56PM, San Francisco Police officers assigned to Bayview Station responded to Carroll Avenue and Arelious Walker Drive to check on the wellbeing of a person.

Upon arrival, the officers met San Francisco Fire Department personnel who were already on scene and tending to a 59 year-old male victim who was found in the middle of the street. The victim was transported to Zuckerberg San Francisco General Hospital (ZSFGH) where he later died.

The San Francisco Office of the Chief Medical Examiner (OCME) conducted an investigation and determined that the victim's injuries were consistent with being struck by a motor vehicle. The victim, Bruce Romans, was 5'08", 153 pounds and was wearing a dark jacket and blue jeans at the time of the incident. Investigators from the SFPD Traffic Collision Investigation Unit (TCIU) are seeking public assistance in solving this case.

Anyone who was in the area of Carroll Avenue and Arelious Walker Drive on the evening of August 4<sup>th</sup> and recalls seeing the victim, or a vehicle driving either erratically or with body damage is asked to call the SFPD 24-hour tip line at 1-415-575-4444 or Text a Tip to TIP411 and begin the text message with SFPD. You may remain anonymous.

### Project Description

S.F. Public Works has partnered with the San Francisco Public Utilities Commission to complete infrastructure improvements along Alemany Blvd. between Seneca Avenue and Congdon Street. Public Works will manage the project and we've hired D'Arcy & Harty Construction, Inc. to complete the work.

Construction is scheduled to begin in late June 2019 with completion expected in December 2020.

This project will include sewer main replacement, street base repairs, curb ramp and bulb-out installation, minor traffic signal work at the Santa Rosa Ave. and Silver Ave. intersections and repaving between Congdon Street and Seneca Avenue. Please note, not all blocks will include sewer main replacement work. Please visit our project webpage for additional information on which blocks will include sewer work.

Sewer service will not be interrupted during construction. Please continue to use your household plumbing per the usual.

Once the sewer work is complete, crews will begin preparations to repave the street. Preparations will include installation of curb ramps and bulb-outs followed by street base repairs. Street base repairs will require the contractor saw-cut sections of the roadway, remove the broken concrete and pour back fresh concrete. Replacing the street base now will improve the longevity of the new asphalt road.

Since there are several blocks included in this project, it may be weeks or months before we reach your block. We are sending you this notice in advance of any work on the project.

### Neighborhood Tip:

Please call 3-1-1 to report any issues in the neighborhood such as potholes, burnt-out traffic signals or streetlights, leaky fire hydrants, broken curbs or sidewalks, illegal dumping, etc. 311 is the primary customer service center for the City of San Francisco. They'll route your concern to the appropriate agency for follow-up.

### Impacts and Restrictions

Street parking may not be possible on the block during construction work hours. In some cases, parking may not be possible on part of the adjacent block as we taper the traffic lanes to accommodate the work zone. Please see posted barricade signs for exact work hours, days, and locations, because they may vary depending on the construction task. The "no parking" signs will be posted at least 72 hours in advance to alert motorists of parking restrictions.

Vehicles parked in the construction zone during the posted work hours will be towed at the vehicle owner's expense. Please allow extra travel time during construction work hours.

Street cleaning restrictions will still be in effect.

We apologize for the inconvenience and thank you for your patience as we work to improve San Francisco.

## Distracted Driving

Distracted driving is anything that takes your eyes or mind off the road. In the smartphone age, distracted driving is the most dangerous when drivers are using their cell phone behind the wheel.

Whether it is talking, emailing, texting, plugging in directions, using an app or scrolling through social media feeds, using a cell phone is not only dangerous, but also illegal.

In 2017, 3,166 people were killed in distracted driving related crashes across the country, or nearly 10 percent of all traffic deaths.

Using a phone to dial, talk or text triples the risk of a driver getting into a crash. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for an average of 5 seconds. At 55 mph, that's like driving the length of a football field with your eyes closed.

Other serious driver distractions such as eating, grooming, reaching for objects on the floor, changing clothes or talking with passengers are just as dangerous. The safest thing drivers can do is put down the phone, focus on the road and just drive.

- ✓ Pull over to safe parking spot to make a call
- ✓ Don't text or call someone you know is driving





## Cell Phone Law

 Holding a phone while driving is illegal. Any electronic device must be used in a hands-free manner, such as speaker or voice commands. The law applies when at a stop sign or signal.

 To use a phone while driving, it must be mounted on the dashboard, windshield (seven-inch square in lower right corner or five-inch square in lower left corner), or center console.

 When the phone is mounted, drivers can swipe or tap the screen once to activate or deactivate a feature. It is illegal to swipe multiple times, enter information or text.

 A first offense ticket is \$162, with additional offenses costing even more.

 You may use your phone while holding it for true emergencies, like calling 911.

## Ability to Pay in San Francisco Traffic Court

If you cannot afford to pay your ticket, you have a right to ask the traffic clerk or judge to consider your financial circumstances.

The court will look at your financial information, and then will decide whether to:

1. **Reduce** Your Fine, and/or
2. Offer you **Community Service**, and/or
3. Offer you an Affordable **Payment Plan**

I can't afford to pay for my traffic ticket.



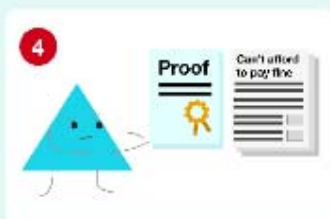
Any time after you have been found guilty of a ticket, you can request the court to reduce your fine because you can't afford it.



The court will give you a form called **Can't Afford to Pay Fine (TR320/CR-320)** so you can explain why you can't afford to pay.



Provide as much detail as you can on the form about your income, expenses, why you can't afford to pay, and what you would like the court to do.



Attach documents showing your income and expenses, or explain on the form why these documents aren't available. Submit your form to the court.



The court will read it and let you know the decision by mail. Check with the court if you haven't heard back after 30 days.



If you've had a change of circumstances or need to provide more info about your situation, you may submit another request.
