

As police officers serving within the City of San Francisco, we are constantly placed into situations that demand both action, and at times, inaction for the protection of our citizens' First Amendment rights. When our officers take to the streets donning their body worn cameras, they are expected to exercise discretion by turning their cameras on to capture public contact relating to criminal activity. These same officers are also expected to deactivate the equipment should they be in position to record First Amendment conduct. As police officers, we know that everything we say or do is in furtherance of the public trust that we have been graced to protect.

This Saturday, January 26th, Northern Command will facilitate the 2019 Walk for Life event which begins with miscellaneous public speakers in Civic Center Plaza and concludes with a large scale march down Market Street. Protest groups are expected to also place themselves along the event's route and will be given the ability to also exercise their freedom of expression. The mission of all of the police officers assigned to the event is the safe facilitation of open expression and assembly in the exercise of these freedoms.

Every week, it is an honor for the men and women of the SFPD to protect and serve the citizens of San Francisco.


## Safety/Awareness Tips



The 2019 San Francisco Chinese New Year Parade will be held on Saturday, February 23, 2019. The parade, begun in the 1860's as a means to educate the community about Chinese culture, is the largest such lunar year celebration in the country and one of San Francisco's most popular and well-attended events.

With huge crowds expected, including guests from all over the world, public safety is the San Francisco Police Department's number one priority. There will be a significant police presence during Lunar New Year activities, with both uniformed and plainclothes officers on duty to monitor public events. 

### **INCIDENT RECAPS**

On 1/17/19, Officers responded to a call regarding an assault with a metal pole. Upon arrival, a bystander Yelled, "He's over there" and pointed in the direction of the subject. Officers broadcasted the subject's description and summoned an ambulance for the victim. Officers successfully located the subject nearby, leaving the scene, while pushing a shopping cart.

As officers were placing the subject in handcuffs, a witness approached them and identified the subject as the one who hit the victim in the head. The witness stated that he was looking out his window when he saw approximately three transient males (including the subject) in a verbal argument. Witness then saw the subject get into a physical fight with two male subjects. While this was occurring, (RV1), who was sitting in his wheelchair, was not involved in the physical struggle or verbal argument. After the physical struggle ended, the subject grabbed a pole and poked (RV1) in the back with it. The subject then raised the pole over his head and forcefully swung the pole one time, striking (RV1)'s head. The witness stated that the assault was completely unprovoked. The subject then walked away from (RV1), westbound on Geary Street. The witness stated that the subject threw the pole in the middle of the street. The pole was picked up by an unknown male. The witness pointed at the unknown male who was sitting in front of 1001 Polk Street, identifying him as the person who had taken the pole. Officers seized the pole from the unknown male.

Officers then conducted a reverse cold show with (RV1), who positively identified the subject as the one who had hit him. The subject refused to speak with officers about the incident and was subsequently booked without incident.

On 1/20/19, (RV1) informed Sergeants that he received a text message from an unknown male subject on 01/17/2019. The male subject identified himself as a friend of the suspect who had possession of (RV1)'s belongings. The subject texted (RV1) pictures of his Japanese ID CARD and envelope that contained his Rose American Express Credit Card. The subject stated that the suspect had all his identification cards, credit cards, and computers. The subject further provided the suspect's name and that he was staying at the Sweden House located at 570 O'Farrell Street. A records check on the suspect revealed that he had an outstanding felony warrant for his arrest. Northern Street Crimes Unit went to 570 O'Farrell Street and saw BOWEN walking down the stairs to exit the Sweden Hotel. The officers placed the suspect under arrest for his Warrant and located various items belonging to numerous victims (including RV1); see SFPD Warrant Arrest Case #190-044-938. On 01/20/2019 at 0924 hours, (RV1) received text messages containing a picture of his stolen wooden box from the subject. The subject asked (RV1) if they could meet so he could retrieve the wooden box for him from his storage unit. Sergeants directed (RV1) to tell the subject that his roommate could meet him. The subject agreed to meet at his storage unit (Extra Space) located at 190 Otis Street at 1330 hours. The subject identified himself and sent photos of himself. At 1239 hours, the subject changed his mind and texted (RV1) that he would no longer be able to meet him today. He further stated, "I'm already on greyhound." Northern Street Crimes unit responded to 190 Otis Street and located the subject along with two other suspects (who were cited and released from Northern Station).The subject took the assigned sergeants to his storage unit to provide them the victim's stolen wooden box. The subject surrendered the wooden box without its cover and stated that the cover was somewhere in the unit, however, he declined to provide permission to search his storage unit for the cover or additional stolen property. As officers were transporting the subject to Northern Station, the subject asked to remove a black wallet from the interior breast jacket pocket. The subject claimed the wallet belonged to a friend and requested to leave it behind for the friend. Officers checked the wallet and found a forged driver's license, among other fraudulent items, and confiscated them for evidence. The subject denied any involvement in the initial burglary and refused to provide any additional information.
