Captain Joe Engler's Message

Residents, Merchants, and Visitors,

Private trespass, otherwise known as 25 MPC (San Francisco Municipal Police Code), is the section to be used to create an area of safety around homes and businesses.

Northern Police Station officers assigned to the several foot beats have been distributing the yellow colored signs to merchants and residents within their assigned areas to create an additional enforcement tool against trespassers and loiterers. The signs are to be posted in a conspicuous location which is in plain view of would be trespassers. These posted signs, which are enforceable for 12 months from the date of posting, are used to issue both infractions and misdemeanor citations to persons remaining upon properties without the owner's consent. Repeat offenders can be booked into the County Jail for a continuing offense when they refuse to vacate a posted location.

A full page copy of the 25 MPC "No Trespassing" document has been included within this newsletter. To be enforceable, a person should make two copies of the yellow colored document and complete the duplicate forms by listing the address location, property owner and/or agents name, signature and date of posting. The duplicate copy of the "No Trespassing" form should be delivered to Northern Station where it will be filed as an active request for enforcement. The original of the form should be posted in an obvious and conspicuous location at the location for enforcement. Aside from the copy included in this newsletter, the yellow colored signs are available at the front counter of Northern Police Station at 1125 Fillmore Street.

The benefit of a property owner using the posted 25 MPC "No Trespassing" sign to protect their property is one of convenience. Ordinarily, to enforce a misdemeanor trespassing offense, a police officer would require a person to be present as a reporting party and to sign a private person's arrest form. With the location predesignated and on file at the district station, police officers can take immediate action and make arrests without the owner present.

Thank you for your trust and know that the officers of the SFPD continue to look for new strategies to keep you safe.

BE THE MATCH



5-year-old Savian Hamilton was recently diagnosed with stage 3 Peripheral T Cell Lymphoma, a rare and potentially deadly form of cancer. Savian will need a mandatory bone marrow transplant to increase his odds of survival. The Hamilton family, in cooperation with the Oakland and San Francisco Police Departments, have organized the following bone marrow drives with the hope of finding a match for Savian.

The registry is open to those who are 18-44 years old (similar race to Savian (African American) are strongly encouraged and increases Savian's chances of finding a match). BeThe Match covers the \$100 cost of testing the swab for all participants between 18-44 years old.

Those who are 45-61 can still join but there is a \$100 tax deductible charge that is required. The charge is used only to pay for the testing of the swab and nothing else. Younger donors are more ideal due to cell metabolism and allows for a more successful graft. Secondly, as most donors age out (over 61) more often than they donate, it is imperative that the company can afford those who can be on the registry longer. Lastly, anyone who joins remains in the registry until they are 61.

This is an easy process that only requires a painless cheek swab. If you are a match for Savian the process is simple and unobtrusive. The donor will receive an injection that stimulates the bone marrow to produce and release stem cells into the bloodstream. The donor then donates blood and the stem cells are harvested. The organization that finds bone marrow matches is "Bethematch.org". You can also order a kit from the above site, if you cannot make it to the drive.





INCIDENT RECAPS

On 9/17/19 at 0041 hours, officers responded to a call of an auto boost in progress in the area of Divisadero/O'Farrell. One of the victims called 911 to provide dispatch with the subjects' description, as well as their location and description of other vehicles that they were breaking into. While en-route, officers located the subjects, made eye contact, and then the subjects fled on foot. Officers exited their vehicle and located one subject crouching behind a vehicle. When officers gave the subject commands to sit on the ground, the subject stood up and ran from the officers. The officers then began a foot pursuit and eventually apprehended a suspect and placed him into handcuffs. Another officer was flagged down by a witness who pointed in the direction of a second subject who had fled to a parking garage. Officers were able to locate the subject, gave loud commands to the subject to surrender, to which he complied and was placed in handcuffs without incident. The witness was able to place both subjects in the area of all vehicles that were broken into, and agreed to perform in a cold show. Officers conducted a positive cold show with the witness. The subjects were then transported to Northern Station and were booked.

On 9/17/19 at approximately 1113 hours, officers responded to a call of a subject brandishing a knife in the area of the 1800 block off Divisadero St. Officers were then flagged down and directed to a restaurant. While inside, officers located the subject matching the description provided by dispatch and saw him pull out a pocket knife; officers ordered the subject to drop the knife, to which he complied. The subject was then placed into handcuffs. Officers then interviewed the victims who stated that the subject saw the victims exit the restaurant with their food and money; the subject approached them to ask for money. The victims refused, so the subject threatened to stab the victims with the knife that was in his hand or to damage their vehicle. The victims quickly got into their vehicle in an attempt to stay safe but feared the subject would still try to attack them. The victims waited in their vehicle until police arrived and arrested the subject.







NO TRESPASSING

REQUEST FOR ENFORCEMENT OF MUNICIPAL POLICE CODE SECTION 25

San Francisco Municipal Police Code Section 25 provides that no person shall willfully remain upon any private property or business premises after being notified to leave by the owner, lessee, or other person in charge. Notice may be oral or in the form of a written notice posted in a conspicuous place.

A violation of Section 25 is an infraction. A second violation within 24 hours (Section 26) is a misdemeanor.
