Hello Richmond District Residents,

A victim recently came to Richmond Station to file a report regarding a PG&E scam. The suspect called the victim claiming to be with PG&E and demanding immediate payment via prepaid Money Pak Card over the phone.

Phone numbers from these scammers often appear to be legit. PG&E states they will never demand immediate payment via Prepaid card and will not ask for personal information.

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is left unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ♦ **An individual peering into vehicles, to try and locate any valuables left unattended.**
- ♦ **An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/or residence.**
- ♦ **An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.**

DEFINITIONS OF CRIME

Robbery– Robbery is the taking of property from another by using force or by using fear.

Assault– An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery- (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

****Assault is when a person swings their arm and battery is when that arm makes contact with another person. ****

Aggravated Assault– Assault upon another person with a deadly weapon or instrument other than a firearm or by means of force likely to produce great bodily injury.

Burglary– The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft– Grand Theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Suspects 1-3 exited the store with merchandise without paying. The Victim confronted the group outside and was pepper sprayed by Suspect 1. Suspect 2 and Suspect 3 fled in an unknown direction. The Victim followed Suspect 1 as she fled east on Geary Blvd.

Officers arrived and located Suspect 1, who was positively identified by the Victim.

Suspect 1 gave a false name and stated she was a juvenile.

At the Youth Guidance Center, Suspect 1 admitted she lied and was actually 19.

Suspect 1 was arrested and booked at County Jail on the following charges: Possession of Stolen Property, Unlawful Use of Pepper Spray, Robbery.

Suspect 2 & 3 are still outstanding.

Robbery w/ Gun

The Victim was sitting in his vehicle with the door open when Suspect 1 approached from the rear and pointed a gun at his chest. Suspect 1 demanded the Victims bag, which was wrapped over his shoulder. Suspect 1 and the Victim briefly struggled over the bag when the strap gave way and Suspect 1 obtained the bag.

Suspect 1 fled to a 2 door silver Honda Civic, where Suspect 2 was waiting in the driver seat.

Suspect 1 is described as a Black Male, 25-30 years old, wearing all black clothing.

Suspect 2 is described as a Hispanic Male, 25-30 years old, wearing all black clothing.

Both suspects are still outstanding.

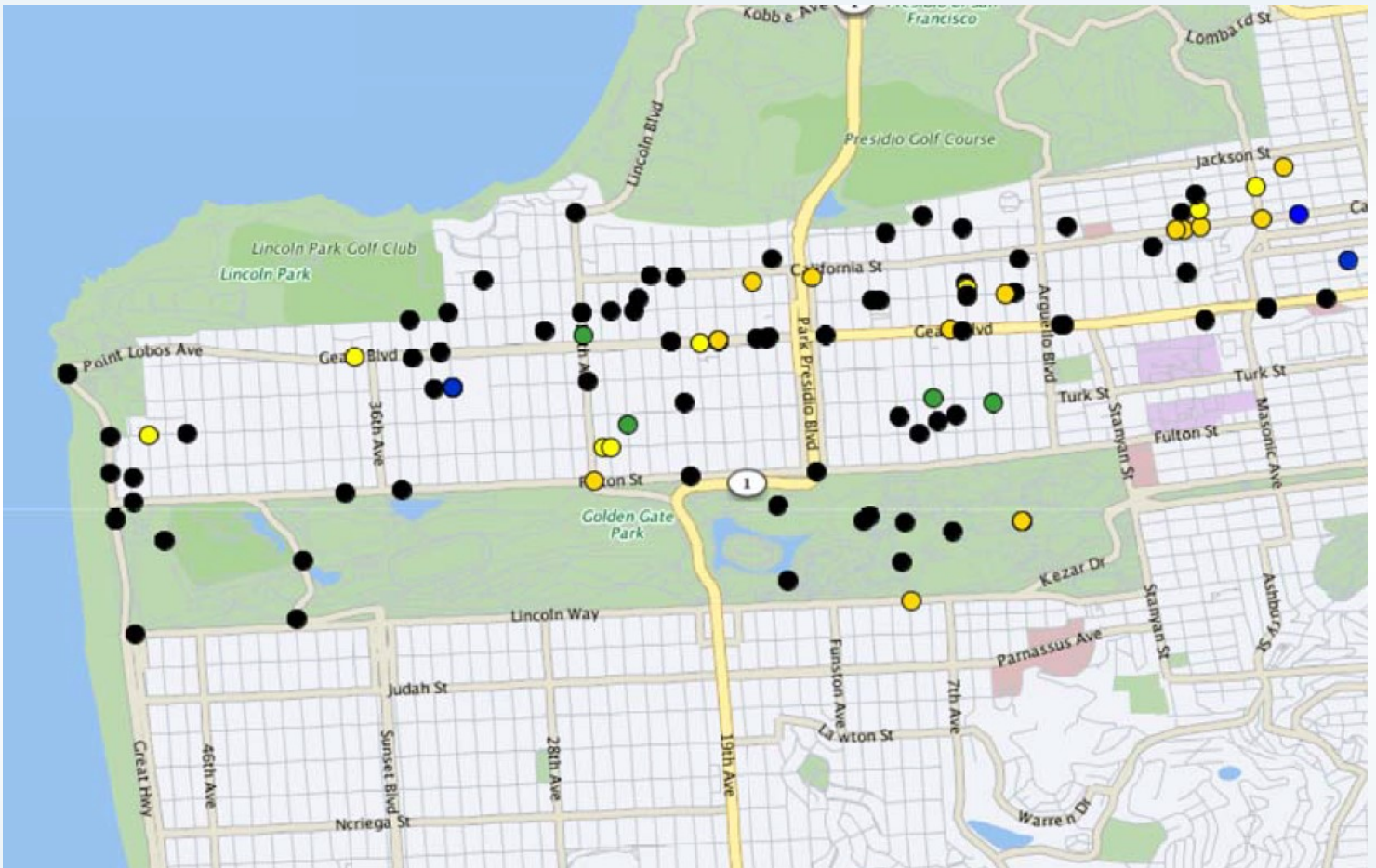
MAP OF CRIMES

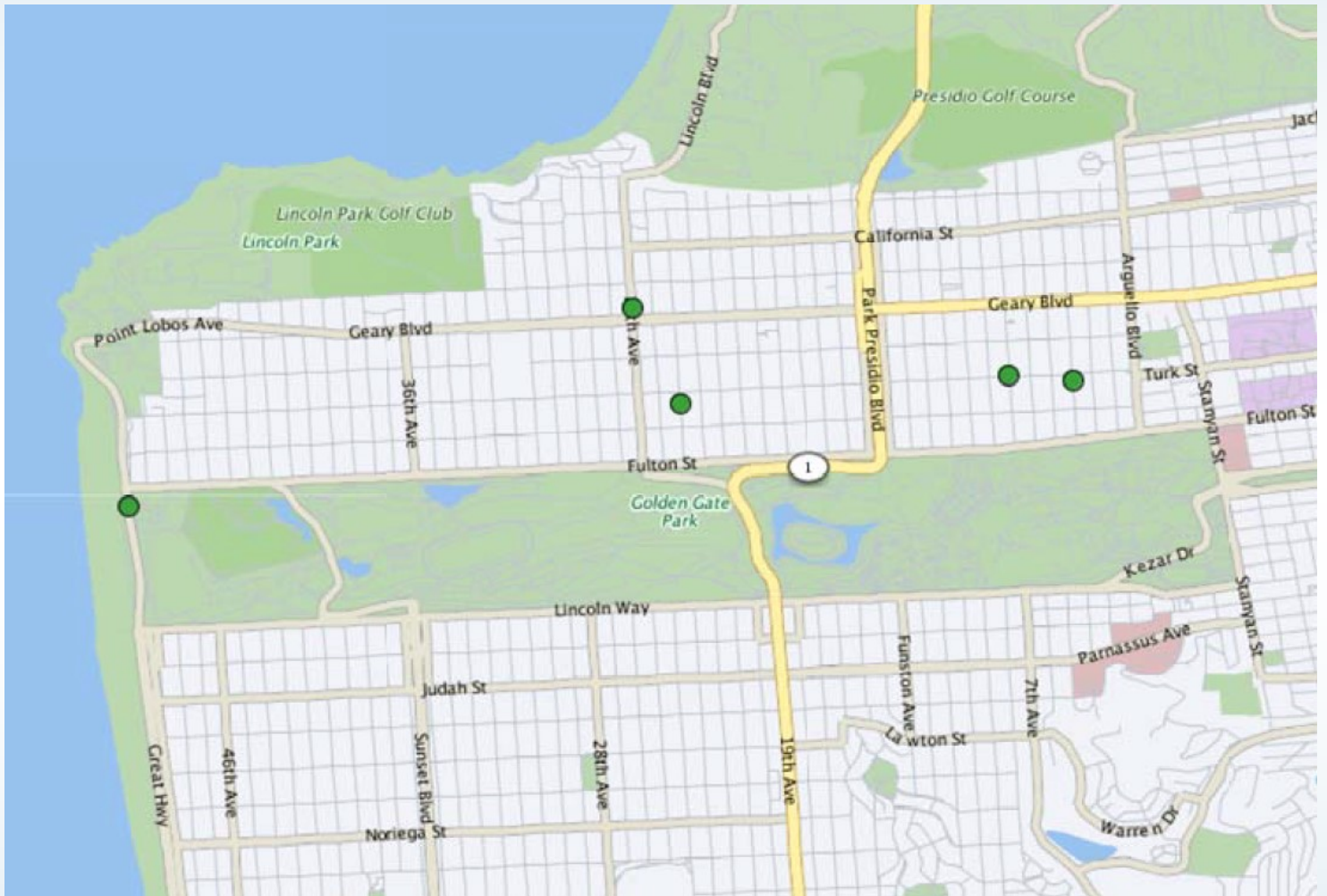

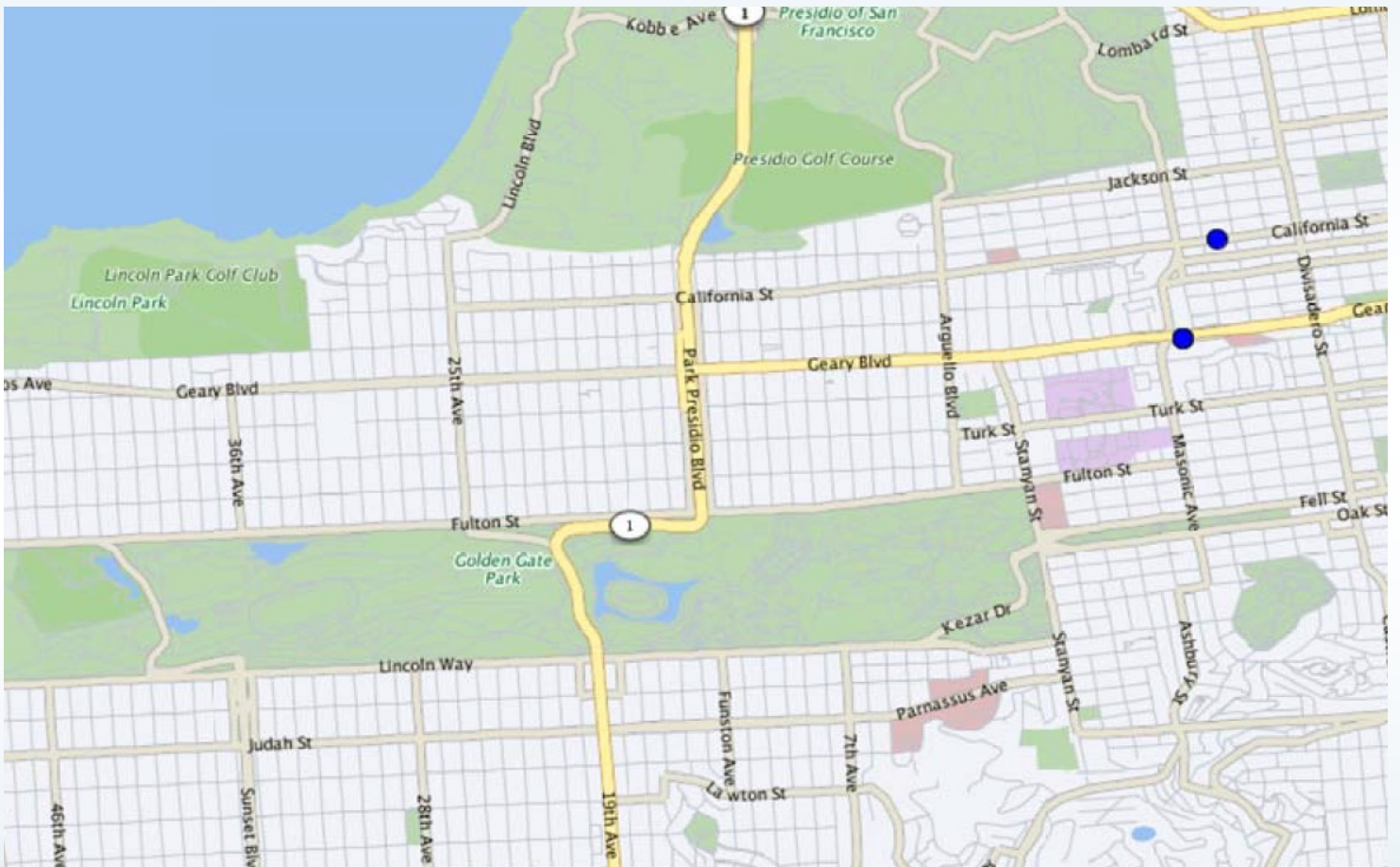

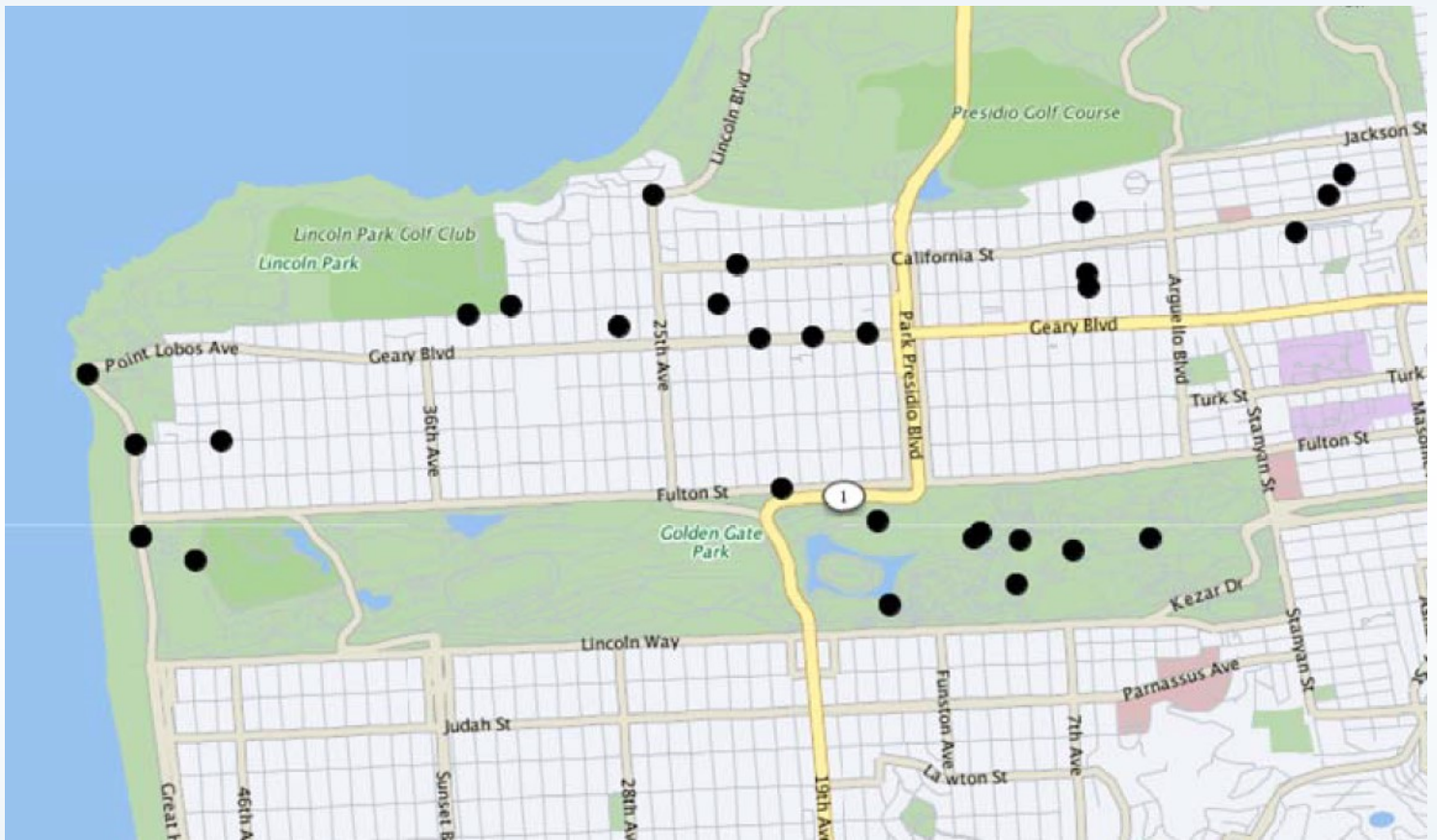

Who to Call for Assistance

San Franciscans regularly ask how they can help and who they should call when they are concerned about a person experiencing homelessness or an encampment in the community. There are some circumstances where it is most appropriate to call 9-1-1, the Police Non-Emergency Number, or 3-1-1. Below are some common reasons why someone may call for assistance and who they should call.

Call 3-1-1 to:

- Get information about services in San Francisco
- Make a 90-day shelter bed reservation (once a CHANGES profile is created at a SF Resource Center)
- Request street or sidewalk cleaning, including human, animal, or hazardous waste
- Report debris and abandoned shopping carts
- Report discarded syringes (**or text 415-810-1337**)

Call Police Non-Emergency 415-553-0123 to:

- Report trespassing and blocked entrances (person is responsive and non-threatening)
- Request a well-being check for a person who is not in distress

Call 9-1-1 to:

- Report a medical or mental health emergency
- Report someone who is acting violent or threatening to themselves or others
- Report someone who is unresponsive and may need medical assistance
- Report trespassing and blocked entrances (person is unresponsive and may need medical assistance)

[What to Expect When Reporting an Encampment to 311](#)

City departments are working to connect people living in encampments with services and shelters and to address the health and safety impacts of encampments.

Please report [encampments](#) through the SF311 app, www.sf311.org site, or by calling 3-1-1. Your service requests to 311 provide important information that the City uses to track encampment activity and assign resources.

Although you may not see the encampment immediately resolved as a result of your complaint, the City departments take the following action in response to encampment reports:

- Public Works will send out a “hot spots” crew to clean the area around encampments and mitigate the most serious sanitation problems within three days (though they strive to do so sooner than that). They will then “close out” the request and refer the issue to one or more other departments when appropriate.
- Department of Public Health Inspectors and the Fire Marshal are working to assess and address potential health and safety hazards citywide.
- The Police Department, with its newly dedicated homeless outreach team, is working directly with the police captain of each district to assess and address safety issues.
- The Department of Homelessness and Supportive Housing’s Homeless Outreach Team (SFHOT) is proactively working with the people in encampments to help them get appropriate services and into a shelter.

Although you may see your request marked as “Closed”, please be assured this does not mean that your request was ignored.

At times, requests are closed because the issue has been previously reported and the departments are already aware of the issue. In some circumstances, requests may be closed out by the original agency after they refer the issue to another department; however, that does not mean that the City agency to which the issue has been referred has also closed it out or is not taking action in follow up.

311 also provides regular encampment reports to the Department of Homelessness and Supportive Housing, the Police Department, the Health Department and San Francisco Public Works, so that they can identify “hot spots” and collaboratively create strategies for resolving encampments.

Unfortunately, there are not enough shelters and navigation centers in the City for everyone who is homeless. The Mayor, the Board of Supervisors, and HSH are also working hard on finding shelter and housing opportunities for people living on the streets.
