CITIZEN OF THE MONTH OXANA SANUKOVA




Oxana is the owner and lead designer at Sol Ambiance Flower Shop located at 5522 Geary Blvd, opened on February 5th, 2016.

The Suspect was arrested and booked at County Jail on the following charges: Threats and Outstanding Warrants


MAP OF CRIMES







Message from the City Attorney

Code Enforcement is not a topic you often see covered in the news media – except when a horrible tragedy occurs because a business or property owner ignores health and public safety codes that exist to protect the public.

13 young partygoers die in Chicago when an unsafe apartment building deck collapses.

100 people die in a Rhode Island nightclub fire ignited by an illegal indoor fireworks display.

5 seniors die and another 20 become seriously ill at a Connecticut nursing home, poisoned by salmonella.


These are the dramatic headline-grabbers, but closer to home in nearly every San Francisco neighborhood there may be Fire, Building, and Health Code violations that threaten our health and safety.

My office works with the Building, Health, Planning, Public Works, Fire and Police Departments to identify threats to neighborhood health and safety and devise the most appropriate and effective solutions.

Our success also requires the watchful eye of people in the neighborhoods. If you see property conditions or business activities that you believe threaten health or safety, call my Code Enforcement Hotline at 415-554-3977.

Housing and Building Code Violations

Lack of heat or water, dilapidated conditions, unsafe or illegal construction, plumbing, electrical and/or mechanical problems, seismically unsafe buildings, or vacant and abandoned buildings.

Private Property Used for Criminal Activity*

Drug dealing, prostitution, illegal businesses, nuisances at liquor stores and entertainment venues, or gambling.

Zoning and Planning Violations

Unauthorized property uses, residential use of commercial spaces, commercial auto repair at residential properties, illegal signs, non-compliance with landmark preservation laws, destruction of San Francisco historical landmarks, or illegal short-term rentals. Public Works Violations

Blight, broken sidewalks in front of residences or businesses, or illegal dumping.

*Please note, our code enforcement efforts aim at long-term solutions for blighted properties. For crimes in progress, please call 911 for police assistance.
