President Obama's Task Force on 21st Century Policing released its final report in May of 2015. This guiding document—for sworn and non-sworn members in all ranks and assignments throughout the 18,000 law enforcement agencies in the United States—was the first comprehensive study of the policing profession since 1967. The over 100-page report with hundreds of actionable recommendations all fit under six "pillars" aimed at fulfilling, restoring, and maintaining the public's trust: "Trust between law enforcement agencies and the people they protect and serve is essential in a democracy."

Think back to a time when a friend, a teammate, a coworker, or a member of government asked you: "Do you trust me?" Did it take long to answer that question? Probably not. Now, think about how difficult it was to answer when a loved one, your significant other, or a spouse asked you: "Why do you love me?" Did you find trouble putting to words something you deeply knew to be inherently true? Both trust and love are conditions of the heart, not conditions of the head. This is why it is difficult to put into words (that exist in the brain) a condition of the heart (part of the limbic system where there is no capacity for language); it is also why it is impossible to talk yourself into loving or trusting another person—it must be proven and forged over time.

Stephen M.R. Covey in his book *The Speed of Trust* helped us to put into words how trust is built and where it is destroyed: "In order to be trusted, I must be trustworthy; in order to be trustworthy, I must have character and competence." Character is demonstrating the courage to live in congruence with the highest moral principles and beliefs that our community, constitution, and profession demands. Competence is the results-oriented delivery of capabilities performed at a masterful level.

In September, Park Station's semi-annual shift and assignment "sign-up," running through the month of August, will go into effect. This month is a time for all members to reflect upon their previous six months, to bid for assignments based upon seniority, interest, talent, and proven results, to request working with a partner whose knowledge, skills, and abilities are complimentary, and to move forward with clear expectations and attainable goals. I expect that our Park Station members will continue to place their attention and intention into the embodiment of the profession's highest ideals and will be measured by their trustworthy and consistent demonstration of competence and character within and for our community in every single interaction, every single day.




Robberies that occurred in the Park District (from Monday, 07/25/22, to Sunday, 07/31/22)



Robbery


Assaults that occurred in the Park District

(from Monday, 07/25/22, to Sunday, 07/31/22)






Auto Burglaries that occurred in the Park District (from Monday, 07/25/22, to Sunday, 07/31/22)

BIAS-FREE POLICING

Information for Discussion:

- 1. There are two Department General Orders (DGOs) regarding how to file a complaint against sworn and non-sworn members of the SFPD (DGO 2.04 Citizen Complaints against Officers, DGO 2.05 Citizen Complaints against Non-Sworn Members). If you would like to file a complaint and have a question about to do so after reviewing the text of the DGOs, please contact any district station, where personnel will be happy to walk you through the process.
- 2. If you would like to <u>commend a police officer</u> for exemplary work, follow the hyperlink and choose the option that best suits your taste.
- 3. If you would like to <u>file a complaint about a police officer</u> with the Department of Police Accountability (DPA), please follow the link and use the method that is easiest for you.
- a. The above link regarding filing a complaint also provides you with links to <u>DGO 2.01 General Rules of Conduct</u>, <u>DGO 2.04 Citizen Complaints against Officers</u>, <u>DGO 2.05 Citizen Complaints against Non-Sworn Members</u>, and <u>DGO 2.07 Discipline Process for Sworn Officers</u> if you would like to reference those resources before or after you make a complaint.
- b. The DPA maintains <u>monthly statistical reports</u>, <u>quarterly</u>, <u>and annual reports</u> on its cases and their outcomes. The information is available on its <u>website</u>.
- 4. If you are interested in reviewing the results of <u>quarterly Disciplinary Review Board reports</u> as presented to the Police Commission, the information is available on the Police Commission website.
- 5. On 08/21/2020 the SFPD re-affirmed its commitment to serve the community of San Francisco without bias by updating DGO 5.17 Bias-Free Policing Policy. The SFPD is dedicated to guaranteeing that every person is afforded equal protection under the law. The SFPD's policy is one of the first to incorporate training on "bias by proxy," and explains the best practices to ensure that bias does not affect how its members interact with the community.

- 6. The Media Relations Unit posts links on Facebook and Twitter quarterly to remind everyone of our whistleblower policy.
- 7. The SFPD is committed to serving the youth in our community, and has created a <u>"Youth Know Your Rights" brochure</u> to explain how it has updated its policies regarding interacting with juveniles. The forms are available in English, Spanish, Chinese, Russian, Vietnamese, and Tagalog. Further information about the SFPD's policies regarding juveniles may be found in <u>DGO 7.01 Policies and Procedures for Juveniles:</u> <u>Detention, Arrest, and Custody.</u>

- 9. Officer-involved shootings (OIS) are complex incidents that are investigated by several different agencies. Prior to May 4, 2019, officer-involved shootings were investigated by the SFPD Homicide Detail, the San Francisco District Attorney's Office, and the SFPD Internal Affairs Division. After that date, the San Francisco District Attorney's Office Independent Investigations Bureau (IIB) replaced the SFPD Homicide Detail as the lead in OIS investigations while the SFPD Investigative Services Detail (ISD) is responsible for examining any ancillary crimes associated with the OIS and assisting the IIB as necessary.
- a. The SFPD is committed to transparency in the wake of an OIS, which is why the Media Relations Unit has an established a <u>protocol for response after an OIS</u>. Media Relations also publishes links on SFPD social media accounts to <u>quarterly updates</u> on OIS investigations.
- b. The SFPD publishes <u>historical data on past OIS</u> incidents.

The San Francisco Police Department's Volunteer Program, ALERT, is a volunteer citizen disaster preparedness and community engagement program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include traffic control, working with other city agencies and community outreach. Volunteers must be 16 years of age, live, work, or attend school in San Francisco.

RESIDENTIAL SAFETY TIPS



Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure. Working together as a community with your neighbors and building management can significantly improve your residential safety.

7 Residential Safety Tips



- Garage: When entering or leaving the garage, watch to ensure door shuts completely. Lock stored bikes to a sturdy rack.
- Car: Always lock your vehicle when parked in your garage and remove all valuables. Never leave garage door opener in your vehicle when parked outside your home.
- Spare Key: Never hide spare keys. If you need to have a spare key available, leave it with a trusted neighbor.

- Open Buzzer: When a visitor rings your bell, confirm who it is by intercom before you grant them access. Similarly, never let strangers follow you through the front door.
- Security Cameras & Alarm Systems: Cost effective tools for preventing crime and identifying criminals.
- Continuous Light Timers: Installing timers on the exterior of your residence is an effective and energy efficient way to deter criminal activity.
- Doors/Windows: Always keep doors and windows locked.

Door and Window Safety

Doors:

- . Should be made of solid wood or metal
- Have a single cylinder deadbolt lock and a 1-inch bolt
- Have a front door viewer or peep hole with a 180-degree range
- · Clearly display unit number

Windows:

- Replace if glass is cracked and replace all damaged or missing locks
- Ground level windows should be burglary resistant: consider purchasing windows with reinforcement wire, laminate, or tempered glass
- Polycarbonate plastic or metal grates can be installed over existing ground level windows
- Windows above ground level are not considered secure: if used for ventilation, lock in position and keep open no more than 3 inches

■ WON'T BE HOME?

Use the "Hold Package" option at USPS.com to have packages held at location post office for pick up. You can also arrange for neighborhoods to pick up any packages that might be delivered.

USE SPECIAL SERVICES

Use USPS special services like Signature Confirmation or Registered Mail to add a layer of security.

REQUEST NONDESCRIPT PACKAGING

When completing your online order, opt for packaging that conceals the item or select the 'gift' option to ensure package arrives in a plain box especially when ordering from a high-end store.

NETWORK WITH NEIGHBORS

Neighborhood groups on social media or community apps can provide a system for reporting suspicious activity. This is also a good way to keep your deliveries and neighborhood secure.

PORCH AREA VISIBILITY

Keep the porch area clear and visible. The more likely a would-be thief is to be seen, the more likely they are to choose another target.

CUSTOMIZE DELIVERIES

Customize deliveries by adding specific delivery instructions using USPS.com and your tracking number. You can also schedule packages to arrive when you are home or reroute packages.

DELIVER TO SECURE LOCATIONS

Send packages to secure locations such as Amazon Lockers, FedEx and UPS locations, P.O. Boxes, and local post office.

USE MODERN ALTERNATIVES

Take advantage of contemporary options like smart lockers, lockboxes, cameras, motion detection lighting, alarms like Package Guard, and services like Doorman.



GARAGE DOOR BREAK-IN PREVENTION



PREVENT GARAGE DOOR BREAK-INS

Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.





ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a



INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



TIE EMERGENCY RELEASE CORD

Tving your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.



INSTALL INTERIOR MAIL SLOT HOOD COVER


If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

YOUR BIKE HAS BEEN STOLEN. NOW WHAT?

Here's what you should do next to increase your chances of recovering your bike:

File a Police Report

You can do this in one of three ways:

- Online at sanfranciscopolice.org/reports
- Via phone by calling (415) 553-0123
- In person by going directly to your district police station

Create a Google Alert

By creating a Google alert for bikes being sold that match the make and model of your bike, you increase your chance of finding it.

If you see your bike for sale on Craigslist or OfferUpNow.com, don't try to recover it yourself. Contact SFPD directly.

SHARING THE ROAD WITH CYCLISTS

When it comes to safely sharing the road with cyclists, it's paramount for drivers to learn how to coexist.

Share the Road

When out and about, drivers need to be evermindful of sharing the road with cyclists.

Follow the 3 Foot Rule

Maintain a distance of 36 inches from cyclists whenever passing them. If possible, keep an even wider berth if there's bad weather or if in a higher speed limit zone.

Be Cautious with Kids

Kids can be unpredictable since their motor skills and decision-making faculties aren't fully developed. Be on alert when driving near schools and residential areas.

Stay Off the Horn

Sudden hoking might startle a cyclist and can cause them to swerve into traffic or off the road.

Mind Your Blind Spots


Drivers should double-check their mirrors when changing lanes, making turns, and especially before opening their car door after parking.

Be Patient

Don't tailgate a cyclist. When you need to pass one, patiently wait until it's safe to do so.


We are accepting Entry Level (Q-2) Police Officer applications. To apply please follow the 2-step process:

DEFINITION OF SUSPICIOUS ACTIVITY

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- An individual peering into vehicles, to try, and locate any valuables left unattended.
- An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.



CRIME DEFINITIONS

Definitions

Robbery – Robbery is the taking of property from another by using force or by using fear.

Assault – An assault is an unlawful attempt, coupled with the present ability, to commit a violent injury on another person.

Battery - (Misdemeanor battery) is any willful and unlawful touching of another.

(Felony battery) is the use of force or violence upon the person of another that causes serious bodily injury.

*Assault is when a person swings their arm and <u>battery</u> is when that arm makes contact with another person.

Aggravated Assault – Assault upon another person with a deadly weapon or instrument other than a firearm or by any means of force likely to produce great bodily injury.

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

Grand Theft – Grand theft is theft committed when the value of the money, labor, or property taken exceeds \$950.

Petty Theft – Theft where the value of the property taken is less than \$950.

WHO AND WHEN TO CALL?

3-1-1: Please contact 3-1-1 when the issue is a not an emergency, yet requires City services or, if you simply have questions regarding City services. Non-emergency situations include the following examples: damage to public property, public trees that requires pruning, defective streets or sidewalks, homeless-related issues. 3-1-1 was developed to help the community inform the appropriate City agency regarding a service request.

SF 3-1-1 APP is available to use on your mobile device. Download the APP and its easy to use for many Non-emergency.

Non- Emergency San Francisco Dispatch Line: Pease call the non- emergency dispatch line (415-553-0123) when the scenario does not need immediate response from the San Francisco Police Department. For example, if there is a loud party, a group of loud juveniles loitering in front of your residence, noise complaints, doubled parked vehicles, suspicious activities, or a homeless/nuisance related issue. The non-emergency line is for situations that require the police, but do not require an immediate police response.

9-1-1, please call 9-1-1 immediately if there is a police, fire, medical, or any other emergency. The purpose of San Francisco's 9-1-1 Emergency Telephone System is to provide the community an immediate response of police, fire, or medical personnel for emergency occurrences. To accomplish this, it is imperative that the calls received on the 9-1-1 line be restricted to those situations that require immediate dispatching of police, paramedic, or fire department personnel. For example, crimes or fires that are in-progress, or medical emergencies.

The San Francisco Police Department district station telephone numbers and emails are not monitored. Questions will be answered in the order we receive them. Station emails are not for making police reports nor for reporting a crime. If you need to make a police report, you can call 415-553-0123 or go to your district police station. **If you have an emergency, please call 9-1-1**.
