PICKPOCKETS

Remember the three “C’s”: **CROWD**, **COVER**, and **CONTACT**. Pickpockets occur under crowded conditions. The thief will use the cover of a pressing crowd to get next to the victim and make the physical contact necessary for the theft. A pickpocket always does two things: They look down because they are looking for a “pocket” (purse) to pick. They use an object (jacket, newspaper, garment bag) to conceal the pocket or purse and then remove the wallet.

GENERAL TIPS

- When boarding public transportation, be aware of pushing and jostling.
- If you see a pick pocketing incident, report it to the bus driver.
- Watch out for strangers who strike up a conversation. This may be a trick to distract you.
- When shopping, don’t leave wallets or purses in dressing rooms, or on top of counters.
- Never carry more money or credit cards than you will need that day.
- Be careful about displaying large sums of money in public.

HOW TO PROTECT YOUR WALLET

- Carry your wallet in your inside jacket pocket, not in your back pocket.
- If you are not wearing a jacket, place your wallet in a pocket which can be buttoned.

HOW TO PROTECT YOUR PURSE

- If you carry a shoulder bag, place your arm around the outside of the bag. Make sure the bag is in front of you, not behind your back.
- When carrying an armload of packages, keep your purse between your body and the packages.
- If you put your wallet in a jacket pocket, make sure it is zipped up or if a loose pocket, use a safety pin on the inside of the garment to secure it.
- Keep purse and keys separated.
- Place your purse on your lap when seated in public places (buses, BART, theaters, etc.). Do not put your purse under the chair.
- When you are in restaurants, never hang your purse on the back of a chair.

HOW TO PROTECT YOUR BACKPACK

- When riding public transportation, wear your backpack in front of you. This prevents the thief from getting into your backpack. Also, you are not pushed by passengers trying to get to the back of the bus because your backpack is in the way.
- Do not store valuables such as wallets and cell phones in the front pockets of your backpack.

IF YOU ARE VICTIM

- Make a police report.
- Notify the police and your credit card companies.
- Don’t be fooled by a call saying that your credit cards have been found and are being mailed back to you. Often this is done by the thief to prevent you from reporting the loss and allows the thief more time to use your credit cards.
- Only by reporting the theft can the police help.

Richmond Station supports the Department's Community Policing Vision and Values and is committed to creating a safe, healthy, and vibrant community. Our spirit is guided by a guardian mindset, and we recognize that our role as protectors is rooted in empathy, understanding, and mutual respect.

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities. Richmond Station uses the following methods to engage with the community:

- **Homeless Outreach:** Officers coordinate with multiple city agencies to provide assistance and offer city services. Officers address quality of life issues and find programs for willing individuals.
- **Foot Patrol:** Richmond Station has dedicated foot patrols on Clement Street, Geary Blvd, and Laurel Village/Sacramento Street corridors.
- **Community Meetings:** Community Meetings are held once a month for the public and residents of the Richmond District to attend. People can voice their questions or concerns about issues in the Richmond District.

WHAT YOU NEED TO KNOW THIS MONTH

I think I have been a victim of a scam! What do I do?

Financial crimes include phone scams, counterfeit money, identity theft, and embezzlement. Scammers often target the elderly, low-income people, and business owners. In some cases, scammers have posed as IRS, courts, or utility representatives to cheat victims out of their money. In all of these cases, your first step is making a police report in person at your local district station or online [here](#). Next, preserve what evidence you may have. Evidence includes eyewitness accounts and/or documents. Useful documents include account statements, receipts and canceled checks. Finally, contact all your banking services and credit bureaus to notify them of the incident, as you may need to close your account or put a hold on your credit. BURGLARY ARREST, WEAPON, CARRYING CONCEALED

2700 block Pine

Two suspects attempted to break into a home. Responding officers spotted the suspects who matched the descriptions, provided by victim to dispatch via 911, walking on the sidewalk. Officers detained one of the suspects while the other suspect fled on foot in unknown direction. Video of incident showed suspect, who was detained by officers, attempting to force entry into the home while the suspect that got away acted as a look-out. The detained suspect was identified, video was provided, arrest search revealed evidence of crime along with a concealed switchblade and a replica snub nose revolver. Suspect was arrested and booked. Case assigned to SFPD Burglary Unit who is conducting the follow up investigation.

Garage door burglary from 2022. Burglary occurred in the middle of the night while residents were home sleeping. Suspect broke garage door windowpane to open garage door and gained entry into the garage. Suspect stole \$9000.00 mountain bike and fled the scene. Suspect's flashlight left in victims garage at the scene of the crime. Video provided shows suspect walking around with flashlight during incident. DNA on flashlight left by suspect in this incident lead to investigation & arrest. Suspect is repeat offender and is also the same suspect arrested in above burglary incident on 02.14.23 for SFPD case #230108840. Case assigned to SFPD Burglary Unit who is conducting the follow up investigation.

Suspect vehicle (KIA Forte) was casing potential victim vehicles at various hot spots throughout the City. City-Wide plainclothes team observed the suspects and started a rolling surveillance of the KIA. Suspects in the KIA committed an auto boost at 219 Clement and fled the District. Suspects were observed discarding unwanted stolen items to sidewalk from the KIA. Discarded items were recovered and an arrest plan was developed to safely apprehend the suspects. Spike strips were authorized and deployed successfully to safely slow the KIA. The KIA stopped, the passenger exited the vehicle, fled on foot, and was quickly taken into custody without incident. The driver of the KIA took off driving again and later caused a vehicle collision at an controlled intersection where vehicles were stopped for a red light. The driver exited the KIA, fled on foot, and was taken into custody after a foot pursuit. During the foot pursuit of the driver, the driver was observed discarding a firearm under a parked vehicle where it was recovered by officers. The firearm was loaded with a 22 round magazine and one round in the chamber. Searches of the suspects and the suspect vehicle revealed evidence related to the incidents, which was seized. Both suspects (driver and passenger) were arrested and booked. Case assigned to SFPD Burglary Unit who is conducting the follow up investigation.

GRAFFITI ABATEMENT ARREST

Officer observed two suspects in-act of tagging building wall with spray paint. Officer attempted to detain both suspects and they quickly decided to run away from the officer and fled on foot. Both suspects were detained after foot pursuits with help of back up officers. Suspects identified then arrested for the vandalism graffiti. Case assigned to SFPD General Works Unit who is conducting the follow up investigation.

BURGLARY ARREST, CONSPIRACY. RESISTING PEACE OFFICER DUTIES

02/21/2023 0614 hours

2800 block Pine

Officers responded to report of 3 adult males & 1 adult female trying to break into the bill change machine at laundromat. Dispatch advised that subjects were trying to hook the bill change machine up to a pickup truck and provided suspect descriptions. As officers arrived, they saw the female suspect standing on the sidewalk 20 feet away from the laundromat and the pickup truck double parked in front of laundromat. Officers gave female suspect verbal commands, she quickly fled on foot. A foot pursuit began where the officer tackled the female to ground, and fight ensued with suspect actively resisting to evade arrest. The female suspect was taken into custody.

During the time the officer was in a foot pursuit of the female. A single Officer had 3 subjects (B2, B3 & D1) detained at gunpoint at the pickup truck. Back up Units arrived, and all 3 subjects were detained without incident and a through investigation was conducted.

Laundromat owner confirmed damage to walls, doors, washers & dryers, and bill change machine. Suspects were observed in the laundromat and going back and forth to pickup truck for tools and toolbox. The suspects appeared to be attempting to open a bill change machine using a crowbar along with a small instrument to open many other washers and dryers coin boxes.

Evidence connecting the suspects to the crime and the vehicle were recovered and seized. Suspects were identified and later arrested for the burglary and damage to property. One suspect was found to be wearing an ankle monitor from an agency during this incident. One of the suspects was found with a replica revolver firearm on their person during this incident. Case assigned to SFPD Burglary Unit who is conducting the follow up investigation.

CARJACKING WITH A GUN

02/26/2023 2155 hours

200 block 11TH Ave

During the course of this carjacking investigation and arrest, officers from Richmond, Northern, Southern, Central, Tenderloin, CHP, Oakland PD, and Oakland/CHP Aerial Unit all assisted in the capture of the suspects.

Richmond officers on scene and immediately ascertained vital information from victims and witnesses and began tracking the victims laptop. Officers provided updated tracking locations to dispatch, which were immediately relayed to Dispatch, who broadcast the updates City-Wide.

Victim was dropping off his friend in front of her house when the suspect with a firearm approached his vehicle. Suspect told victim to exit vehicle and give him his keys. Victim complied in fear and gave the suspect his cell phone and wallet. Victim and friend were out of the vehicle as suspect drove away. On scene, two additional victims reported an attempted robbery involving the same suspect vehicle.

Tenderloin officers quickly observed carjacked victim vehicle and attempted to apprehend the suspects, who refused to stop and took off. A pursuit was initiated of the violent felon carjacking vehicle and the suspects were pursued to Oakland. Per Aerial Unit, the suspects exited the victim vehicle, in Oakland, that was carjacked and fled on foot while taking off several items of clothing as they were running. Aerial Unit assisted in apprehending the suspects who choose to conceal themselves. Aerial Unit advised that the suspects had ran into a driveway trying to hide from searching PD Units. A perimeter was setup and commands were given to the suspects. Both suspects were taken into custody without further incident.

Suspect vehicle was towed for CSI processing. Evidence linking the suspects to the crime was recovered from scenes and vehicle which included a Glock firearm. SFPD computer check revealed recovered Glock firearm was stolen out of Fresno. Case assigned to SFPD Burglary Unit who is conducting the follow up investigation.

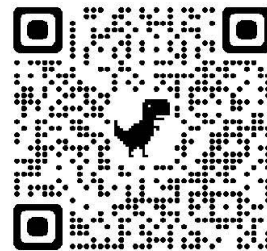

- Do not leave valuables in your vehicle
- Remove garage door opener from your vehicle if parked outside your garage
- Lock the door from your garage leading inside your home
- "Block the cord" – garage door openers have an emergency release cord that, when pulled, disconnects the door from the mechanism thereby making it easy for burglars to enter your garage

**CITY LAUNCHES COMMUNITY IMPACT SURVEY TO HELP
SECURE STATE AND FEDERAL ASSISTANCE
FOR ELIGIBLE SAN FRANCISCANS**

Businesses, property owners and renters who experienced damage from winter storms are urged to complete the survey to help inform the City's recovery efforts

San Francisco, CA—Mayor London N. Breed today announced the launch of a storm damage [survey](#) for residents and businesses who experienced damages to their property as a result of the storms that began on New Year's Eve. The survey will help inform the San Francisco Department of Emergency Management (DEM) about the extent and range of damages caused by the storms to private property. Once the survey is completed, findings will be considered for eligibility from state and federal agencies overseeing storm relief assistance programs.

These programs, such as disaster assistance grants from the Federal Emergency Management Agency (FEMA) and low-interest disaster loans from the Small Business Administration (SBA), can offer much-needed help to San Franciscans recovering from storm damages.

"We know there are a lot of people that need financial help as a result of recent severe storms," said Mayor Breed. "Together with state and federal partners, we are working to secure every available relief program for eligible business owners and residents. This is why we are urging anyone who experienced damages to their businesses and homes to complete the survey."

"These winter storms were unlike any we have seen and many residents and business owners experienced damage from storms," said Mary Ellen Carroll, Executive Director, San Francisco Department of Emergency Management. "If your home, business, or any other property was damaged, we urge you to complete this survey to support San Francisco's post-storm recovery."

Last week, preliminary estimates for storm-related costs to City infrastructure within San Francisco totaled nearly \$17 million, in addition to at least \$25 million in damages to City infrastructure located in Alameda, Tuolumne, and San Mateo Counties. Prior to the community impact survey, initial estimates for private property damages were approximately \$10 million, but local, state, and federal representatives must first verify estimates to determine San Francisco's eligibility for available state and federal funding assistance.



“In the wake of the heaviest series of storms we’ve had in over 200 years, we’re calling on all San Franciscans who love their city to take this impact survey and help be our eyes and ears on the ground,” said Board President Aaron Peskin. “By understanding the damages we’ve sustained, we can get San Francisco moving more quickly toward recovery and resilience.”

This community impact survey will capture information for all storm-related property damages, including impacts from flooding, land and mudslides, sinkholes, and fallen trees or power poles. The information gathered will provide necessary details to inform the City’s understanding of the overall impacts of the storms on private property and will support the request for state and federal assistance programs to be granted to San Francisco.

While residents and business owners are strongly encouraged to complete the survey, survey submission does not guarantee that an individual or business will be eligible or receive assistance from state or federal programs.

San Francisco’s [Community Impact Survey is available now through February 9, 2023](#), and soon will be made available in Spanish, Chinese, and Filipino. IF YOU SEE SOMETHING, SAY SOMETHING...

Suspicious activity is any observed AND articulable behavior that could indicate a crime-related incident has been committed, or is about to be committed. Articulable means you are capable of expressing, explaining, or justifying to our dispatchers and/or officers that you believe a person violated a law or regulation. Race, gender, religion, socio-economic status, style of dress, choice of hairstyle, etc. should NEVER be a factor in classifying someone as suspicious. Some examples of suspicious activity:

- Individual(s) peering into vehicles to try and locate any valuables left unattended.
- Individual(s) trying door handles to vehicles and/or residences to gain access.
- Individual(s) following delivery trucks to see where the truck is dropping off packages.

While this isn't an exhaustive list, nor absolute confirmation of a crime, we hope these examples will assist you should you ever need to call the police.

What is the SFPAL? What is the Law Enforcement Cadet Program?

Fifty-five years ago, two policemen decided they wanted to do something about “the growing juvenile delinquency problem” in San Francisco. They courageously took out personal loans and started what has grown into the San Francisco Police Activities League. From this meager beginning and a handful of kids, SFPAL has grown to serve thousands of San Francisco youth – reaching every San Francisco neighborhood and block over the past half-century. Today, almost 1,200 kids participate in PAL healthy activities with the help of over 100 civilian and police volunteers every year.

The SFPAL Law Enforcement Cadet Program is a collaborative effort of SFPAL and the San Francisco Police Department (SFPD). The PAL Cadet Program has provided opportunities for growth, leadership, and career experiences for thousands of San Francisco youth — including many who have chosen to pursue law enforcement or public service careers. SFPAL Cadets receive training modeled after the basic training academy for new police recruits and are taught by SFPD Police Academy training staff. The program is designed to provide hands-on job skills training and leadership development through proper preparation and training.

CRIME DEFINITIONS

HOMICIDE: Murder and non-negligent manslaughter is the willful killing of one human being by another. Deaths caused by negligence, attempts to kill, assaults to kill, suicides, and accidental deaths are excluded. Manslaughter by negligence is the killing of another person through gross negligence. Deaths of persons due to their own negligence, accidental deaths not resulting from gross negligence, and traffic fatalities are not included in the category of manslaughter by negligence.

RAPE: Penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. Attempts or assaults to commit rape are also included; however, statutory rape and incest are excluded.

ROBBERY: The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

AGGRAVATED ASSAULT: An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. Simple assaults are excluded.

BURGLARY: The unlawful entry of a structure to commit a felony or a theft. Attempted forcible entry is included.

LARCENY (aka THEFT): The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Examples are thefts of bicycles, motor vehicle parts and accessories, shoplifting, pickpocketing, or the stealing of any property or article that is not taken by force and violence or by fraud. Attempted larcenies are included. Embezzlement, confidence games, forgery, check fraud, etc., are excluded.

MOTOR VEHICLE THEFT: The theft or attempted theft of a motor vehicle. A motor vehicle is self-propelled and runs on land surface and not on rails. Motorboats, construction equipment, airplanes, and farming equipment are specifically excluded from this category.

ARSON: Any willful or malicious burning or attempting to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.



PREVENT GARAGE DOOR BREAK-INS



Garages can sometimes be the most vulnerable area of the home and they are often the entry point most targeted by thieves because of the easy access to the home. Here are some tips to help secure your garage and protect it from theft.



ALWAYS CLOSE YOUR GARAGE DOOR

This may seem obvious, but just drive through any residential neighborhood and you'll likely see a few wide-open garage doors. This is an invitation to burglars and at the very least, you're allowing passersby to easily view the contents of your garage.



INSTALL MOTION-SENSITIVE LIGHTS

Homes and garages with poor exterior lighting become more appealing targets for burglars. Ensure all entry points are well-lit. Constant lighting supplemented by motion sensitive lighting is best.



REINFORCE THE GLASS ON THE GARAGE DOOR

Add vinyl adhesive to reinforce garage windows. You can also opt for a frosted or translucent glass design to allow sunlight in while obscuring contents inside.



DON'T LEAVE GARAGE DOOR REMOTE IN YOUR CAR

A garage door remote is basically another key into your home and thieves won't hesitate to use it if they find it. Opt to use a remote on a keychain.



INSTALL AN INTERIOR MANUAL GARAGE DOOR LOCK

When leaving on a vacation or for extended periods of time, disconnect automatic door motor and install a manual lock.



TIE EMERGENCY RELEASE CORD

Tying your emergency release cord into a small ball will make it more difficult to reach by thieves who manage to break the garage windows.



INSTALL SURVEILLANCE CAMERAS

There should be at least 1 exterior mounted camera facing the street and registered with the D.A.'s office.



SECURE ANY VALUABLES

Keep all tools in cabinet systems with locks and be sure to hang and lock any bicycles. As much as possible, try to avoid keeping valuable items in the garage or inside vehicles.



HAVE A QUALITY, FUNCTIONING GARAGE DOOR

Garage doors should be as secure, sturdy, and well-built as your front door and should remain in good condition and tight fitting. Deadbolts should also be added to the garage-to-house door.



INSTALL INTERIOR MAIL SLOT HOOD COVER

If the garage door is equipped with a mail slot, a hood cover will prevent any view into the garage and its contents, eliminating enticement to enter.

STOREFRONT VANDALISM RELIEF GRANT



Get a grant of up to \$2,000 for vandalism related costs. Make sure you gather all required information and documents before you apply. Check out our website for more information.

Whether you live in a single family home, condo, or a large apartment complex in San Francisco, there are a number of ways you can keep your residence safe and secure.

FREQUENTLY ASKED QUESTIONS

HOW DO I ADD INFORMATION TO A COMPLETED POLICE REPORT?

There are two ways to add information to a completed SFPD Police Incident Report:

1. **In Person**— You may go to any police station in San Francisco and request to complete a Supplemental Report. Please be prepared to provide your original case number.
2. **Online** — Using our online portal is the most convenient way to document additional property loss to the initial report, additional details that may assist the investigation, and/or additional details to describe stolen property, such as a serial number. You can access the online portal here: [SFPD Online Reporting System](#).

HOW DO I REQUEST A COPY OF MY POLICE INCIDENT REPORT?

There are three ways to obtain a copy of your SFPD Police Incident Report:

1. **In Person** — You may request a copy in person ONLY at SFPD Police Headquarters Crime Information Services Unit at 1245 Third Street during normal business hours (Monday - Friday, 8 am-5 pm, and Closed on Holidays). Reports are NOT available through the district stations.
