SFPD Arrests Taraval District Assault Suspect 23-122

October 04, 2023 | 7:35 PM

On Wednesday, September 27, 2023, at approximately 1:42 p.m., San Francisco Police officers from Taraval District responded to the 100 block of West Portal Ave. regarding an assault in progress. The investigation determined that a male suspect assaulted a victim without provocation and caused her to fall to the sidewalk. A coworker of the victim ran to the aid of the assaulted victim and was also assaulted by the suspect as the suspect pushed her into a retail establishment. While inside the store the suspect assaulted an additional victim, an elderly female customer, which caused her to fall to the ground. During the assault, a worker at a nearby business witnessed the victims being attacked and ran to their aid. The witness held the suspect to prevent him from further assaulting the victims but was bitten by the suspect, which caused him to release his hold.

The suspect fled the store but was followed by witnesses and bystanders who stopped and detained the suspect. As officers arrived on scene, they observed the suspect who was being detained by citizens. Officers detained the suspect and developed probable cause to arrest him. The suspect, identified as 39-year-old Parmjit Janda, was transported to San Francisco County Jail where he was booked for 4 counts of assault likely to produce great bodily injury (245(a)(4) PC) and elder abuse (368(b)(1) PC).

Three victims were treated and released by medics at the scene and one victim was transported to the hospital by medics all for non-life-threatening injuries. The SFPD is grateful for the quick actions of the individuals who intervened and helped detain the suspect until officers arrived on scene. Their actions prevented this suspect from escaping, and we commend them for their help in this incident.

While an arrest has been made, this incident remains an open and active investigation. Anyone with information is asked to contact the SFPD at 1-415-575- 4444 or text a tip to TIP411 and begin the message with SFPD. You may remain anonymous

One of the subjects was arrested, the second subject was cited and the third was released.



Help for behavioral health crises

A community health approach to people experiencing mental health and substance use crises in San Francisco

Street Crisis Response Teams (SCRT)

<https://sf.gov/street-crisis-response-team>

The Street Crisis Response Team (SCRT) operates citywide, seven days a week, 24 hours a day. SCRT provides rapid, trauma-informed emergency care to people in acute crisis. SCRT teams address urgent behavioral health and wellness issues. They provide linkages to critical resources for people with complex health needs such as urgent care, emergency shelter, substance-abuse treatment, mental health and medical clinics, and residential programs.

SCRT units are staffed with a Community Paramedic, an Emergency Medical Technician (EMT) or second paramedic, and either a Peer Counselor or a Homeless Outreach Team (HOT) specialist. Behavioral health clinicians are a core part of SCRT. On March 4, 2023, the SCRT program reconfigured its team composition to improve outcomes for people in crisis, to be able to respond to a broader range of crisis calls, and to offer follow-up after the crisis. Behavioral Health clinicians now provide follow-up support through the expanded City's Office of Coordinated Care (OCC), offering follow-up to people who got a response from an SCRT unit. Follow-up includes care coordination and connections to critical resources.

An alternative to law enforcement

We know that people experiencing homelessness and mental health or substance use challenges need specialized care and support.

Our street crises teams have the unique expertise to respond to people in crisis and de-escalate disruptions in the community.

We avoid unnecessary use of police and costly hospital stays, and address the immediate needs of people experiencing homelessness.




A community paramedic, EMT, and peer or SFHOT specialist

A community paramedic and/or EMT assesses for medical and mental health emergencies and determines the client's most immediate needs.

A peer or SFHOT specialist with lived and/or proximate experience helps make the connection with clients to gain trust and move them to be open to care.

After the response call, the team transports clients to services, such as treatment and housing, and refers the client to follow up care and support.



Neighborhood based care and support

SCRT operates citywide, seven days a week, 24 hours a day.

Up to twelve teams that understand unique community characteristics and are responsive to the complex needs of individuals are in the field every day.

Two teams provide overnight coverage and fill in any gaps in needs.

Call 9-1-1 if you see someone in crisis and describe what you are seeing to our trained dispatchers.



Submit a parks related request

Report a problem or request service inside of a San Francisco park, playground, recreation facility, or sports facility

The San Francisco Recreation and Park Department administers more than 220 parks, playgrounds, and open spaces, including two outside the city limits-- Camp Mather in Yosemite Valley and Sharp Park in Pacifica, Calif. Our park system includes 25 recreation centers, nine swimming pools, five golf courses and numerous tennis courts, ball diamonds, soccer fields and other sports venues. Included in the department's responsibilities are the Marina Yacht Harbor, the San Francisco Zoo, and Lake Merced.

Our staff members are diverse, committed and talented recreation and park professionals, from gardeners, foresters, and recreation leaders to park patrol officers, custodians, electricians, painters, and more.

Response time

Varies. Usually within 5 business days.



Describe Me!



How to Describe a Suspect

Providing a detailed description of a criminal suspect can help solve crimes in San Francisco. Suspects can easily change their appearance with a hat, jacket or glasses. It is important to be mindful of unique characteristics such as body markings, tattoos, shoes and specific clothing markings, like logos.

Note the Following Unique Characteristics:

Race _____ Sex _____ Age _____ Height _____ Weight _____

Hair _____ Eyes _____ Complexion _____

- Physical Characteristics (slight or heavy build, scars, marks, tattoos, manner of walk, mustache, glasses) _____
- Clothing (type and color, logos or brand names, shoes, jewelry, accessories) _____
- Weapon (type of weapon used by the suspect: rifle, shotgun, automatic, revolver, knife) _____
- Remarks (note anything the suspect says, accent, any names used) _____
- Means of Escape (vehicle or foot, license plate number, year, make, model, color, traveling in which direction) _____

If it's safe, take a photo of the suspect, vehicle, license plate number, etc.

What to Do During an Emergency



How to Call 911 in an Emergency

- Remain Calm and **Dial 911** Immediately
 - **WHEN** to Dial 911
 - If a crime is posing an immediate threat to you or others
 - If there is a medical emergency
 - If the incident is in progress
 - If the incident just occurred and you know where the suspect is
- State the following information:
 - **WHERE** the incident is happening and **WHAT** is occurring, for example: **"I'm at 1234 Market Street and I've just been robbed"**
 - Tell the operator if you are in immediate danger or are being threatened
 - Be **brief, clear** and **accurate**
- As long as it is safe, stay on the line and answer the operator's questions
- Describe each suspect separately from head to toe (*see more information on the back of this card*)



- 陳述以下資訊：
 - 事件發生地點，發生什麼事，例如：
 - 「我在1234 Market街，剛被人搶劫了」
 - 告訴接線人員，您是否有立即的危險，是否正受到威脅
 - 務必簡短、清楚、正確
- 只要情況安全，請繼續保持通話，回答接線人員的問題
- 針對每一個嫌犯，從頭到腳進行描述（詳情請見此卡背面）



Dispose of Unwanted and Expired Medication at Taraval Station

There is a secured bin at Taraval Station where you can dispose of unwanted and expired medication at any time of the day or night. The bin will accept any type of prescription and off the shelf medication.

When disposing the medication, please leave it in the original container with your personal information crossed out or removed. You can also place the medication into a clear plastic zip top baggies. Contact the front desk officer and inform them that you want your medication dispose of. The officer will assist you. Please note that once an item that had been disposed of inside the bin, we cannot retrieve it. So make sure your ring, cell phone or anything of value is not accidentally disposed of.
